should be objectively recognized that this is one of the basic areas in which this phenomenon

is regulated. As part of the first issue of the journal Tourism - management, administration,

law, we would like to know the current state of research in this area. Changes taking place in

the market of tourist services affect employment, tourist offer, but also business models. The

ways of dealing with the change are interesting from the point of view of the market regulator,

which is the minister responsible for tourism. At the same time, we would like to know the

positions of people scientifically involved in this area.

As part of the first issue of the scientific journal, we want to present information on the

change that can take place on many levels, which is why scientific texts on changes in legal

regulations, changes in business concepts or the geopolitical situation, which will affect

tourism, are welcome.

Changes in tourism from the perspective of the ongoing war in the east should also be

properly considered and presented. The factors associated with the change prove that many

important questions arise regarding tourism research in both economic and political

(administrative) dimensions.

Making the right diagnosis in the context of changes that are present on the market of tourist

services and affect it is currently one of the main challenges for the tourism sector, which is

recovering after the pandemic. Thus, I would like to invite you to submit proposals for

scientific articles addressing the issues of research on change management in tourism.

Suggested topics:

• legislative changes and their impact on tourism,

• change in the area of tourist services as a factor influencing the market,

• change management in the hotel industry,

• legal and factual aspects of employment in managing change in public administration in the

area of tourism,

• impact of the COVID-19 pandemic and the war in Ukraine on the market of tourist services,

• changes in the perception of tourist regions in the face of pandemic and war crises.
