- 6. Access to the data has authorized employees of the Embassy of the Republic of Poland in Bangkok. Data will be made available to members of the Contest Committee and authorized employees of the Embassy of Thailand in Warsaw.

- 7. The data will not be transferred to third countries nor international organizations.
