# **Regulations of the 8th International Piano Competition**

# 24th - 28th of April - Augustów 2024

## Ι

1. The 8th International Piano Competition – Augustów 2024, taking place between the 24th and 28th of April 2024 in Augustów is organized by the Centre of Artistic Education.

2. The State Music School of Emil Młynarski in Augustów - Poland is the co-organizer.

3. International Piano Competition in Augustów is organized every 2 years and is dedicated to the students of primary and secondary music schools from Poland as well as foreign countries.

4. Competition performances will take place at the Concert Hall of the school, at 1 Wybickiego Street.

5. Participants of the competion will perform on the Yamaha concert piano. Each participant of the competition will have a rehearsal at the concert hall. Practice rooms will be available during the competition.

6. Participants of the Competition will perform in four categories based on age.

**1st Category** – students born in 2014 and younger

2<sup>nd</sup> Category – students born in 2011 and younger

3<sup>rd</sup> Category – students born in 2008 and younger

4<sup>th</sup> Category – students born in 2002 and younger

7. Auditions of the competition are open to the public and will be held in one round for the 1st and 2nd category, and in two rounds for the 3rd and 4th category.

8. A participant from the younger category may compete with the older category on the condition of performing a programme required for the older category. 9. Participants of the competition in respective categories will perform in alphabetical order of their last names, beginning with a letter drawn by lot and following the same order during the 2nd round of auditions. (This rule regards the 3rd and 4th category).

10. The organizer of the Competition calls into being the Jury and appoints the Head of the Jury.

11. The pedagogues whose students participate in the competition may not become the chairman or members of the Jury.

12. The Jury members will evaluate the participants and write down the results on their score cards. The participants of the competition will be awarded points in a scale from 1 to 25. The number of points obtained will be grade point average, obtained from each Jury member and calculated arithmetically.

13. The Jury appraises performances based on: repertoire selection being in accordance with the Competition regulations, technical skills, sound quality, style of interpretation, artistic quality of the performance.

14. After each round of the Competition  $(3^{rd} \text{ and } 4^{th} \text{ category})$  the Jury appraises performances of the participants in the respective round. The participants of the  $3^{rd}$  nad  $4^{th}$  category who will be awarded 21 grade points average or more in the first round the the competition, will be qualified for the second round of the Competition.

15. The participants of the 2<sup>nd</sup> round will become the finalists of the competition. While selecting the laureates the Jury considers grade point average obtained in both rounds of the Competiton. The participants who will be awarded 22 grade points average or more will become laureates of the competition.

16. After completing the Competition auditions each Jury member selects and writes down on the score cards one candidate for the Special Prize – awarded for the best performance of **Witold Lutosławski's** works and the best performance of a piece composed by a **Lithuanian composer.** 

17. The Jury makes decisions regarding appraising and rewarding based on the Regulations of the Jury. Decisions of the Jury are final and irrevocable

19. Applications must be sent electronically with the following email attachments:

- RODO agreement for processing personal data for competition purposes, scanned and signed by a participant's parent/ legal guardian or a participant of age

Registration fee is non refundable in case of resignation from participating in the competition. <u>Cost of money transfer is covered by the participants.</u>

20. Participation in the competition will be determined by the order of applications.

21. Information about rehearsal time and performance time will be published on the school website : <u>www.gov.pl/psmaugustow</u> after closing the list of the registered participants.

22. Programme of the competition must be memorized and performed in accordance with the time limits. The compositions of Witold Lutosławski and Lithuanian composers are welcome.

## 1st Category - students in 2014 and younger

• A free style piece by a contemporary Polish composer from the XXth or the XXIst century or a piece from the XXth or the XXIst century by a composer from the country of origin of a participant.

• A free style piece contrasting in character and tempo.

Duration time up to 7 minutes

## 2nd Category - students born in 2011 and younger

- A virtuoso etude or a virtuoso compositon
- A piece from the Classicism period (a sonata allegro form: a fast movement of a sonata, sonatina, rondo; or variations from the Classicism)
- A free style piece

Duration time up to 12 minutes

# 3rd Category – students born in 2008 and younger

#### **1st Round**

- A piece (or a few chosen movements of a cycle piece) from the Baroque
- A virtuoso etude or any other virtuoso composition

Duration time up to 13 minutes

#### 2nd Round

- A sonata allegro form or rondo, or variations from the Clacissism
- A free style piece or pieces.

Duration time up to 15 minutes

## 4th Category – students born in 2002 and younger

#### 1st Round

• Allegro (first movement of a sonata), rondo or variations from the Classicism or Romantism.

• Two virtuoso style etudes, at least one of them composed by Frederic Chopin.

Duration time up to 17 minutes

#### 2nd Round

• Freely chosen programme.

Duration time up to 25 minutes

## IV

23. The winners of the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place will be granted the title of a laureate of the 8<sup>th</sup> International Piano Competition – Augustów 2024. The Jury reserves the right to granting awards ex aequo or not granting an award in a respective category.

24. The laureates of the competition, organized by the Centre of Artistic Education, will be granted following privileges: exempting from the promoting or final examination at the artistic school with the highest grade (article 44 of educational system act from September 7<sup>th</sup>, 1991), being accepted into high schools firstly (article 132 of educational system act from 14<sup>th</sup> December, 2016). Finalists and distinguished will receive entitlements mentioned in regulations based on article 162 of educational system act from 14<sup>th</sup> December, 2016 – Educational Law (the way of calculating points for respective educational criteria during recruiting into high schools).

25. The prize winners in the  $1^{st}$  and  $2^{nd}$  category will receive gift prizes and diplomas. The prize winners in the  $3^{rd}$  and  $4^{th}$  categories will receive financial prizes and diplomas.

26. The of the laureate of the 4<sup>th</sup> category chosen by the Jury will perform during a cycle of concerts Young talents at the Fryderyk Chopin'w Museum

recitals and the laureates of the 3<sup>rd</sup> and 2<sup>nd</sup> categories will perform piano recitals "Musical quarters of an hour" in Żelazowa Wola.

27. The Jury may grant the Grand Prix of the competition for the participant presenting the most preeminent artistic personality, as well as the Special Prize for the best rendering of a piece composed by Witold Lutosławski, to commemorate the 30<sup>th</sup> anniversary of his birth, as well as a piece of a Lithuanian composer.

28. Distinctions will be also granted at the Competition. The participants honoured with distinctions will receive diplomas and gifts.

29. All participants will receive diplomas of participation in the competition.

30. The prize winners are obliged to performing during the concert of laureates.

31. The organizers reserve rights to recording and public release of artistic performances, as well as promoting the event in media, press and internet.

32. Sending the registration for the competition is equal with permission for processing personal data in accordance with the Act of European Parliament and Cuncil from 27<sup>th</sup> of April, 2016 and Personal Data Protection dating 10<sup>th</sup> of May, 2018.

33. Registration of the participant means accepting the regulations of the competition.

34. Cost of transportation, accomodation and board is covered by the participants.

35. In the event of epidemic threat, the competition will be conducted online.
