DESCRIPTION (topic, expectations, comments/formal requirements):

Participation in research and contract work carried out at IMGW-PIB in the field of oceanographic issues, hydrodynamic modelling, with particular emphasis on wave forecasts in marine areas. Participation in scientific projects and their initiation. Participation in publishing activities and expert studies.

I. Terms and conditions of the competition:

Candidates should meet the requirements for employment for the position of assistant professor set out in the Act of 30 April 2010 – on Research Institutes (Journal of Laws of 2024, item 534 (i.e.) and in the Statute of the Institute of Meteorology and Water Management – National Research Institute.

II. Required documents:

1. Application for employment for the position.
2. Curriculum vitae (CV)
3. Self-report
4. Education confirmed by the possession of:
 - Doctoral degree in the discipline: environmental engineering, mining and energy
5. Professional experience in the field of:
 - conducting research works, confirmed by:
 - ✓ a list of publications and reports, scientific and technical studies from the last 3 years, along with information on the scoring of

the Ministry of Science and Higher Education, Impact Factor, number of citations and the Hirsch index. The candidate should be the author of at least three peer-reviewed scientific publications. The candidate should be the lead author of at least one of them. The total number of points obtained, according to the Ministry of Science and Higher Education list, cannot be less than 240, depending on the year of publication.

- participation in the work of research teams, confirmed by:
 - ✓ a list of research works (national and international projects) with an indication of the role played by the candidate in these works.
- Experience in environmental engineering, mining and energy confirmed by:
 - ✓ a list of documents related to the speciality: hydrodynamic modelling, with an indication of the role played by the candidate in their development (min. 3 items).

6. Professional qualifications confirmed by:

- participation in scientific conferences, seminars and symposia (including international ones),
- certificates of completed training, internships, etc.
- experience in hydrodynamic modelling.

7. Knowledge of a foreign language:
a statement on the knowledge of foreign languages and the level of their proficiency.

8. Reading the Information on the processing of personal data of persons participating *in recruitment processes at IMGW-PIB*.

9. Candidate's declaration of exercising full public rights.

10. A declaration that the candidate has not been convicted by a final judgment of an intentional crime or an intentional tax offence (thus consenting to the verification of data in the National Criminal Register by the potential employer).

III. PURPOSE AND LEGAL BASIS FOR DATA PROCESSING

We will process your personal data for the purpose of conducting a competition for the position of Assistant Professor:

- **based on legal regulations**, i.e. according to Art. 6 (1) (c) of the GDPR in connection with Art. 43 (6) of the Act on Research Institutes – which requires a competition procedure to be carried out. In areas not regulated by the act, the processing is based on Art. 22¹ of the Labour Code. The data will be processed to the extent of: first name(s) and last name, date of birth, contact details provided by the candidate - e-mail address, telephone number, education, professional qualifications, and employment history;
- **based on your consent** pursuant to Article 6(1)(a) of the GDPR for the processing of your personal data, i.e., personal data other than those specified in the point above — for example, a candidate's photograph, traditional mailing address, or information confirming the absence of a criminal record for intentional offences, including intentional fiscal offences, obtained on the basis of your declaration (in the case of the latter data, the legal basis is Art. 10 in connection with Article 6(1)(a) of the GDPR);
- **based on your consent pursuant to Article 9(2)(a) of the GDPR** – in the event that the application documents contain special categories of personal data such as: racial or ethnic origin, political opinions, religious beliefs, trade union membership, genetic or biometric data, **data concerning health**, or sexual orientation;

In the case of processing based on consent, the data will be processed until the consent is withdrawn. In the case of processing based on the legitimate interest of the administrator, the data will be processed until an objection is raised due to the data subject's particular situation.

V. Recipients of personal data – Your data may be disclosed to entities and persons authorized under legal provisions, including entities entitled to access public information. The data may also be shared with entities performing support services (based on necessary agreements) that are essential for achieving the stated purposes of processing, such as software providers, postal operators, or couriers.

VI. Your rights – In accordance with the GDPR, you have the right to request access to your personal data and to receive a copy thereof, the right to request rectification (correction), erasure, or restriction of the processing of your personal data, as well as the right to data portability.

Consent and information on the right to withdraw consent – You have the right to withdraw your consent to the processing of personal data at any time. The withdrawal of consent does not affect the lawfulness of processing based on your consent before its withdrawal. A declaration of withdrawal of consent to the processing of personal data may be sent to the addresses indicated in point I.
