"Access to housing and education for children in migration: challenges and good practices"

CONTEXT AND AIMS

The EMN in response to the request of the European Commission has developed a report "Children in Migration" (hereinafter – the Report) to synthesise information on the implementation of the 2017 Commission Communication on the protection of children in migration¹ (hereinafter – the Communication) at national level. The Report covers all the key chapters of the Communication and reflects the legislation, policies and practices in place in Member States and Norway from 1 January up to 31 December 2019.

The webinar "Access to housing and education for children in migration: challenges and good practices" is organised in the context of the follow-up report to the Communication and will serve as a launch event for the Report produced by the EMN. Being aware that both the Communication and the Report covers broad range of topics related to protection of children in migration, the webinar will specifically focus on two important reception conditions for migrant children – housing and access to education.

The 2017 Communication provides that reception conditions should be in line with the EU acquis, whereby reception conditions should include not only safe and appropriate accommodation, but also any necessary support services to secure the child's best interests and well-being, such as: independent representation, access to education, healthcare, psychosocial support, leisure and integration-related measures.
