Introduction

This report synthetically presents basic figures and information on the projects and programmes pursued in connection with Polish development cooperation in 2023. Initiatives funded by the Ministry of Foreign Affairs under the Polish Aid programme are described in greater detail.

The priority for Polish development cooperation in 2023 was efforts to support Ukrainian institutions and society in dealing with the conflict brought about by the Russian aggression. Projects implemented under the Polish Aid programme, financed by the MFA, were focused on mitigating and preventing the impact of the Russian aggression, and on providing humanitarian aid to Ukraine. In Georgia and Moldova, the Polish Aid funds were used, among other things, to continue projects for the development of crisis management systems, facilitation of access to education and vocational training, and support of key


reforms related to those states' European ambitions.


In 2023, the MFA financed assistance projects in selected Sub-Saharan African and Middle Eastern countries. The goals of these projects included ensuring equal opportunities in education, growing entrepreneurship in the agri-food sector, as well as modernising and strengthening healthcare infrastructure. Notably, with the outbreak of the Israel-Hamas war in October 2023, the MFA provided additional funds in response to appeals concerning the disastrous humanitarian situation in the Gaza Strip.

In 2023, Poland allocated PLN 10.842 billion in official development assistance, which was 0.33% of its gross national income (GNI). Poland also transferred PLN 903.72 million in bilateral official development assistance to Ukraine, with PLN 300.21 million devoted to humanitarian aid.

Development cooperation system

3.1. Development cooperation and Polish Aid projects

Development cooperation involves providing assistance to less developed countries and their societies (development assistance) and ensuring security for people affected by natural disasters or conflicts (humanitarian aid). It also covers global education, i.e. educational activities undertaken in order to increase awareness and understanding of global problems and interdependence between countries. In these areas, the Ministry of Foreign Affairs cooperates with government administration authorities, NGOs and local entities in partner countries, as well as with international organisations.

Development assistance can be provided bilaterally or multilaterally. The former involves activities for a specific partner country in the form of assistance projects and programmes, donations and loans to implement specific projects, scholarships for citizens of beneficiary states, and preferential credit facilities. The latter involves payments to international institutions that support development or provide humanitarian aid, e.g. specialised UN agendas.

Development cooperation helps in the achievement of the sustainable development goals (SDGs), adopted in the UN General Assembly Resolution Transforming our World: The 2030 Agenda for Sustainable Development. By adopting this resolution in 2015, leaders of the UN Member States committed to eliminating poverty in all its forms and, at the same time, to pursuing numerous economic, social and

environmental objectives, by means such as ensuring access to education, food and clean water, creating equal opportunities for states and social groups, promoting the observance of human rights, maintaining peace and stability across the world, protecting the natural environment, mitigating climate change, and improving access to sustainable energy sources.

The funds which the donors provide to partner states to support their economic and social development, as well as payments to multilateral international organisations, are classified as Official Development Assistance (ODA). Preliminary figures show that in 2023, Poland provided PLN 10.842 billion in Official Development Assistance. Bilateral cooperation accounted for approximately 66% of all ODA, which is close to PLN 7.151 billion, while multilateral cooperation accounted for PLN 3.691 billion. In total, in 2023, ODA amounted to 0.33% of Poland's GNI¹.

3.2. Geographic and thematic priorities

In 2023, the priority countries for Polish development cooperation continued to be the following:

- four countries of the Eastern Partnership: Georgia, Moldova, Ukraine, and Belarus, with respect to supporting civil society;
- two Middle Eastern countries: Lebanon and Palestine;
- four Sub-Saharan African countries:
 Ethiopia, Kenya, Senegal, and Tanzania.

Under the Multiannual Programme for Development Cooperation for 2021-2030,


the thematic priorities covered the following selected sustainable development goals:
16. Peace, justice and strong institutions,
4. Quality education, 8. Decent work and economic growth, 10. Reduced inequalities,
3. Good health and well-being, 6. Clean water and sanitation, 11. Sustainable cities and communities, and 13. Climate action.

Apart from the thematic priorities, Polish development cooperation also focused on two key cross-cutting priorities: climate protection and equal opportunities.

3.3. Polish development cooperation: legal and institutional framework

Development cooperation is a part of foreign policy, an expression of Poland's solidarity with developing countries as well as the fulfilment of obligations resulting from Poland's membership of international organisations. Polish development cooperation is governed by the Act of 16 September 2011 on Development Cooperation (Polish Journal of Laws of 2021, item 1425), and is coordinated by the Minister of Foreign Affairs via the National **Development Cooperation Coordinator.** The measures are implemented on the basis of the Multiannual Programme for Development Cooperation for 2021-2030. Solidarity for Development and the annual Development Cooperation Plans drafted in line with the Multiannual Programme. At the MFA, the organisational unit competent for planning, coordinating and implementing the aid activities is the Department of Development Cooperation.

Non-governmental organisations, actors in the public finance sector, the Polish Academy of Sciences, as well as units subordinate to it, and higher education institutions take part in implementing the Multiannual Programme.

The Ministry of National Education pursues a scholarship policy which covers support for foreign students from developing countries. The Ministry of the Interior and Administration provides public-security technical aid in the areas of medical rescue, protection of borders, rescue services, and road safety in Georgia, Moldova and Ukraine. The Ministry of Development Funds and Regional Policy provides support for building the institutional capacity of administration authorities in countries of the Eastern Partnership. In implementing the projects of the Armed Forces Operational Command, the Polish Military Contingent operating within the UNIFIL mission plays a part in improving the quality of life for the Lebanese and addressing the needs communicated by local governments. Initiatives undertaken by the Office of Competition and Consumer Protection help to improve the consumer protection system in Moldova and Armenia.

In the international arena, Poland cooperates with organisations such as the European Union, the United Nations, and the Organisation for Economic Co-operation and Development (OECD).

Poland's humanitarian aid

With the humanitarian crisis brought about by the Russian aggression in Ukraine, a significant part of the humanitarian aid payments made by the MFA concerned aid to Ukraine and Ukrainian citizens.

At the same time, the MFA provided support for the humanitarian programmes and responded to appeals made by the Middle East, the Gaza Strip, and selected African states. In 2023, in response to the UN's humanitarian appeals, the MFA also provided support for Lebanon and Sudan, as well as the activities of the UNHCR in Armenia related to the conflict in Nagorno-Karabakh.

Furthermore, the MFA also made payments to the Central Emergency Response Fund of the United Nations (OCHA CERF) for anticipatory action aimed at averting crises, and for growing crisis resilience in developing countries. Poland paid its declared contributions to the International Committee of the Red Cross (ICRC) in line with the 2018 Memorandum of Understanding, and to

the United Nations Office for the Coordination of Humanitarian Affairs (UN OCHA), since Poland is part of the OCHA Donor Support Group (ODSG).

Financial support for humanitarian efforts of international organisations further included payments to the United Nations International Children's Emergency Fund (UNICEF), the World Food Programme (WFP), the Food and Agriculture Organization of the United Nations (FAO), the United Nations Office for the Coordination of Humanitarian Affairs (UN OCHA), the United Nations High Commissioner for Refugees (UNHCR), the UN Ukraine Humanitarian Fund, the International Fund for Agricultural Development (IFAG), the United Nations Development Programme (UNDP), the United Nations Human Settlements Programme (UN Habitat), the United Nations Relief and Works Agency


for Palestine Refugees in the Near East (UNRWA), and the International Committee of the Red Cross.

Via Polish non-governmental organisations which implemented eight projects in Ukraine worth a total of PLN 8.7 million, Poland provided support with respect to food, healthcare, medical aid, psychological aid, as well as education and hygiene. This aid was

primarily directed towards the Kharkiv and Poltava Oblasts.

Furthermore, the Ministry of Foreign Affairs provided PLN 9.8 million in aid for Palestinians, by making payments to specialised UN agendas (UNRWA, UNICEF, WFP). Additionally, medical equipment was delivered to Egyptian hospitals treating patients from the Gaza Strip.

Bilateral development cooperation

In 2023, bilateral development cooperation mostly took the form of projects and tasks carried out by Polish non-governmental organisations, central administration bodies, local government units, as well as diplomatic and consular missions. Polish Aid was directed not only to the ten priority countries, but also to other developing countries specified in the list of the Development Assistance Committee of the Organisation for Economic Cooperation and Development (DAC OECD).

Bilateral development cooperation financed by the Minister of Foreign Affairs in 2023 was provided by the following means:


- non-governmental organisation projects selected in calls for proposals conducted by the Minister of Foreign Affairs;
- projects implemented by Polish diplomatic missions;
- activities entrusted to Solidarity Fund PL;
- scholarship programmes;
- projects implemented by government administration bodies;
- the Eastern Partnership Academy of Public Administration;
- earmarked contributions.

5.1. Calls for proposals conducted by the Minister of Foreign Affairs

Each year, the Minister of Foreign Affairs announces calls for proposals for projects aimed at priority states of Polish development cooperation and their societies. The rules for these calls define the objectives and premises for the procedure and the proposal assessment criteria. Proposals may be submitted by non-governmental organisations, local government units, public and non-public higher education institutions, research institutes, and the Polish Academy of Sciences and its organisational units. Applicants specify the local partners that will cooperate in the implementation of the project.

In 2023, the Minister of Foreign Affairs announced the following calls for proposals:

- Polish Development Assistance 2023, under which the Minister co-funded 22 projects: four each in Georgia, Tanzania and Ukraine, three each in Palestine and Moldova, and one each in Lebanon, Cameroon, Kenya, and Zambia;
- Polish Humanitarian Aid 2023, under which the Minister decided to co-fund eight projects in Ukraine and one each in Iraq and Jordan.

5.2. Projects implemented by Polish foreign missions

Projects implemented by Polish foreign missions were carried out both in Polish Aid priority countries and in other developing countries. In 2023, 138 projects worth a total of PLN 11,109,705.96 were implemented.

The initiatives were prepared jointly with local partners, i.e. registered and legally operating NGOs, religious centres, and public institutions, as well as central and local administration in the territory concerned. Their aim was to satisfy the needs of local communities.

Priority states of the Eastern Partnership (Georgia, Moldova, Ukraine) saw the implementation of 33 projects.

Five initiatives were pursued in Armenia and one in Uzbekistan. Development initiatives were implemented to strengthen healthcare systems, which included providing support for the rehabilitation and social integration of people with disabilities. Measures were taken to support crisis management systems, ensure the safety of the population, including fire safety, and improve access of local communities to municipal services. Small--scale educational infrastructure was also co-funded. Projects were also conducted to grow entrepreneurship and tourism, and to implement pro-environmental solutions locally. In Ukraine, psychological care was extended to include children experiencing the trauma of war.

In priority Sub-Saharan African states (Ethiopia, Kenya, Senegal, and Tanzania) and Middle Eastern states (Lebanon and Palestine), 25 projects were implemented. Development and humanitarian activities were also pursued in the Western Balkans (Albania, Bosnia and Herzegovina, Montenegro, North Macedonia, Serbia), Africa (Angola, Cape Verde, Egypt, the Gambia, Madagascar, Morocco, Namibia, Rwanda, South Africa, Tunisia, Uganda, Zambia), the Middle East (Iran, Jordan, Syria), Asia (Cambodia, Indonesia, Mongolia, Pakistan, the Philippines, Thailand), and South America (Colombia, Venezuela). Polish foreign missions also pursued initiatives in Jamaica, Mexico, Papua New Guinea and Türkiye. A total of 98 projects were implemented, with 88 development projects and ten humanitarian projects.

The development projects implemented by the Polish foreign missions involved the development and modernisation of medical and sanitary infrastructure and support for the development of specialist healthcare, in particular for mothers and their children, as well as people with disabilities. Efforts were also made to expand the educational infrastructure and systems; to ensure equal opportunities in education for girls, young women, and people in vulnerable groups – especially due to their disability – internally displaced persons, and refugees; and to support the growth of vocational education and entrepreneurship, as well as creating new jobs. Measures were taken to improve sustainable food production and food security, including through making local communities more resilient to the harmful impacts of climate change; energy efficiency was also improved, along with making the production and consumption of renewable energy more popular.

5.3. Activities carried out by Solidarity Fund PL (SFPL)

In 2023, commissioned by the MFA, Solidarity Fund PL undertook various development measures in selected states of the Eastern Partnership.



Solidarity Fund PL

Initiatives were implemented for Belarusian society, including those supporting non--governmental organisations, civic initiatives, editorial offices of media organisations, think tanks for human rights and democratic institutions, as well as free media providing civil society with access to information.

The focus in Moldova was building the competence of the Moldovan administration, which included

implementing the key institutionalisation stage for the National LEADER programme, involving local development in rural areas; engaging towns, cities and urban areas in implementing the National Urban Development Programme; developing a model for the functioning of voluntary fire services as part of the civil protection system, and reinforcing the competences of the Moldovan Ministry of the Interior and subordinate units.

Efforts in Georgia were aimed at supporting local government units and reinforcing decentralisation related to ensuring greater efficiency of local governments and introducing energy efficiency solutions in local governments.

The projects carried out in Ukraine were aimed at supporting the reform of the civil protection system at the local level, supporting the reform of the social policy, testing model solutions in providing services for those impacted by the war at oblast, raion and hromada levels, implementing the Good Management internship programme, and studying the safety of journalists in the country.

Armenia saw initiatives for effective democratic institutions, including civil society, public institutions and local governments for example in building a system for civic review of standards in court proceedings, and developing entrepreneurship and cooperation between authorities and the rural communities.

In 2023, the SFPL was commissioned by the MFA to make preparations for Polish observers to participate in OSCE/ODIHR observation missions for the parliamentary election in Kazakhstan and the presidential election in Uzbekistan.

In total, to implement its measures, the SFPL received a special-purpose subsidy of PLN 36 million.

5.4. Eastern Partnership Academy of Public **Administration (EPAPA)**

The EPAPA is pursued by the National School of Public Administration (KSAP) under the initiative and with the cooperation of the MFA. The purpose of the EPAPA is to strengthen public administration in Eastern Partnership countries through specialist training for officials.

In 2023 the EPAPA was conducted for the 13th time, with three week-long training modules and one two-week module which involved a study visit in cooperation with the Civil

Service Department at the Chancellery of the Prime Minister of Poland. The training modules included both lectures and workshops conducted by experienced experts and practitioners. They were organised for representatives of five countries, which were Armenia, Azerbaijan, Georgia, Moldova and Ukraine, and covered topics of regional policy, fight against VAT fraud and price fixing, as well as human resource management systems in the civil service. Each module was intended for around 15 participants.

5.5. Scholarship projects

General access to high-quality education is an opportunity for permanent, sustainable and peaceful development of states and societies. Foreign students in Poland have the opportunity to acquire knowledge and skills in domains important for the socio-economic development of their countries of origin. At the same time, they learn about the Polish culture, language and customs, and make contacts that foster stronger academic, social and economic relations between Poland and its partner countries.

Poland supports students from developing countries who attend programmes at Polish higher education institutions, offering tuition waivers and scholarship programmes co-funded from amounts earmarked for development cooperation.

The Ministry of Science and Higher Education (MSHE), the Polish National Agency for Academic Exchange (NAWA), and higher education institutions take the lead in these efforts.

The Stefan Banach Scholarship Programme

The Stefan Banach Scholarship Programme has been operating for a decade. In 2023, students from 36 countries - Albania, Angola, Argentina, Armenia, Azerbaijan, Belarus, Bosnia and Herzegovina, Brazil, Colombia, Ethiopia, Georgia, India, Indonesia, Iran, Iraq, Jordan, Kazakhstan, Kenya, Kosovo, Lebanon, Mexico, Moldova, Montenegro, Nigeria, North Macedonia, Palestine, Peru, the Philippines, Senegal, Serbia, South Africa, Tanzania, Tunisia, Ukraine, Uzbekistan, and Vietnam attended master's programmes in Poland in exact, natural, technical, agricultural, forest, and veterinary sciences.

In addition, students from European, Southern Caucasus, and Central Asian countries had the opportunity to start their programmes in

the field of humanities and social sciences as well, with the exception of philology studies of their native language. New scholarship beneficiaries also had a chance to take part in a preparatory course for studies in Poland. The candidates were selected by NAWA.

A total of over 600 foreign students were chosen for the programme from among 3,500 applicants.

The Konstanty Kalinowski Scholarship Programme - Solidarity with Belarus

In 2023, Poland continued its assistance for students and researchers from Belarus, offering scholarships, free programmes and preparatory courses for studies at Polish higher education institutions. Offered by the Centre for East European Studies at the University of Warsaw, the Konstanty Kalinowski Scholarship Programme gave assistance to almost 600 people.

They were able to study at Polish higher education institutions and enjoy the full extent of the academic freedoms. The programme is the largest in Europe to provide assistance for young Belarusians who have been forced to continue their education abroad due to their political views.

5.6. Projects implemented by government administration bodies

The involvement of the government administration authorities and their initiatives serve to provide support to reforms and systemic actions in partner countries, especially in priority states for Polish foreign policy. The Polish public administration

carries out development projects using Polish Aid funds and co-funding from the European Union budget.

In 2023, the Ministry of the Interior and Administration, the Armed Forces Operational Command, the Ministry of Development Funds and Regional Policy, the Ministry of Finance, the Ministry of Infrastructure, the Ministry of Economic Development and Technology, and the Office of Competition and Consumer Protection implemented 20 projects worth a total of PLN 4.5 million for Georgia, Moldova, and Ukraine, as well as Ethiopia, Lebanon, and Tanzania (see Financial Annex).

Polish government administration authorities mainly focused on modernising the public administration institutions of the partner countries, including those that are preparing Ukraine, Moldova, and Georgia for membership of the European Union.

As regards Ukraine, the efforts undertaken supported the country's institutions in maintaining and performing their duties in wartime. For example, the MIA and its subordinate units provided support for Ukrainian state and voluntary rescue services.



ODA in 2023 for priority countries - states of the Eastern Partnership (in PLN million)




Belarus

Despite the difficult political situation and no respect for human rights and fundamental freedoms in Belarus, Poland continued aid activities for Belarusian society in 2023 in two thematic areas: peace, justice and strong institutions, and equal opportunity education. Several dozen initiatives were directed for instance towards repressed people, Belarusian independent media

and journalists, and Belarusian students and researchers at Polish higher education institutions. Most funds were allocated to projects aimed at improving the access of Belarusian society to objective information, including radio and TV broadcasts, and at funding costs of education and scholarships for students.

Georgia

Assistance for Georgia focused on improving public security, including the emergency rescue system. Poland continued to provide support for the development of a training centre for the fire service in Tbilisi, drafted a plan for the development of an emergency unit network, and started developing an IT system for effective crisis management. Poland also maintained assistance for increasing road safety and establishing mountain rescue services, and supported education and healthcare for marginalised groups, including most of all people with disabilities. Projects were conducted to

improve their quality of life, access to rehabilitation services, and social integration. Assistance was given to establishments working directly with people with disabilities, both through deliveries of rehabilitation equipment, and through training for specialists. Additionally, projects to improve access to high-quality kindergarten education in rural areas were implemented.

Competences of local governments were developed with respect to promoting regions and attracting investors, as well as obtaining external funds to pursue local




investments, including in energy efficiency. A total of 23 projects were implemented, 15 by NGOs, one by a local government unit (the municipality of Tarczyn), two by government administration authorities, and five by the Polish Embassy in Tbilisi.

Moldova

A total of 28 projects were implemented in Moldova, six by NGOs, three by local government units, five by Polish government administration authorities, and 14 by the Polish Embassy in Chişinău. Four projects were carried out by the SFPL representative office in Chişinău.


Polish development assistance to Moldova includes support for key reforms strengthening the institutional capacity of public administration to plan and implement development policies: regional, urban, spatial and infrastructural. An important part of the Polish Aid programme is also to improve public security, including by developing crisis management systems and increasing the competences of emergency services. Poland also continued providing support for growing entrepreneurship in rural areas (using LEADER, an approach in European rural area development policy).

Ukraine

Ukraine has been a priority beneficiary of Polish Aid since 2005. The year 2023 saw the implementation of 40 development cooperation projects for Ukraine, including eight in humanitarian aid, four in development assistance, eight projects conducted by administration bodies, 14 projects carried out by Polish diplomatic offices, and six projects implemented via the SFPL.

As a result of Russia's full-scale aggression, development assistance activities for Ukraine were adjusted to meet the immediate needs of the Ukrainian people. At the same time, new initiatives were launched, providing support for Ukraine in preparing for the country's reconstruction and strengthening its resilience. In cooperation with the Ukrainian administration authorities, Poland pursued efforts related to the recovery and modernisation of Ukrainian towns and cities damaged as a result of the war. Ukrainian state and voluntary emergency services received necessary equipment and took



part in training in rescue and firefighting in wartime. Courses in fire safety for children were also held. Ukrainian police forces received a 3D scanner to document war damage to infrastructure.

Polish development assistance also included activities aimed at mitigating the economic and social impact of the war in Ukraine.

Poland financed initiatives promoting entrepreneurship among those affected by the armed conflict as well as the recovery and growth of enterprises. The support also included a vocational training system, taking into account the country's reconstruction needs. The Polish Aid programme also financed the development of a mental health support system for the population in wartime conditions. Another important element of cooperation with Ukraine in 2023 was support under the Stefan Banach Scholarship Programme.


Ukraine - ODA in 2023 (in PLN million)

5.7.2. Other priority countries - Africa

Senegal

In Senegal, in 2023, Polish NGOs continued two projects selected under the Polish Development Assistance 2022 call for proposals, whereas the Polish Embassy in Dakar implemented five projects. The efforts focused on expanding and modernising the medical infrastructure and on increasing the competences of medical personnel, especially as regards perinatal care and combating hunger and malnutrition. 

was provided on healthy eating for children, with measures to raise awareness of health, hygiene and prevention issues.

Initiatives implemented under the equal opportunities priority addressed the difficult situation of young women on the Senegalese labour market. Their purpose was to create favourable conditions for the education and vocational growth of young women and to empower them on the labour market by teaching them new skills and competences.

Kenya

Kenya saw the implementation of eight projects, five by NGOs and three by the Polish Embassy in Nairobi. They continued to provide support for the Kenyan specialist rescue system, including to make firefighting services in road and technical rescue more efficient. Poland developed a network of fire service units, delivered medical and specialist rescue equipment, and provided relevant training. Polish Aid was also used to fund climate action related to supporting entrepreneurship of local communities in rural areas.

Under the equal opportunity priority, support was provided for the vocational training sector to help integrate young people into the labour market, especially with respect to the poor communities of Nairobi. Efforts concerning healthcare involved expanding and modernising the medical, sanitary, and administrative systems and infrastructure. The initiatives raised the qualifications of medical personnel, especially in perinatal care, and provided

support for the improvement of the medical rescue system, including actions in health-and life-threatening situations. Training in obstetrics, gynaecology and neonatology was also provided. Projects implemented by the Polish Embassy in Nairobi in 2023 included improving educational conditions, with infrastructure built for education centres, taking into account sanitary conditions, access to water and electricity. The Embassy also carried out an initiative to prevent human trafficking, improve the mental, physical and social condition of the survivors, and provide support in job seeking.



Tanzania

Polish NGOs implemented six projects in Tanzania, whereas the Polish Embassy in Dar es Salaam carried out four initiatives. The main purpose of the efforts of NGOs in Tanzania was to support the growth of entrepreneurship and improve competitiveness, effectiveness and innovation, especially among producer

groups and labour cooperatives, helping to alleviate poverty of local farmers who were losing their income on coffee plantations.




The modernisation of the mechanical and hydraulics department at a technical school in Iringa and the provision of training for teachers increased young people's vocational skills and their opportunities regarding job seeking. Poland also continued to provide support for the medical rescue system by delivering medical equipment to five hospitals in the Dar es Salaam region and providing training for medical personnel in various aspects of emergency medicine, including postpartum complications. The construction of the Educational and Vocational Centre in Kiabakari improved access to vocational education for single mothers, persons with disabilities, and people in vulnerable groups. Projects in Tanzania were also meant to provide equal opportunities for a decent life

through measures such as vocational training and courses in entrepreneurship addressed at 100 women with albinism. The projects implemented by the Polish Embassy in Dar es Salaam included supporting efforts to sustain biodiversity and protect ecosystems, grow entrepreneurship, eliminate barriers in education at all levels, enhance vocational competences, and provide opportunities for physical development. The Ministry of Finance, in turn, implemented a project which involved providing support for Tanzania to make its tax systems more efficient and digitalise them.

Ethiopia

Ethiopia saw the continuation of a three-year project which covered training for medical emergency workers and other medical personnel, competence development of the instructor staff in emergency medicine and the purchase of medical equipment.

The Ethiopian Ministry of Health played a part in these efforts; also, in cooperation with the ministry, a Polish NGO developed a strategy for the development of emergency services.



5.7.3. Other priority countries - Middle East

Palestine

The escalation of the Israeli-Palestinian conflict as a result of Hamas's terrorist attack on Israel on 7 October, and the subsequent outbreak of hostilities in the Gaza Strip, were an important backdrop for Polish development cooperation initiatives pursued in the region in 2023. Thanks to the efforts of Polish NGOs, their Palestinian partners, and the Polish Representative Office to the Palestinian Authority in Ramallah, most of the initiatives planned for Palestine were implemented.

Polish NGOs carried out seven development projects. An additional four projects were implemented by the Polish Representative Office. The key areas for development cooperation were the improvement of the educational infrastructure, support for people with disabilities, promotion of entrepreneurship, and the strengthening of vocational capacities. Vocational workshops were organised for people in vulnerable

groups, whereas young people from families facing social and economic hardship were able to take part in electricity, woodwork, graphic design and digital marketing training courses.

Efforts to improve access to healthcare and provide support for people with disabilities resulted in the equipping of therapy rooms in rehabilitation centres in the Hebron Governorate. Thanks to sensory kits, children are able to continue therapy at home; parents received auxiliary equipment. Selected rehabilitation centres received additional amenities, such as a playground or cooperative kitchen; others received equipment that allows them to operate for profit (e.g. through sheep farming and milk production).




Efforts in the West Bank helped to improve medical care for pregnant women and ensured access to screening tests for over six thousand inhabitants of the Hebron and Jenin Governorates. Fifteen patient admission points were renovated; medicine and medical equipment for mobile wards operating within the region were purchased. In cooperation

with the Ministry of Health of Palestine, a multistage medical instructor education programme was completed.

Lebanon

The Polish Aid programme in Lebanon in 2023 involved four development projects implemented by Polish NGOs, six projects of the Polish Embassy in Beirut, and six projects of the Polish Military Contingent within the peace-keeping mission of the United Nations Interim Force in Lebanon (UNIFIL). The priorities in this country were climate protection and support for the education system. In addition, Poland provided support for sustainable energy management and built the capacity for the local administration to improve response to natural disasters.

The actions taken improved the efficiency of the institutions responsible for reacting to crisis situations, i.e. Lebanese Civil Defence,

the Beirut Fire Brigade, and the Lebanese Red Cross. Specialist equipment was bought for firefighters and rescue workers, training workshops were organised on medical emergencies for instructors, and a Roadmap for the Development of a System of Search and Rescue Groups in Lebanon was developed. Other projects made renewable electricity more accessible; this is one of key topics for Lebanon, a country that is experiencing a crisis. Polish Aid improved waste, water and sewage management through means that included building and starting up a sewage treatment plant on ships, as designed by Lebanese young people, making it possible to remove plastic waste from the rivers flowing into the Mediterranean Sea.

Poland also offered support for Lebanese schools, providing equipment and furnishings, and raising the qualifications of the teaching staff. The assistance also covered vocational education and practical professional training. The Polish Military Contingent also assisted with the development of the education systems. The projects implemented by the Civil-Military Cooperation team (CIMIC)


helped furnish public primary schools and an orphanage in Aynata with computer and multimedia equipment.

Multilateral development cooperation

6.1. Cooperation with international organisations

Poland has been actively cooperating within international organisations, chiefly the European Union, the Development Assistance Committee of the Organisation for **Economic Co-operation and Development** (DAC OECD), and the United Nations (UN), seeking to have the priorities of the Polish

foreign policy and of the Polish Aid programme incorporated into the works of these institutions. Efforts were made primarily to maintain strong support for Ukraine, increase food security, and improve the response to growing needs in the humanitarian aid sector.

OECD development cooperation peer review

Within the multilateral institutions, the most important process for Poland was the peer review of the Polish development cooperation system, conducted by the OECD's **Development Assistance Committee** (DAC). The months of work on the part of the evaluation team, made up of DAC experts and representatives of Sweden and New Zealand, resulted in a report with recommendations. It contains an analysis of the system, an evaluation of its efficiency,

as well as a list of best practices and areas which need improvement. Particular attention was paid to finding opportunities for making the system more effective, improving the programming of bilateral official development assistance (ODA), and strengthening multilateral partnerships as well as partnerships with civil society. The report was discussed during the DAC meeting at the OECD in November 2023.

Cooperation in EU development policy

During ministerial meetings, mainly of the Foreign Affairs Council on Development (FAC DEV), during meetings of the working parties of the Council of the European Union², and in expert discussions, Poland consistently sought to secure as much funding as possible for the recovery of Ukraine in the future, also in the form of the Ukraine Facility, and to treat countries covered by the European Neighbourhood Policy as priorities. Discussions on the EU forum during Sweden's and Spain's presidencies also pertained to issues such as reforming multilateral development banks

and the global financial architecture, focusing on healthcare, offering support for Palestine, and providing aid to particularly vulnerable countries.

An important process in 2023 was the preparations for the 46th ACP-EU Council of Ministers on 15 November 2023, in Apia, Samoa; it saw the signing of a Partnership Agreement between the European Union and its Member States as one party, and the members of the Organisation of African, Caribbean and Pacific States as the other party (the Samoa Agreement).

The Working Party on Development Cooperation and International Partnerships (CODEV - PI), the African, Caribbean and Pacific (ACP) Working Party, and the Council Working Group on Humanitarian Aid and Food Aid (COHAFA).


This agreement is the basis for relations between the EU and the ACP for the next 20 years and covers cooperation in sustainable development, economic growth, human rights as well as peace and security.

Cooperation with international development banks

Poland continued its cooperation with international development banks, primarily with the European Investment Bank (EIB) and the European Bank for Reconstruction

and Development (EBRD), through both fixed member contributions and participation in trust funds, such as those providing support for Ukraine and Moldova.

Voluntary development contributions

By making voluntary contributions, Poland continued to provide support for the development initiatives of specialised multilateral organisations, programmes and funds. In the wake of the Russian aggression against Ukraine, most of the activities co-funded by Poland involved Ukraine and, to a lesser extent, Moldova and Georgia.

Other supported activities were aimed at democratisation, peace-building, the reduction of inequalities, and support for least developed countries (LDCs) as well as small island developing states (SIDSs).

Poland made voluntary payments to the United Nations Development Programme (UNDP), the Office of the United Nations High Commissioner for Human Rights (OHCHR), the United Nations Entity for Gender Equality and the Empowerment of Women (UN Women), the United Nations Office for Disaster Risk Reduction (UNDRR), the United Nations Mine Action Service (UNMAS), and the United Nations Democracy Fund (UNDEF).

As in previous years, Poland also provided financial support for development activities carried out by regional organisations – the OECD, the OSCE Office for Democratic Institutions and Human Rights (ODIHR) – and the Council of Europe's programmes for Ukraine, Moldova, and Georgia.


In addition, in 2023, Poland made contributions towards NATO's Ukraine-related project, as well as the activities of

the European Endowment for Democracy (EED) supporting Belarusian civil society.

In total, in 2023, voluntary development contributions amounted to approximately PLN 13.6 million.

Poland paid its obligatory contribution to the European Development Fund (EDF), resulting from its membership of the European Union, at over EUR 42 million.

6.2. Engaging the private sector to achieve the goals of development cooperation – the Polish Challenge Fund



The year 2023 saw the continuation of efforts to engage the Polish private sector in development cooperation through the partnership with UNDP in implementing the Polish Challenge Fund (PCF). Thanks to co-financing from the PCF, Polish entities – companies, scientific hubs – have the opportunity to transfer their innovative solutions in green technology, energy transition, digital innovation, and organic farming to partner countries. In 2023, the PCF operated in Ukraine, Georgia, and Moldova.

Global education



Global education is a special type of education aimed at modern society. Its goal is to develop awareness and understanding of global issues and challenges. The addressees are encouraged to explore the economic, social, political, environmental, and technological interdependencies that exist between countries. In the face of current challenges such as climate change, social and economic inequalities, armed conflicts, migration, and the development of new technologies, global education is becoming a tool that enables people to understand these developments and their consequences. By fostering critical reflection and acceptance of differences, as well as by developing the ability to cooperate, it aims to raise civic awareness of the global challenges, making citizens capable of effective action for sustainable development.

In 2023, under the Global Education 2023 call for proposals, the Minister of Foreign Affairs granted PLN 463,200 in subsidies for four projects. The projects concerned raising the competences of teachers in providing global education during school classes. The project of the Salesian Missionary Voluntary Service Youth for the World expanded the education facilities on offer at the Global Education Park in Cracow, adding courses and events directed to students

of pedagogy degree programmes and programmes with teaching specialisations.

In 2023, the MFA continued intersector dialogue with NGOs, the Ministry of Science and Education, and the Ministry of Climate and Environment, on how to develop global education in Poland. In the European Declaration on Global Education to 2050 adopted in Dublin on 4 November, 2022, the Ministry of Economic Development and Technology was invited to participate in the dialogue, as it is competent for pursuing the 2030 Agenda in Poland and also undertakes measures to raise awareness of sustainable development for representatives of the public and private sectors.

MFA representatives also took part in the meetings of the Global Education Network Europe (GENE), the purpose of which is to exchange experience and best practices of European states in global education. With the Dublin Declaration adopted in 2022, the meetings also support the countries in implementing its provisions at state level and help with the monitoring of this process.

MULTILATERAL DEVELOPMENT CO-OPERATION

The following OECD FX rates were adopted for the purposes of calculations: 1 USD = 4,2017 PLN; 1 USD = 0,9248 EUR; 1 USD = 0,8985 CHF; 1 USD = 1,5051 AUD. Any slight differences in the aggregated amounts presented may result from currency conversions and rounding applied.
