**Information on the processing of your personal data by the
Embassy of the Republic of Poland in Dublin**

To understand your rights under Regulation 2016/679 (EU) of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regards to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (referred to as the "GDPR" or "General Data Protection Regulation"), and the Act of 18 July 2002 on Providing Services by Electronic Means, the Act of 16 July 2004 Telecommunications Law and the Act of 10 May 2018 on the Protection of Personal Data, please read the following information.

1. The administrator, within the meaning of Art. 4 point 7 of the GDPR, personal data is the Minister of Foreign Affairs located in Poland, in Warsaw, Al. J. Ch. Szucha 23, while the acting administrator is the Polish Ambassador to Ireland, 5 Ailesbury Road, Ballsbridge, Dublin 4.
2. The Data Protection officer (DPO) has been appointed at the Ministry of Foreign Affairs and in Embassies abroad. DPO can be contacted through email address: iod@msz.gov.pl or by mail Al. J. Ch. Szucha 23, 00-58 Warszawa.
3. Data are processed on the basis of art. 6 sec.1. lit. GDPR, i.e. based on participant's consent for the purposes related to organizing art contest.
4. Personal data will be processed until the purpose mentioned in point 3 is realized, and then they will be stored for archival purposes in accordance with the provisions of the Act of July 14, 1983 on the national archival resource and archives (Journal of Laws 2020, item 164) as well as with the internal regulations of the Ministry of Foreign Affairs, or until the consent is withdrawn. 5. Providing data is voluntary, but necessary to participate in the abovementioned art contest. The consequence of not providing the data will be the inability to participate in the Competition.
6. The data is protected under the provisions of the GDPR and may not be made available to third parties who are not authorized to access this data. The details of the competition winners and scans of their works may be posted on the Facebook account of the Polish Embassy in Dublin.
7. Access to data is granted to authorized employees of the Embassy of the Republic of Poland in Dublin.
8. Personal data will not be transferred to a third country or to international organizations.
9. The data provider has the right to control the processed data, as specified in art. 15-19 GDPR, in particular the right to access and rectify your data, the right to delete data and limit their processing, if applicable.
10. Personal data will not be processed in an automated manner that will have an impact on making decisions that may have legal effects. The data will not be profiled.
