Remarks:

The above selection of key topics and proposed main sessions is based on reflections of challenges on the European agenda. Other specialized themes are important but should be covered in side sessions like Flashes and other formats. This 2nd program outline for EuroDIG 2014 tries its best to consider the impressing number of more than 90 proposals (received until end of 2013), the online voting and vivid debates on key issues and topical priorities during the open planning meetings end of January in Berlin and Geneva in February.

This consolidated program still needs more specifications and tuned focus. Session titles are still working titles – except for the session on the over-arching theme "Digital society at stake – Europe and the future of the Internet". This fine-tuning on titles, focus, related questions, suggestion and selection of panellists etc. needs to be accomplished by the organizing teams (submitters of related proposals – see numbers of related proposals).
