#### on the evaluation of the quality of education at a doctoral school

Pursuant to Article 259 (1) and Article 262 (2) of the Act of 20 July 2018 - Law on Higher Education and Science (Journal of Laws of 2024, item 1571, as amended), hereinafter referred to as the "Act", having reviewed the result of the evaluation referred to in Article 262 (1) of the Act, which was carried out by the Evaluation Team, the Science Evaluation Committee

### positively evaluate the quality of education

at the Doctoral School

run by

Feliks Nowowiejski Academy of Music in Bydgoszcz.

This evaluation applies to the period from 1 October 2019 to 18 December 2024.

#### Justification:

The evaluated Doctoral School in the discipline of musical arts meets all criteria and requirements set forth by law. The cooperation between the doctoral student council, the Doctoral School's management, and the Academy's authorities is assessed very positively. The education programmes and individual research plans correspond to the learning outcome descriptors for level 8 qualifications of the Polish Qualifications Framework and are properly designed, appropriately reflecting the artistic and scientific activities of the doctoral candidates. Education at the Doctoral School has a highly individualised character, is conducted properly, and the verification of learning outcomes is carried out based on university-wide regulations. The recruitment rules for the Doctoral School, formulated clearly and in accordance with applicable regulations, received a positive assessment with a recommendation to ensure timely adoption and publication. The Doctoral School provides comprehensive support for artistic activities and scientific supervision at the highest level is ensured by a team of outstanding educators - artists of international renown. The mid-term evaluation system complies with applicable regulations and good academic practices, and the entire process is transparent and inclusive. The internationalisation of the Doctoral School, given the nature of the discipline, is achieved, among other things, through the active participation of doctoral candidates in artistic events (concerts, competitions, festivals) of international standing and significance. The effectiveness of doctoral training is confirmed not only by completed doctoral degree conferrals but also by the successes of doctoral candidates in national and international competitions, which serve as the best external validation of the quality of education.
