3. Notices to Skippers

In the area administered by Regional Water Management Authority in Poznań the following waterways are open to navigation: Warta River at km 0+000 - 333+000 (Notice no. 3/2025, 5/2025, 6/2025, 9/2025, 13/2025, 14/2025) and the Ślesiński Canal at km 0+000 - 26+460 (Notice no. 11/2025).

The section of the Warta River at km 333+000 - 406+600 remains closed to navigation (Notice no. 46/2024).

The Pątnów sluice - boats width limited up to 4.50 m (Notice no. 27/2024)

Please be especially careful due to the bridges renovation:

- Warta River in km 2+450,
- Ślesiński Canal in km 3+600,
- Ślesiński Canal in km 17+200.
