Subject: Decree of Minister of Agriculture on Registration of Poland's Food Safety Testing Laboratories

Dear Excellency,

Indonesian Agricultural Quarantine Agency (IAQA) presents its compliments to the Embassy of the Republic of Poland in Jakarta. IAQA has the honor to inform the Embassy of the Republic of Poland that the Minister of Agriculture has stipulated the Decree No.5426/KPTS/KR.040/K/5/2021 regarding the Registration of Poland's Food Safety Testing Laboratories on 17 May 2021, as attached. The Decree is valid for three years and can be renewed. The registered food safety testing laboratories are listed in Annex I (LAMPIRAN I) and the fresh food of plant origin (FFPO) with its contaminants are listed in Annex II (LAMPIRAN II).

IAQA has the honor to remind the Embassy of the Republic of Poland that the food safety requirements for the exportation of Poland's FFPO to Indonesia are as follows:

- 1. Every consignment must be accompanied by:
 - a. Prior Notice issued by Poland's exporter (or its representative) in Poland and
 - b. Certificate of Analysis (CoA) issued by the registered laboratories listed in Annex I;
- 2. Prior Notice must be issued before the FFPO arrived in Indonesia;
- 3. The testing result in CoA must not exceed the Maximum Residues Limits (MRLs) and/or Maximum Limits (MLs) of contaminants as listed in Annex II.

In addition, any changes in the data of registered laboratories (e.g. accreditation status, address, contact person, etc.) or in the data of registered and banned pesticides in Poland must be reported forthwith to IAQA.

Thank you for your kind attention and we are looking forward to continue our valuable cooperation between the Government of the Republic of Poland and the Government of the Republic of Indonesia.
