

## **Information of the Minister of Infrastructure of the Republic of Poland**

The extraordinary circumstances related to the Russian military aggression against Ukraine, which is a direct neighbour of the Republic of Poland, led to a humanitarian catastrophe and an influx of refugees. The international community admirably responded to this tragedy by declaring delivery of humanitarian aid to both refugees who managed to reach the territory of the European Union and those in need in the zone of military operations. In order to regulate and improve the movement of vehicles or convoys with humanitarian aid on the territory of the Republic of Poland, I hereby provide you with the following information.

The Polish government has decided to allow passage through Poland without a sanction in the form of an administrative fine for violating the obligation to pay tolls in the e-TOLL system of any humanitarian vehicle or convoy that, for various reasons, cannot pay the toll. Each institution or organization planning to transport humanitarian aid through the territory of the Republic of Poland is asked to provide the following information:

- contact details (headquater address, e-mail address, telephone number),
- number of vehicles,
- vehicle registration numbers
- indication of the country in which the vehicle is registered
- as far as it is possible: proposed itinerary of transport, the approximate period of travel through the territory of the Republic of Poland (in both directions),
- organization name.

In order to obtain possibility to travel through Poland without a sanction in the form of an administrative fine for violating the obligation to pay tolls in the e-TOLL system for vehicles or convoy with humanitarian aid, the package of the above-mentioned information should be reported to the Ministry of Infrastructure by e-mail to the following address: [humanitarianaid@mi.gov.pl](mailto:humanitarianaid@mi.gov.pl).

In addition, if the route of a vehicle or convoy with humanitarian aid runs through one of the toll motorway sections managed by private management, it is possible to pass these vehicles without paying the toll, provided that prior (24 hours in advance) contact the relevant concessionaire. In addition, please provide information also on the above-mentioned e-mail address and fulfilling the provisions given by the concessionaires.
