Competition Rules

1. The organiser of the 2nd 'CON BRIO' International Piano Competition is the Wojciech Kilar First Degree State Music School in Wodzisław Śląski.
2. The 'CON BRIO' Piano Competition is an international, single-stage competition for piano students of first degree state music schools, first degree music schools and first degree state comprehensive music schools.
3. The competition auditions shall take place on 11–12 May 2026 in the concert hall of the Wojciech Kilar First Degree State Music School in Wodzisław Śląski using a Yamaha piano.
4. The objective of the competition is to promote young talent, exchange experiences between teachers and integrate the music community.
5. Participants will compete in 6 groups:
 - Group 1 – Year 1 of the six-year cycle
 - Group 2 – Year 2 of the six-year cycle
 - Group 3 – Year 3 of the six-year cycle and Year 1 of the four-year cycle
 - Group 4 – Year 4 of the six-year cycle and Year 2 of the four-year cycle
 - Group 5 – Year 5 of the six-year cycle and Year 3 of the four-year cycle
 - Group 6 – Year 6 of the six-year cycle and Year 4 of the four-year cycle
6. The 'CON BRIO' Piano Competition Programme for all groups:
 - two contrasting pieces of music.
 - The programme must be performed from memory.
7. Auditions are open to the public.
8. The Jury shall evaluate participants on a scale of 1 to 25 points.
9. The Jury's decisions shall be final and indisputable.
10. The Jury may award a Grand Prix.
11. The competition shall offer in-kind prizes.
12. Ex aequo prizes may be awarded.
13. The Jury may award honourable mentions.
14. Winners shall be required to participate in the winners' concert.
15. Students of Jury members shall not be eligible to participate in the competition.
16. The conditions for participation in the competition are:
 - 1) payment of the entry fee for participation in the competition, in the amount of **PLN 150.00**, shall be paid by bank transfer to the following bank account: **PLN 73 1010 1212 3107 0513 9134 0000**, with the note:
Donation – 'CON BRIO' Piano Competition, along with the participant's first and last name, **by 20 April 2026**.

17. In the event of withdrawal from the Competition, the entry fee is non-refundable.

18. Participants are responsible for covering their own travel, accommodation and living expenses during the Competition.
19. Submission of an application is tantamount to acceptance of the 'CON BRIO' Piano Competition Rules.
20. In accordance with Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter referred to as the GDPR), the Wojciech Kilar First Degree State Music School in Wodzisław Śląski hereby informs that:

 - 3) Personal data (including image) will be processed for the purpose of promotion and implementation of tasks by the Wojciech Kilar First Degree State Music School in Wodzisław Śląski and will be made available in accordance with your consent pursuant to Article 6(1)(a) of the GDPR and Article 81 of the Act of 4 February 1994 on copyright and related rights concerning the dissemination of images;
 - 4) The recipients of personal data will be natural persons and legal entities having access to websites, portals and media in accordance with your consent;
 - 5) The controller does not plan to transfer data to a third country or international organisation, but it should be noted that the location of the final storage of the recorded image and personal data of the winners in connection with their publication on Facebook may involve the location of the data server outside the European Economic Area;
 - 6) The data will be processed until the moment that justifies its processing for information and promotional purposes or until you withdraw your consent to its processing;
 - 7) You have the right to request from the controller access to personal data concerning the data subject, data rectification, erasure or restriction of data processing, or the right to object to data processing;
 - 8) You have the right to withdraw your consent at any time without affecting the lawfulness of the processing carried out on the basis of your consent prior to its withdrawal;
 - 9) You have the right to lodge a complaint with the supervisory authority: Personal Data Protection Office, ul. Stawki 2, 00-193 Warsaw;
 - 10) Providing personal data is voluntary, but failure to do so will prevent you from participating in the Competition;
 - 11) The Personal Data Controller shall not make automated decisions and shall not profile personal data;
 - 12) The Personal Data Controller shall not plan to further process personal data for purposes other than those for which the personal data will be collected
