amending the regulation on fees for activities with regard to approval of active substances, safeners and synergists as well as activities in the scope of authorisation of plant protection products, parallel trade permits and permits for trial purposes

On the basis of Article 15 (8) of the Act of 8 March 2013 on Plant Protection Products (Journal of Laws Dz. U. of 2015, item 547, and of 2016, item 542), it is hereby ordered as follows:

- § 1. In the Regulation of the Minister of Agriculture and Rural Development of 12 July 2013 on fees for activities with regard to approval of active substances, safeners and synergists as well as activities in the scope of authorisation of plant protection products, parallel trade permits and permits for trial purposes (Journal of Laws Dz. U. item 854), the following changes are introduced:
- 1) § 2 and 3 shall be replaced by the following:
 - "§ 2. The amounts of fees referred to in § 1 point 1:
 - 1) letter a and letter b, the first, fourth and fifth sentence, are specified in Appendix No. 1 to the Regulation;
 - 2) letter b, the second, third and sixth sentence, are specified in Appendix No. 2 to the Regulation.
 - § 3. In the case, when the application related to issuance of a decision on changing the authorisation of a plant protection product or a parallel trade permit, or a permit for trial purposes is submitted in at least two scopes, referred to in item 1 point 5 of Appendix No. 1 to the Regulation, one fee shall be paid, corresponding to the amount required for submission of an application in the scope subject to the highest fee.";
- 2) the previous Appendix to the Regulation shall be marked as Appendix No. 1 to the Regulation and shall have the wording as defined in Appendix No. 1 to this Regulation;

- 3) Appendix No. 2 shall be added to the Regulation, in the wording specified in Appendix No. 2 to this Regulation.
- § 2. For the amount of fees for submission of an application, referred to in § 1 point 1 letter a of the Regulation amended in § 1, submitted before the effective date of this Regulation, the previous provisions shall apply.
 - § 3. The Regulation shall enter into force 14 days after the date of announcement.
