I. Terms of payment, reductions

- 1. The prices in this price list are gross prices, meaning that they include VAT.
- 2. Based on the order and the hunting protocol, the forest district inspectorate shall issue an invoice within 14 working days from the date of completion of the hunt. An electronic invoice is recommended. In the case of a traditional form of invoice, a scan of the invoice must be sent on the day of issue and a hard copy sent by post. The payment deadline is 14 days. An invoice issued to a foreign hunting office must be accompanied by a specification in English or German containing all the bill elements derived from the "hunting protocol". If the sum of the bill in whole or in part is not covered by the prepayment, the specification must also state the amount to be paid.
- 3. In the event that a complaint is lodged by a hunting office in accordance with the procedure set out in Chapter IX of this Appendix, payment for services provided and goods purchased may be suspended until the complaint's final resolution.

II. Hunting-free periods

The order to organise a stay and/or hunt on the dates listed below requires prior approval from the forest district inspectorate.

- 1 April 2024
- 1 November 2024
- 11 November 2024
- from 23 to 26 December 2024
- from 31 December 2024 to 1 January 2025

III. Other regulations and information

- 1. Each hunter coming to a hunt ordered by a hunting office at the RDLP will be insured against civil liability for damage caused to third parties during the hunt, based on an insurance agreement concluded by the forest district inspectorate with an insurance company. In case of an insured event, the insurer, the RDLP or any other domestic hunting office which referred the hunter must be notified immediately and a damage report in 4 copies must be drawn up, including a detailed description of the event's circumstances (possible sketch), personal details and address of the hunter and the injured party, as well as a claims assessment. The protocol is signed by the hunt leader, the hunter and the person drawing up the protocol on behalf of the organiser, and possibly the pilotinterpreter. The above procedure also applies if the event does not indicate liability on the part of the insurer but is an accident. The insurer makes the decision on the claim's validity.
- 2. Every hunter is obliged to strictly comply with Polish hunting regulations. All foreign hunters must confirm with their own signature that they have been made aware of and have accepted the hunting safety regulation. In the event of failure to comply with the regulations, particularly with regard to hunting safety, the leader is obliged to exclude the hunter from the hunt or, in a drastic case, to stop the hunt. Hunters will not be entitled to any compensation in this regard. Particular attention should be paid to the absolute prohibition of hunting by persons under the influence of alcohol or other drugs. The leader is obliged to not allow such a hunter to hunt or to remove him from the hunt.
- **3.** In the event of unlawful game shooting, i.e.:
- game not included in the list of game animals,
- during the protection period,
- game not included in the obtaining plan,
- resulting in exceeding the obtaining plan,

- this fact must be documented in the hunting protocol, and the competent authority must be notified. No fee shall be charged for the shooting. If the shooting has taken place during a hunt ordered by a foreign hunting office through the RDLP, the hunting office shall assume financial responsibility, in accordance with the agreements concluded, in an amount corresponding to the amounts concluded in the currently applicable Regulation on Illegally Obtained Game of the Minister responsible for the environment. This fee should not be included in the hunting invoice but in a separate note. If the unlawful shooting took place in a field hunting district, the equivalent amount must be transferred to the Voivode. The hunter does not have the right to take a trophy of illegally obtained game.
- **4.** A hunting protocol, specifying the quantity, type and quality of the services provided, shall be drawn up at the end of the hunt and the trophy measurements. Particular attention should be paid to specifying whether the client used the room as a single person or whether more people were staying in the room, whether the client used transport rental and other additional services. The transport provision can only take one of two forms: "transport on the hunt days, paid through the hunting office" if the hunt organiser provided the hunter with transport, or in other cases, "the hunter did not use the vehicle provided by the forestry district inspectorate".
- 5. Photographic documentation is required for each deer trophy (heads and antlers) and mouflons (horns). The following trophies should also be measured and valued according to the CIC formula buck antlers from 350g in net weight, deer stag head from 5.00kg in gross weight, fallow deer palms from 2,500g in gross weight, mouflon ram horns from 700mm in length and wild boar husks from 200mm in upper husk length. A valuation should also be made if the trophy has not reached the stated size but its appearance indicates the possibility of obtaining a medal. The CIC score must be recorded in the protocol. Photographs of trophies scoring as specified in Order No. 58 of the Director General of the State Forests of 1 October 2014 must be included in the online catalogue of hunting trophies

(<u>https://trofea.lasy.gov.pl</u>). The hunting protocol, and the possible measurement of trophies in the presence of the hunter or the leader of the hunting group, is drawn up by the pilot-interpreter and by a representative of the hunt organiser.

Protocols from hunts organised at the request of a domestic hunting office is drawn up by the pilot-interpreter or a representative of the client.

The protocol is signed by:

- the forest district inspector or the person authorised by them,
- the hunting forester,
- the hunter,
- the pilot-interpreter.

The protocol is drawn up in Polish and in a foreign language which the foreign hunter understands, on a binding numbered form in 3 copies:

- the original protocol is received, as an annex to the invoice, by the hunting office
 - that settles accounts with the forest district inspectorate,
- 1 copy of the protocol is given to the hunter,
- 1 copy of the protocol is kept at the forest district inspectorate.

A scan of the original protocol shall be forwarded to the RDLP (regardless of who ordered the hunt) – electronically only, in PDF file format.

The hunting protocol constitutes the basis for:

- drawing up the hunting invoice,
- <u>in matters of dispute dealing with any complaints made by either party.</u>

The "REMARKS" section of the hunting protocol should list and graphically separate from the other entries, all facts that may have a major impact on the hunt settlement, e.g. transport during the hunt, the use of rooms, information on shortening or extending the stay, etc. Unless any of the parties raise objections – a note should be made in the "Remarks" section: "No remarks".

If the hunting order has not been fulfilled, the reasons for the negative outcome of the hunt must be stated in the "Reasons for failure to shoot game" section. Entries in the "Remarks" and "Reasons for failure to shoot game" sections may be made by either party.

- **6.** All trophies to be weighed shall be weighed 24 hours after completion of the preparation. In the event of an early departure of the hunter from the hunt, the above actions must be carried out immediately prior to the hunter's departure. The following reduction factors are introduced:
 - measurement immediately after preparation completion up to 3 h 59 min:
 - 8% of the weight indicated by the measuring device,
 - measurement between 4 hrs and 7 hrs 59 mins after preparation completion:
 - 7% of the weight indicated by the measuring device,
 - measurement between 8 hrs and 11 hrs 59 mins after preparation completion:
 - 5% of the weight indicated by the measuring device,
 - measurement between 12 hrs and 15 hrs 59 mins after preparation completion: 4% of the weight indicated by the measuring device,
 - measurement between 16 hrs and 19 hrs 59 mins after preparation completion: 3% of the weight indicated by the measuring device,
 - measurement 20 hours after preparation completion: **no deductions**.

If the hunter takes the whole head of the hunted deer, the estimated weight of the trophy is stated in the protocol. The specified estimated weight of the trophy will be the sole basis for calculating the shooting fee and will not be subject to complaint once the protocol has been signed. If the hunter takes the whole boar head, the visible part of the tusks will be taken as 1/3 of their total length for the calculation of the shooting fee. The weight of a roe buck antlers should be entered into the

protocol as a mathematical operation: gross weight -90g = net weight. The weight read from the measuring device is used for other species (deer, fallow deer).

7. The hunter has the right to take the hunting trophies specified in the price list, the value of which is included in the shooting price. Furthermore, the hunter may buy (subject to entry in the hunting protocol) the carcasses and/or hides of the hunted game.

It is not possible to purchase and export wild boar carcasses and skins and their parts in hunting districts restricted due to African swine fever (ASF).

- **8.** A fee for wounding the game will only be charged if the wounded animal is not found. The hunt leader or guide on an individual hunt is obliged to provide the hunter with indisputable evidence of injury in the form of paint or cuttings. A dog, bred to search for wounded game, must be used. The hunter should be allowed to participate in the search for the wounded game. At the hunter's express request, the search for the wounded game may continue after his/her departure, provided that the hunter submits undertakes to pay for the shooting at the rate specified in the price list, less the fee for wounding the game, in the hunting protocol.
- **9.** All shots fired during individual and group big game hunts shall be entered in the protocol.
- **10.** If the hunter leaves a game trophy or hide obtained during a hunt in Poland (does not take it with him/her at the end of the hunt), this fact should be clearly noted in the hunting protocol. The forest district inspectorate does not act as an intermediary for the ordering of services by hunters involving the hide tanning or making of medallions. At the client's request, the preparer should be contacted if possible. The pilot-interpreter employed on the hunt, if necessary, should assist with the interview. All settlements for this service, including the transport of the trophy, are made directly between the hunter and the person undertaking the service (e.g. the tanner or preparer).

- 11. If a trophy size limit is included in the hunting order (e.g. buck with antlers up to 149 g in net weight, deer stag up to 3.49kg in head weight or mouflon ram up to 700 mm in horn length) with the GUARANTEE annotation, the forest district inspectorate is responsible for carrying out the shooting in accordance with the order. If a trophy size of shot game exceeds the agreed limit, the shooting fee may only be charged up to the amount of the order (subject to separate regulations for bundle prices for deer stags and mouflon rams).
- **12.** The forest district inspectorate organising the hunt shall be responsible for all claims of clients resulting from incorrect organisation of the hunt, the provision of services in discordance with the order, concerning e.g. the quality (cleanliness) of the lodging and board, incorrect work of the hunting staff.
- 13. The forest district inspectorates shall be obliged to inform about all agreements, contracts and orders concerning hunting organised through hunting offices other than those located in the RDLP (in electronic form at the least).
- **14.** Forest district inspectorates issue invoices for services provided to and goods purchased (hides and/or game carcasses) by foreign hunters directly to:
- a) foreign hunting offices, in the case of hunts ordered through the RDLP,
- b) Polish hunting offices, in the case of other hunts.
- 15. Invoices are drawn up in the Polish currency (PLN).
- **16**. The forest district inspectorates have the right to reduce the prices contained in this appendix by negotiating up to 15% and to increase them without limitation. It is also permitted, subject to a separate approval of the RDLP, to establish flat-rate and bundle prices other than those contained in this appendix and discounts of more than 15%.

17. In the case of individual hunts, the presence of a pilot-interpreter is mandatory at the beginning and end of the stay (drawing up the protocols – at the one-day rate set out in section V. paragraph 7/1.).

18. In the case of hunting offices based in Poland, the hunting office is responsible for providing a pilot-interpreter.

19. It is not possible to combine types of hunts during the day (e.g. doing a morning goose hunt with other hunters hunting deer stag or non-trophy game in the morning).

20. A hunter is only allowed to go to the hunting ground twice during a single day. It is possible to organise an additional hunt, subject to prior approval by the organiser – the forest district inspectorate.

21. The organisation of group hunts is only possible on working days, i.e. from Monday to Friday, which does not exclude the arrival or departure of groups of hunters on non-working days.

It is necessary to sound the traditional hunting signals. Alternatively, the presentation of commemorative diplomas or medals is recommended.

- 2/3. Deer hinds and calves throughout the season in all forest district inspectorates, except the Milicz and Jawor forest district inspectorates:
- 15%
- **3.** For persons accompanying a hunter or clients for holiday stays (without hunting), in all forest districts with hunting quarters, except the Jawor forest district inspectorate:

- 20% discount on the price list rate specified for hunters.
- **4.** For persons accompanying a hunter or clients for holiday stays (without hunting), in the Jawor forest district inspectorate:
- 10% discount on the price list rate specified for hunters.
- **5.** Stay of hunters after the last day of the group hunt, in all forest district inspectorates, except the Jawor forest district inspectorate:
- 20% discount on the price list rate specified for hunters.
- **6.** Stay of hunters after the last day of the group hunt in the Jawor forest district inspectorate:
- 10% discount on the price list rate specified for hunters.

Other discounts, as well as bundle and flat-rate prices negotiated individually for individual hunts are also permitted as described in Chapter III item 16 of this Appendix.

X. Penalty fees

- 1. For non-performance of the sale of hunts previously ordered by the Hunting Office according to the provisions set out in §8 of Agreement no. of (date).
- 2. For cancellation of a hunt less than 7 days before its start date the fee is equivalent to the due amount for 2 days of stay benefits and hunt organisation, and for 2 days of the pilot's work if an agreement for his/her services has been concluded. This fee will be charged to all hunting offices selling hunts in the forest district inspectorate, based on one-year or hunt-specific agreements.
- **3.** For a shortened stay of 2 days or more hunting offices must be charged:

- 3/1. per hunter for 2 days of stay and hunt organisation.
- 3/2. per accompanying person for 2 days of stay.
- 3/3. per hunter and accompanying person aged over 12 for 2 days of the pilot-interpreter's work.
- **4.** If the stay and hunt is shortened by less than 2 days, the due amount for the stay and hunt organisation is charged according to the order placed.
- **5.** A penalty fee of 100% of the shooting price is charged for incorrectly shot game.

If a hunter shoots the game in discordance with the selection criteria or shoots a game not intended for shooting, contrary to the instructions given by the group hunt leader, the forest district inspectorate shall document this fact in the hunting protocol and charge an additional penalty fee.

The penalty fees referred to in items 3, 4 and 5 apply to all hunting offices.

XI. Complaints

concluded Complaints from hunting offices based abroad that have an agreement with the RDLP in Wrocław with regard to the hunt's organisation, its outcome, conditions of accommodation and board, trophy measurements, work of the pilot etc., will be processed by the RDLP. Complaints from Polish hunting offices will be processed by the forest district inspectorate that concluded the agreement. The Director of the RDLP in Wrocław is the appeal authority for partners dissatisfied with the forest district inspectorate's processing of complaints. Complaints will be processed provided that:

• they are reported during or immediately after the hunt and recorded in the hunt protocol,

or

• they are submitted in writing at a later date if the hunting protocol contains remarks justifying the complaint.
