## NOTIFICATION OF INTENT (NOI) TO ISSUE AN INVITATION FOR INTERNATIONAL BIDDING (IFIB)

- 1. The Science & Technology Collaboration Support Office (CSO) located in Neuilly-sur-Seine, France, intends to invite international bids for the replacement of the security windows, their frames as well as some entrance doors of its buildings in an effort to increase the overall site security and energy consumption efficiency.
- 2. Title of the IFIB: CSO Security Windows Replacement
- 3. Requirement: The CSO requires contractors' support for the replacement of the current security window infrastructure equipped with BR3, P5A and SP10 glass by a common standard BR6-NS i.a.w. the European Norm (EN) 1063 throughout. It is planned to replace some 41 units of varying sizes with an estimated total glass surface of approx. 100 m2. These works will include supporting works such as masonry -, electrical -, metal and other refurbishment works.
- 4. Type of Contract: Fixed-Price Contract
- 5. Period of Performance: Summer 2020
- 6. Bidding Procedure: Sealed Bidding, Two-Envelope method.
