

**NOTICE TO INJURED PARTIES REGARDING DISCONTINUATION OF PREPARATORY PROCEEDINGS
CASE FILE NO. 3048-1.DS.28.2025**

1. District Investigation Division of the District Prosecutor's Office in Sosnowiec hereby informs all injured parties in case no. 3048-1.Ds.28.2025 that, pursuant to the decision dated 23 May 2025, the investigation into the following matter has been discontinued.

The decision was based on the statute of limitations having expired for the offence /pursuant to Article 17 § 1(6) of the Code of Criminal Procedure.

The case file no. 3048-1.Ds.28.2025 was registered in the District Prosecutor's Office in Sosnowiec pursuant to the decision on separating materials from the investigation no. 3048-1.Ds.46.2024, conducted against Michał K., suspected of the act under Article 202 § 3 of the Penal Code and others.

Attached are the current instructions on the rights and obligations of the injured party in criminal proceedings.

Pursuant to Article 131 § 2 and § 3 of the Code of Criminal Procedure, the decision on discontinuation of the investigation in case no. 3048-1.Ds.28.2025 will be delivered to the injured party who requests it within 7 days of publication of this announcement.
