RE: Correspondence consultations for the Draft Land Acquisition and Resettlement Action Plan for the Works Contract 3A.2/4 Flood Protection in Serafa Valley – Serafa 2 Reservoir

Dear Sir/Madam,

The State Water Holding Polish Waters RZGW in Cracow (hereinafter referred to as the Investor) plans to implement the investment titled *Works Contract 3A.2/4 Flood Protection in Serafa Valley – Serafa 2 Reservoir* within the framework of *the Odra-Vistula Flood Management Project* (hereinafter referred to as the OVFMP) to be implemented within the City of Cracow and the Town of Wieliczka, Municipality of Cracow, Commune of Wieliczka.

The objective for implementation of *the Odra-Vistula Flood Management Project* is raising the flood protection level for the residents living in selected areas of the Odra River Basin and of the Upper Vistula River Basin, and institutional improvement of the governmental administration in the range of securing more efficient protection against summer floods and winter floods and rapid floods. The OVFMP Project is co-funded by the International Bank for Reconstruction and Development (hereinafter referred to as the World Bank or the IBRD) (loan agreement no. 8524 PL dated September 10, 2015), Council of Europe Development Bank (frame loan agreement no. LD 1866 dated May 24, 2016), European Union's Cohesion Fund (IEOP 2014-2020), and the State Budget.

The Works Contract 3A.2/3, comprising development of a dry flood storage reservoir, shall be implemented as one of the tasks within the framework of OVFMP. Due to engaging funds of the World Bank for implementation of the *Works Contract* in question, the Investor is obliged to apply so called Operational Policies of that International Co-funding Institution. It is especially obliged

to apply *Operational Policy OP 4.12 – Involuntary Resettlement* – containing main rules and procedures forming an approach of the IBRD toward involuntary resettlement associated with investment projects. Within the framework of fulfilling regulations under that Policy, a document titled *Land Acquisition and Resettlement Action Plan* (hereinafter referred to as the LA&RAP) was developed, and it is currently subject to disclosure / public consultations, as it contains information on legal bases linked with the purchase of properties and on measures planned to mitigate adverse impact on Project Affected Persons and to improve or – at least – restore their living conditions. **In case of the Works Contract 3A.2/4 there are no physical or economic resettlements, and only undeveloped plots or parts of plots shall be acquired for the purpose of Contract implementation.**

Your property is located within the area of permanent acquisition and / or in the area of permanent or temporary restrictions associated with an obligation to redevelop a network within the aforementioned *Works Contract*, what has already been informed to you in the letter dated 2019. The Consultant working on behalf of the Investor, AECOM Polska Sp. z o.o., has informed private owners of properties to be acquired on behalf of the State Treasury by letter about the socio-economic survey to be run in September and in October 2019. Some of you attended the survey, but we were not able to contact the others.

We would like to invite you for reviewing the Draft LA&RAP and for expressing your opinion about that study, and for asking questions / notifying the remarks. A Question Form attached may be helpful for that purpose. You will also find the following appendices attached to this letter: **announcement and information brochure, in which you will find all contact data** to send the questionnaire back or to provide oral information by phone.
