

INFORMATION ON THE PROCESSING OF PERSONAL DATA PROVIDED DIRECTLY BY A RELATED PERSON

In accordance with Article 13 (1) and (2) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Processing Regulation) (OJ EU L 119 of 05/04/2016, page 1, as amended, hereinafter referred to as the Regulation), State Water Holding Polish Waters informs that:

- 1) State Water Holding Polish Waters with its office at 80/82. Grzybowska Street, 00-844 Warsaw (hereinafter referred to as PGW Polish Waters) is an administrator for your personal data.

- 3) Your personal data shall be processed to implement an obligation imposed onto the administrator, i.e. performance of **consultations for the Draft Land Acquisition and Resettlement Action Plan for the Works Contract 3D.2/2 – Expansion of the left and right embankment of the Biala River in the Tarnow Municipality and the City of Tarnów**, in accordance with Operational Policy OP 4.12 of the International Bank for Reconstruction and Development (World Bank), based upon the Frame Loan Agreement no. LD 1866 (Article 6 (1) letter c) of the Regulation).
- 4) Your personal data may be transferred to authorized units only, based upon provisions of the commonly binding law.
- 5) Your personal data shall be processed in the time necessary for achievement of processing purpose given in item 3, and then during the period determined in accordance with regulations issued based upon Article 6 (2) of the Act of July 14, 1983 on the state archival resources and files.
- 6) Due to processing of your personal data you have the following rights:
 - a) Right of access to your personal data, including right to obtain copies of that data (legal basis: Article 15 of the Regulation);
 - b) Right to demand correction (rectification) of your personal data in case the data is incorrect or incomplete (legal basis: Article 16 of the Regulation);
 - c) Right to demand limitation of processing for your personal data (legal basis: Article 18 of the Regulation).
- 7) Due to processing of your personal data you are entitled to claim to the President of the Personal Data Protection Office, if you would consider that processing of your personal data violates provisions of the regulation (legal basis: Article 77 of the Regulation).
- 8) Provision of your personal data is a legal obligation and is necessary for achieving the aims discussed under item 3, and a consequence of not providing the personal data is inability to achieve those aims.

- 9) Your personal data shall not be processed in an automated way and shall not be profiled.
