1. In accordance with the stipulations of the Bi-Sc Procurement Directive 60-70, Annex B, the following information is provided on an Invitation for International Bidding (IFB) that this Headquarters has the intention to release:

IFIB Reference: IFIB-ACT-SACT-21-111 Title of IFIB: M&S SME Contractor Support. **Requirement**: HQ SACT/Modelling & Simulation (M&S) and Training Technologies Branch provides M&S and Training Technology support to the NATO Command Structure (NCS) in the areas of operational planning, capability development, defence planning, strategic and operational exercising and wargaming, utilizing Subject Matter Experts in M&S, education and training technologies, instructional system designs and information systems. In July 2020, HQ SACT received a significant tasking from the Military Committee regarding Russian Missile Studies. In addition to the multi-year studies, there is a series of white papers that must also be produced. The analytical studies will be fully supported by simulation and wargaming. It has been decided that the peacetime establishment positions will conduct the studies even though those positions were already fully programmed on other activities. Therefore, to create capacity within the M&S Section, it will be necessary to temporarily reinforce the section with additional resources. Type of Contract: Firm Fixed Price (FFP) Level of Effort. Period of Performance: Base: 1 JANUARY 2022 - 31 DECEMBER 2022 with (1) one 12-month option period (2023). **Bidding Procedure:** The intended procurement method will be International Competitive Bidding (Sealed Bidding) in accordance with Bi-SC Procurement Directive 60-70, Annex B, and Procedures for International Competitive Bidding (2015 Edition).
