

Competition for the position: LECTURER

Rector - Commandant of the General Tadeusz Kościuszko Military University of Land Forces announces a competition for the position of **lecturer** (civilian employee) at the Faculty of Command in the Reconnaissance Department and Aeromobile Forces in a group of didactic staff.

Post: full-time; employment contract. (from 01.10.2023)

Place of employment:

General Tadeusz Kościuszko Military University of Land Forces, ul. Piotra Czapkowskiego 109, Wrocław

The scope of the main tasks performed at the workplace:

- conducting lectures on subjects covering the area of military reconnaissance, methods and tactics of reconnaissance in tactical operations as well as the organization and means of combat selected armies of other countries. Conducting lectures concerns training groups in all forms of education carried out at the University;
- conducting practical training, in various field and environmental conditions, including exercises, seminars, group classes and training in the above-mentioned topics. Improving the practical skills of students in planning, commanding, carrying out reconnaissance in tactical activities, identification and recognition means of combat of other countries armies;
- prepare training documentation and required documents supporting the didactic process as well as development and updating of education and training programs;
- using elements of the IT system supporting the University management process in the area of its competence.

Necessary requirements:

- completed higher education;
- knowledge of tactics and operation of reconnaissance subunits and general military subunits of the Polish Armed Forces;
- knowledge of organizational structures and tactics of units of other non-NATO countries;
- knowledge of the means of combat used in the Polish Armed Forces and in the non-NATO countries;
- knowledge of historical and current armed conflicts;
- several years of experience in working with teams of people in various positions, including managing or commanding.

Additional competences:

- experience in teaching (didactic positions);
- experience in commanding or participation in the work of the military staffs in the Polish Armed Forces or experience;
- experience in work or service in Polish Military Contingents outside the country;
- the ability to use foreign languages;
- the ability to share knowledge and develop training documentation.

- in the case of the candidacy of foreigners whose documents are not issued in Polish, it is necessary to submit copies of the documents together with a sworn translation;
- if the academic title has been obtained at a foreign university, a copy of the document confirming the recognition of the academic title (if required by law) or a declaration as to the basis for recognition of the title on the basis of an agreement on recognition of the equivalence of education in Poland should be submitted;
- in the case of candidates who are not Polish citizens, a declaration of undergoing the screening procedure is required.
