November 2025

At the end of November 2025 the State Treasury (ST) debt amounted to **1,908,835.2 million***, i.e.:

- increased by PLN 14,732.7m (+0.8%) in November 2025;
- increased by PLN 279,495.3m (+17.2%) compared to the end of 2024.

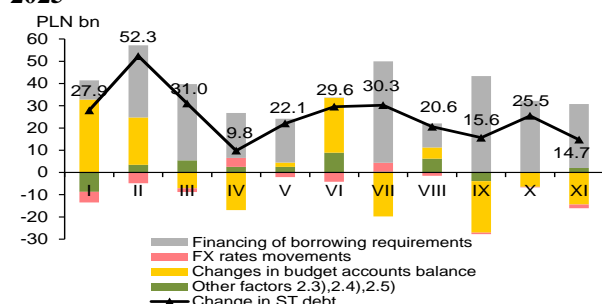

Factors affecting changes in the ST debt in January-November 2025



The increase in the debt in November 2025 was mainly a result of:

- the State budget net borrowing requirements (PLN +28.8bn), including State budget deficit of PLN 17.8bn, balance of liquidity management consolidation (PLN +2.3bn), European funds management (PLN +4.1bn) and granted loans balance (PLN +1.4bn);
- a decrease in budget accounts balance (PLN -14.4bn);
- transfer of TS under other acts than the Public Finance Act (PLN +0.9bn);
- change in other State Treasury debt (PLN +0.9bn), including an increase in deposits from PFSE (PLN +0.6) and a decrease in deposits from GGE (PLN -1.1bn) allocated under the liquidity management consolidation and an increase in other deposits (PLN +1.3bn);
- the FX rates movements (PLN -1.6bn) – appreciation of the zloty against EUR by 0.4%, against USD by 0.3% and against JPY by 1.7%.

The increase in the debt since the beginning of 2025 was mainly a result of:

- the State budget net borrowing requirements (PLN +275.9bn), mainly as a result of State budget deficit of PLN 244.9bn, funds for financing European Union funds budget deficit (PLN +8.7bn), granted loans balance (PLN +10.6bn), European funds management balance (PLN +18.2bn) and balance of liquidity management consolidation (PLN -7.3bn);
- a decrease in budget accounts balance (PLN -2.1bn);
- transfer of TS under other acts than the Public Finance Act (PLN +9.5bn);
- change in other State Treasury debt (PLN -2.1bn), including an increase in deposits from PFSE (PLN +11.0), a decrease in deposits from GGE (PLN -10.5bn) allocated under the liquidity management consolidation and a decrease in other deposits (PLN -2.6bn);
- the FX rates movements (PLN -13.6bn) – the appreciation of the zloty against USD by 10.7%, against EUR by 0.8% and against JPY by 10.5%.

In November 2025 the domestic ST debt (according to the place of issue criterion) increased by PLN 14.8bn, including balance of issuance of marketable Treasury securities (TS; PLN +13.6bn), balance of issuance of saving bonds (PLN +1.6bn) and a decrease of the other ST debt (PLN -0.4bn).

In November 2025 the foreign currency ST debt decreased by PLN 0.1bn which was the result of:

- the positive balance of debt issuance:

- the FX rates movements (PLN -1.6bn)
- increase of the other ST debt (PLN +1.3bn).

Since the beginning of 2025 the domestic ST debt increased by PLN 274.7bn. In the same period the **foreign currency ST debt** increased by PLN 4.8bn, which was the result of:

- a decrease in the debt denominated in EUR (EUR -0.9bn), an increase in debt denominated in USD (USD +5.5bn) and no change in debt denominated in JPY;
- the appreciation of the zloty (PLN -13.6bn).

According to preliminary data, the **ST debt at the end of December 2025** amounted to **ca. PLN 1,952.0bn**, and increased by PLN 43.1bn (+2.3%) m/m. According to the place of issue criterion debt amounted to:

- **domestic debt:** ca. PLN 1,554.6bn,
- **foreign debt:** ca. PLN 397.4bn (i.e. 20.4% of the total ST debt).

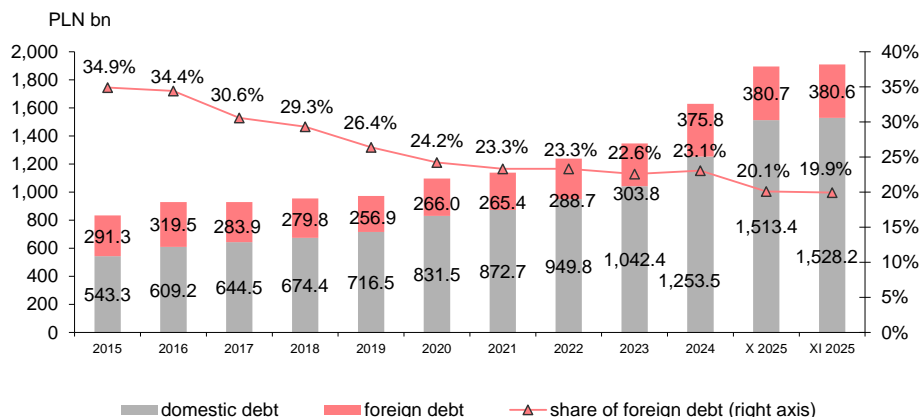

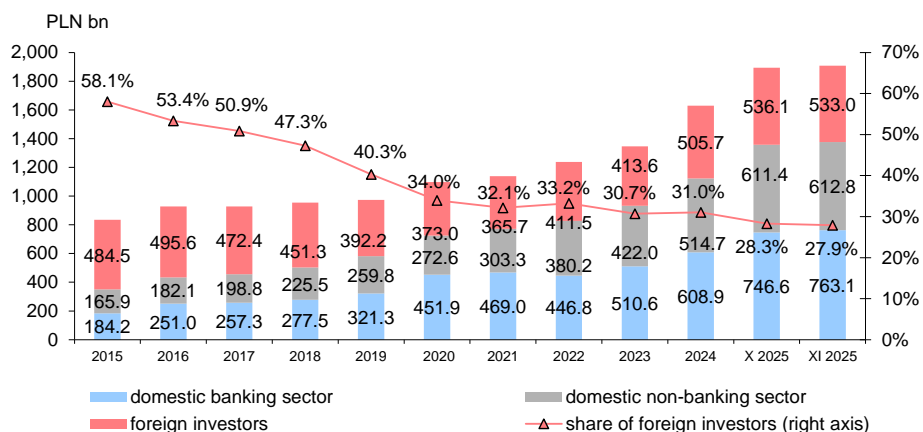
ST debt according to the place of issue criterion

In November 2025 the share of the foreign currency debt in the total ST debt amounted to 19.9%, i.e. it decreased by compared to the previous month by 0.2 pp and decreased by 3.1 pp compared to the beginning of 2024. Decrease in the share in November was mainly a result of FX rates movements and an increase in domestic debt. The debt management strategy assumes maintaining the share of foreign currency debt in the total ST debt below 25% with possible temporary deviations due to market or budgetary conditions.



ST debt by holder

In November 2025 the share of foreign investors in the total ST debt amounted to 27.9%, i.e. it decreased by 0.4 pp m/m and decreased by 3.1 pp since the beginning of 2024. The decrease in share in November resulted from high growth dynamics of the banking sector holdings in the domestic TS market.

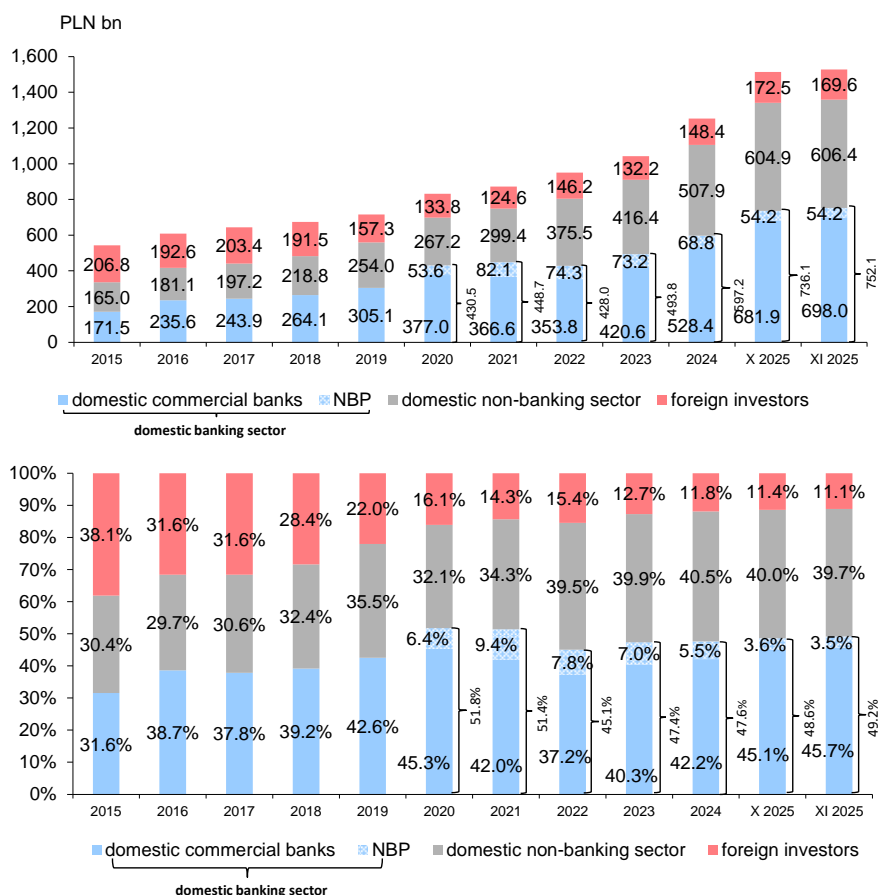


Domestic ST debt by holder in nominal value and structure

In November 2025 an increase in the domestic debt held by residents took place (PLN +17.6bn, i.e. banking sector: PLN +16.0bn, including NBP: no change and non-banking sector: PLN +1.6bn) and an decrease in foreign investors holdings (PLN -2.8bn).

Since the beginning of 2025 changes in holdings of the domestic debt by the type of investor amounted to as follows:

- domestic banking sector: PLN +154.9bn (including NBP: PLN -14.6bn),
- domestic non-banking sector: PLN +98.6bn,
- foreign investors: PLN +21.2bn.

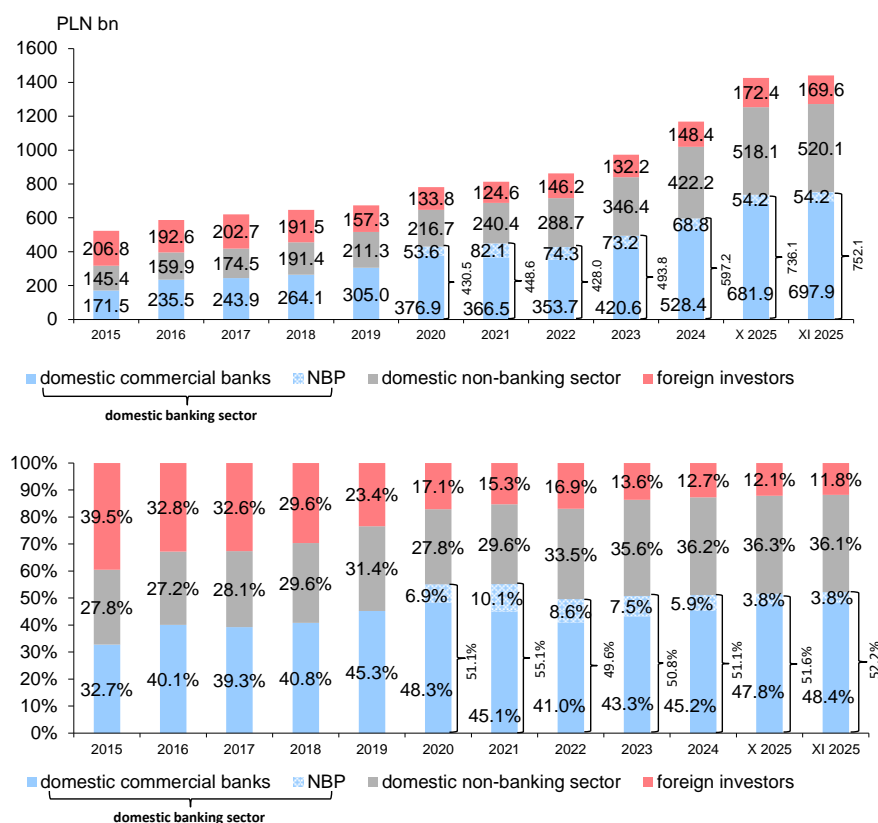


Domestic TS debt by holder in nominal value and structure

In November 2025 residents increased their domestic TS holdings by PLN 18.0bn in total, i.e. banking sector: PLN +16.0bn (including NBP: no change) and non-banking sector: PLN +2.0bn. In the case of foreign investors an increase in holdings of PLN 2.8bn was recorded.

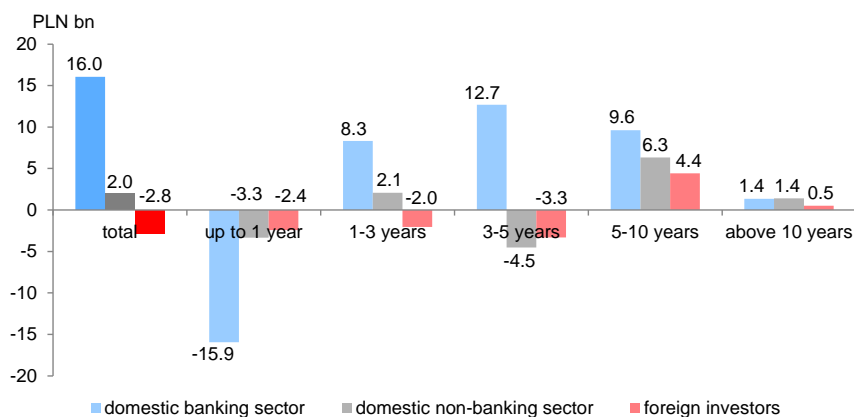
Since the beginning of 2025 changes in holdings of the domestic TS debt by type of investor amounted to as follows:

- domestic banking sector: PLN +154.9bn (including NBP: PLN -14.6bn),
- domestic non-banking sector: PLN +97.8bn,
- foreign investors: PLN +21.2bn.



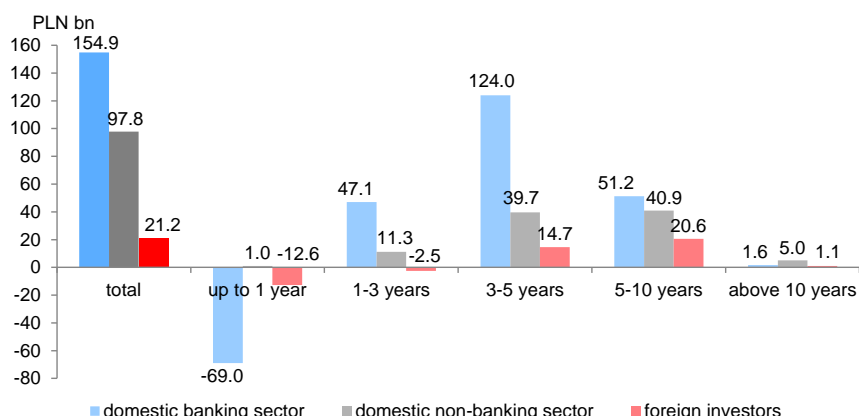
Changes in the domestic TS debt according to residual maturity by the type of investor in November 2025 m/m*

An increase in domestic TS holdings of banking sector observed in November 2025 was mainly the result of an increase in their TS portfolios in the instruments with maturities above 1 year. In the case of non-banking sector their TS holdings increased due to rise in instruments with maturities between 1 and 3 years and over 5 years. A decline in the TS portfolios held by foreign investors was mainly the result of a decrease in their TS portfolios in the instruments with maturities up to 5 year.



Changes in the domestic TS debt according to residual maturity by the type of investor in 2025*

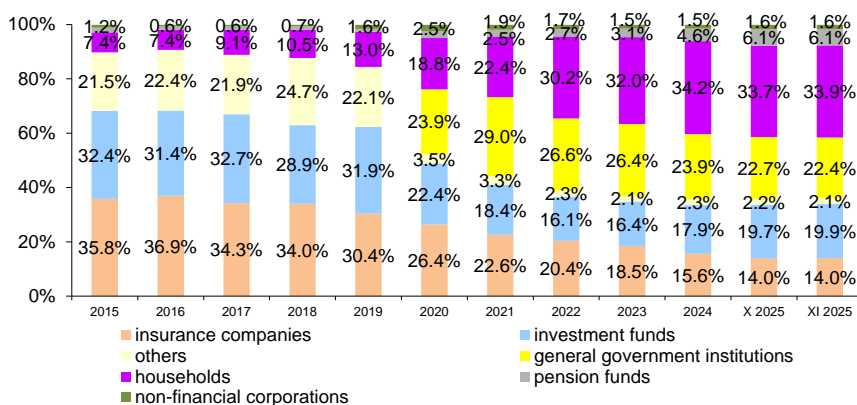
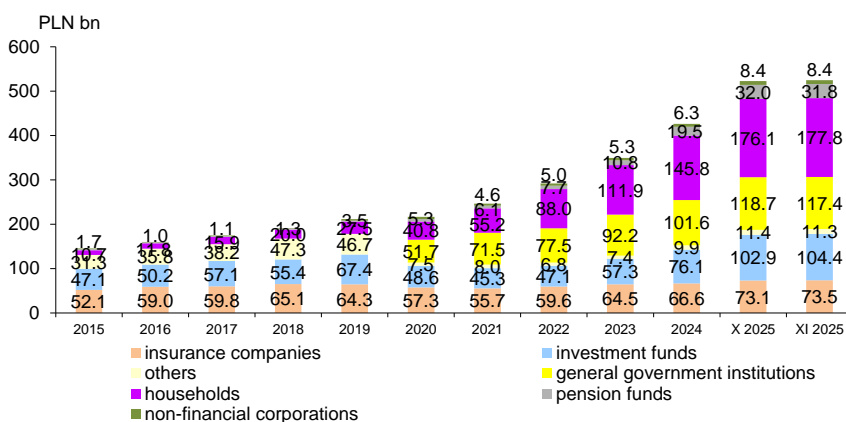
From January to November 2025 the banking investors increased their TS portfolios which was the result of growth in holdings in the instruments with maturities over 1 year. Non-banking investors increased their TS portfolios in the instruments with all maturities. An increase in the TS portfolios held by foreign investors was a result of an increase in their TS portfolios in the instruments with maturities over 3 years.



The domestic TS debt towards domestic non-banking sector by holder – in nominal value and structure**

In November among domestic non-banking entities the main holders of the domestic TS were households (33.9%), general government institutions*** (22.4% share in November 2025, this category includes, among others: Bank Guarantee Fund and Demographic Reserve Fund), investment funds (19.9%), and insurance companies (14.0%).

In November 2025 the domestic TS holdings of the non-banking sector increased by PLN 2.0bn m/m and by PLN 98.7bn since the beginning of 2024. An increase in holdings m/m was mainly a result of an increase in the TS portfolios of households (PLN +1.8bn) and investment funds (PLN +1.5bn), with a decrease of general government institutions (PLN -1.3bn).



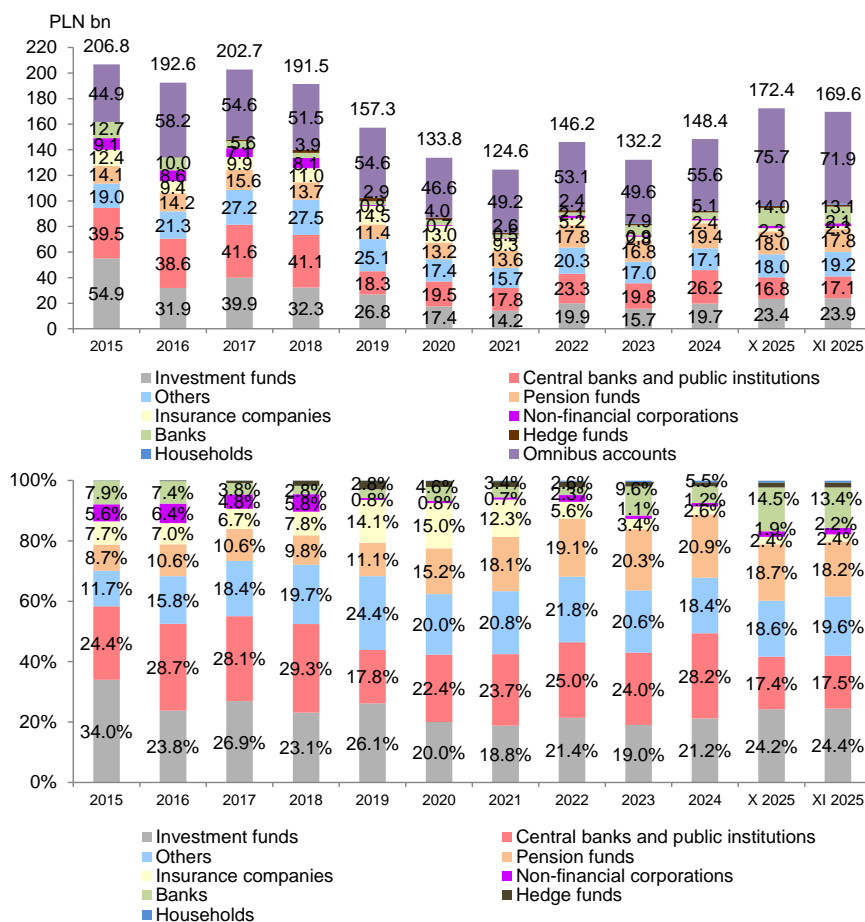

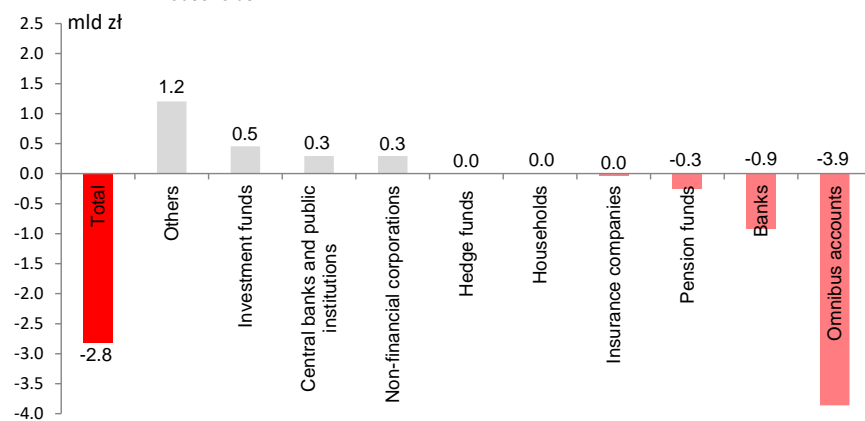
The domestic TS debt towards non-residents* by holder in nominal value and structure**

The structure of non-residents holding the domestic TS in their portfolios is well-diversified, with a dominant role of stable institutional investors: investment funds (24.4% share in November 2025), pension funds (18.2%), central banks and public institutions (17.5%), banks (13.4%) and insurance companies (2.4%). A significant part of the domestic TS debt to foreign investors is registered on omnibus accounts (PLN 71.9bn), which allow investors to buy the TS without the need to have a separate account in Poland.



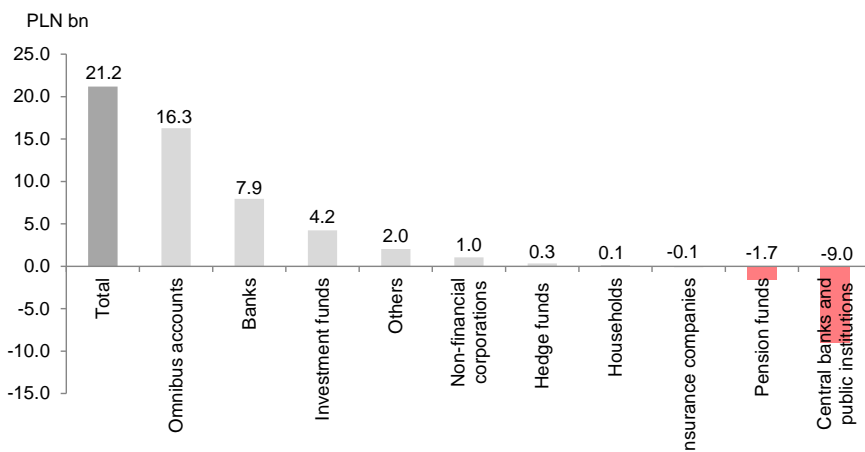
Changes in the domestic TS debt towards non-residents by holder in November 2025 m/m

In November 2025 foreign investors decreased their holdings in the domestic TS debt by PLN 2.8bn. The highest decrease was recorded in the case of omnibus accounts (PLN -3.9bn), banks (PLN -0.9bn) and pension funds (PLN -0.3bn). On the other hand, an increase in holdings was recorded in case of other entities (PLN +1.2bn), investment funds (PLN +0.5bn), central banks and public institutions (PLN +0.3bn) and non-financial corporations (PLN +0.3bn).



Changes in the domestic TS debt towards non-residents by holder in 2025

From January to November 2025 non-residents increased their holdings in the domestic TS debt by PLN 21.2bn. The biggest increase in the portfolio concerned omnibus accounts (PLN +16.3bn), banks (PLN +7.9bn) and investment funds (PLN +4.2bn). On the other hand, a decrease in exposure was recorded mainly in case of central banks and public institutions (PLN -9.0bn) and pension funds (PLN -1.7bn).



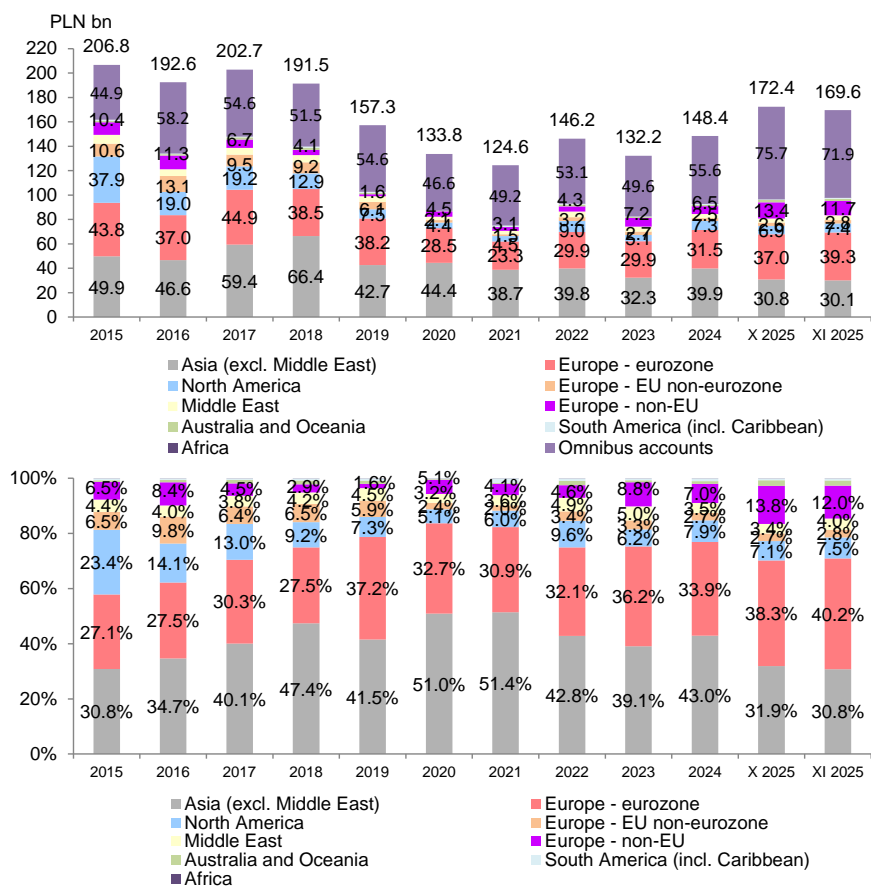

The domestic TS debt towards non-residents by region in nominal value and structure*

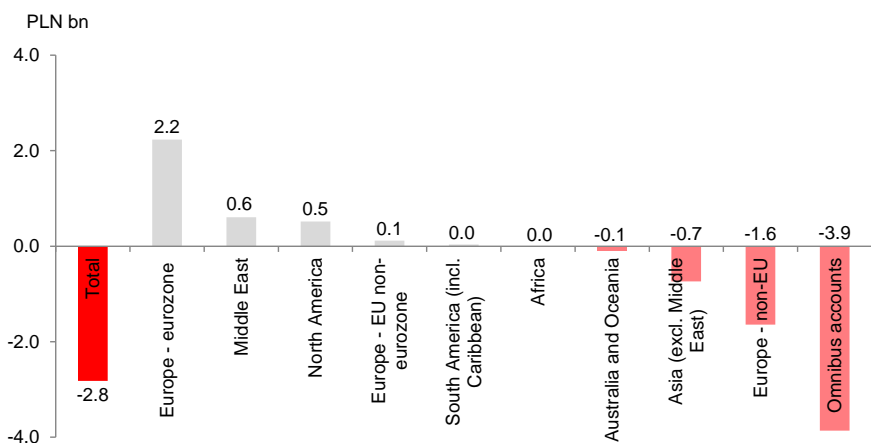
The geographical structure of the domestic TS held by foreign investors is well-diversified. In November 2025 the largest TS portfolios reached entities from eurozone countries: 40.2% (PLN 39.3bn, including non-residents from Luxembourg: PLN 10.5bn, the Netherlands: PLN 9.6bn, Ireland: PLN 6.2bn and Germany: PLN 5.5bn). The second largest group of holders of the TS were investors from Asia: 30.8%, representing debt in the amount of PLN 30.1bn, of which PLN 17.6bn was held by investors from Japan and PLN 10.6bn by Asian central banks. Non-residents from Europe non-EU countries (12.0%, representing debt in the amount of PLN 11.7bn, of which PLN 7.2bn was held by investors from the UK) also entities from North America held significant TS portfolios: 7.5% (PLN 7.4bn, including non-residents from the United States: PLN 6.9bn). The share of investors from other regions amounted to 8.9%.

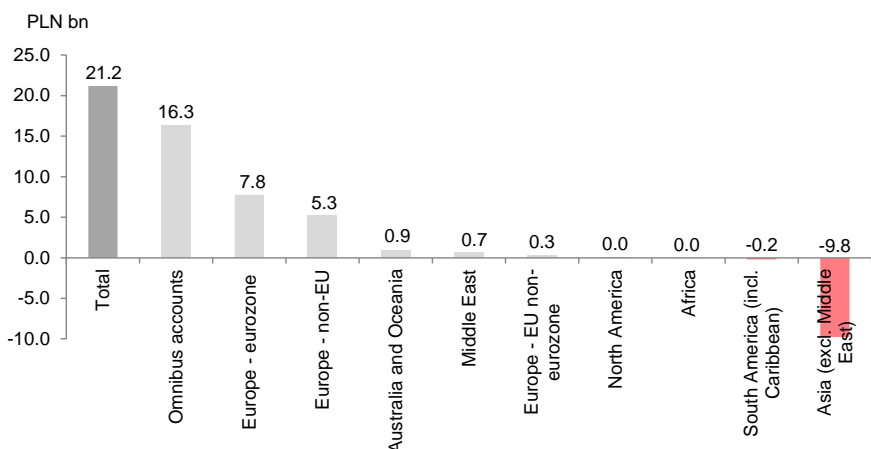
Changes in the domestic TS debt towards non-residents by region in November 2025 m/m

In November 2025 a decrease in the domestic TS held by non-residents resulted mainly from a decrease in the TS held by investors at omnibus accounts (PLN -3.9bn), investors from Europe non-EU (PLN -1.6bn) and investors from Asia (PLN -0.7 bn). An increase in TS holdings was recorded in case of investors from Europe – eurozone (PLN +2.2bn), investors from Middle East (PLN +0.6bn) and from North America (PLN +0.5bn).



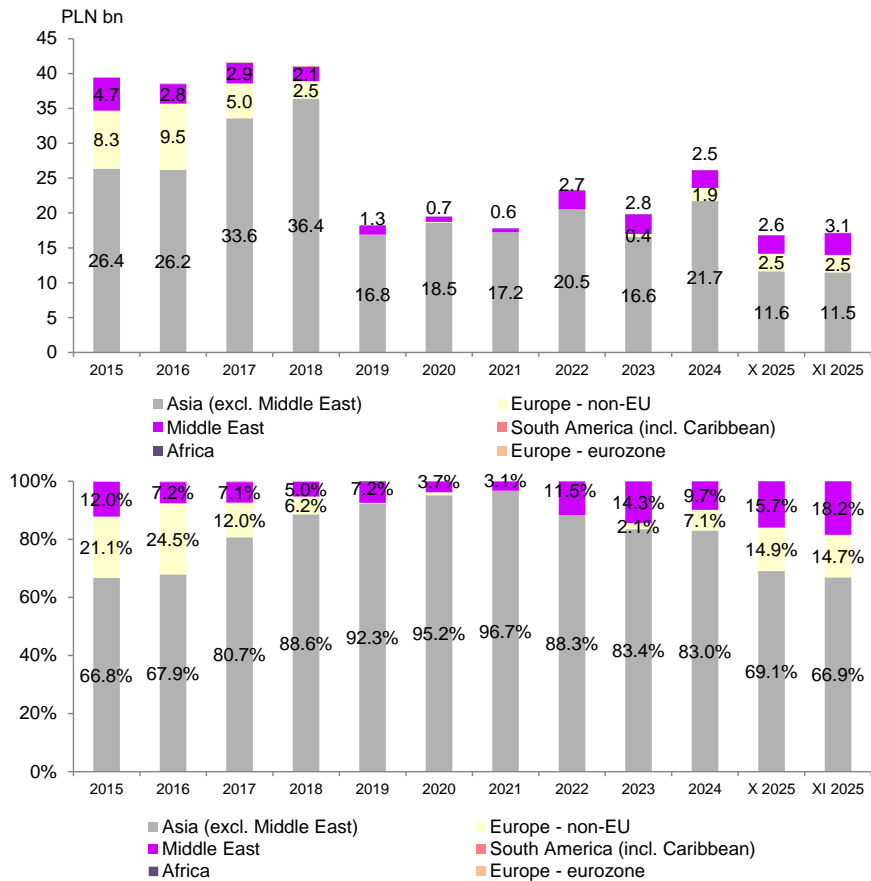
Changes in the domestic ST debt towards non-residents by region in 2025

From January to November 2025 non-residents increased their holdings in the domestic TS debt by PLN 21.2bn. The biggest increase in the portfolio concerned investors at omnibus accounts (PLN +16.3bn), investors from eurozone (PLN +7.8bn) and investors from Europe non-EU (PLN +5.3bn). A decrease in TS holdings was recorded in case of investors from Asia (PLN -9.8bn).



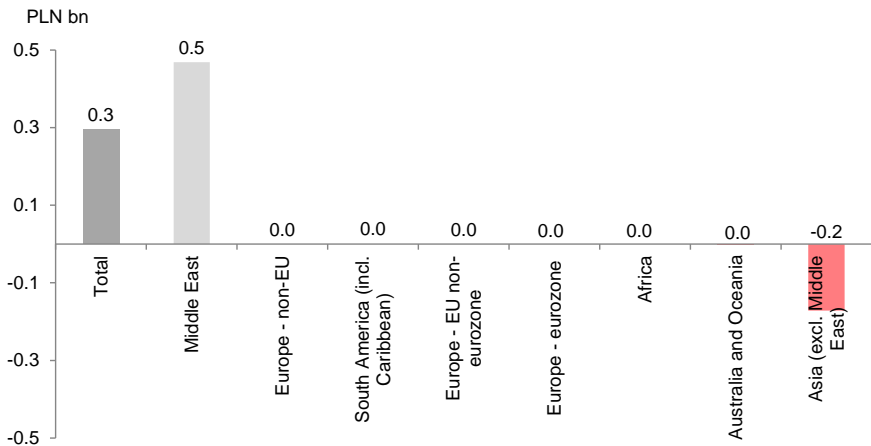
The domestic TS debt towards foreign central banks and public institutions by region in nominal value and structure

In the structure of the domestic TS held by foreign central banks and public institutions entities from Asia were predominant – in November 2025 their share amounted to 66.9%. Domestic TS were held also by central banks and public institutions from Middle East countries (14.7%) and Europe non-EU countries (18.2%).



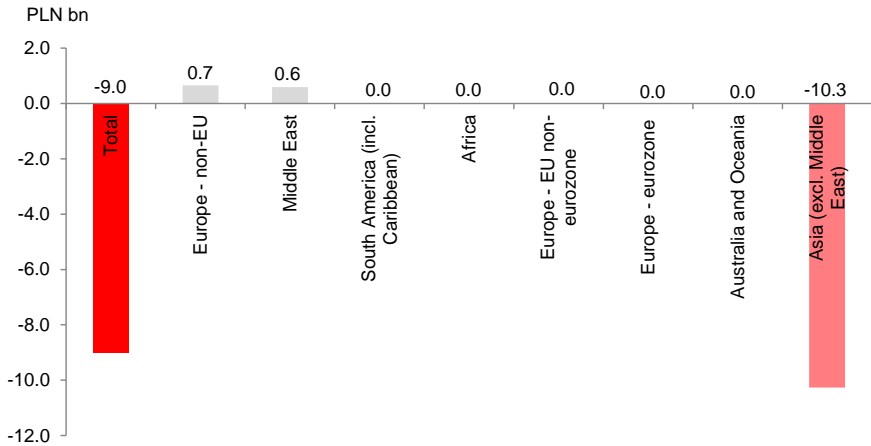
Changes in the domestic TS debt towards foreign central banks and public institutions by region in November 2025 m/m

In November 2025 the domestic TS held by foreign central banks and public institutions increased by PLN 0.3bn m/m. It resulted mainly from an increase in holdings of investors from Middle East (PLN +0.5bn) with a decrease in holdings of investors from Asia (PLN -0.2bn).



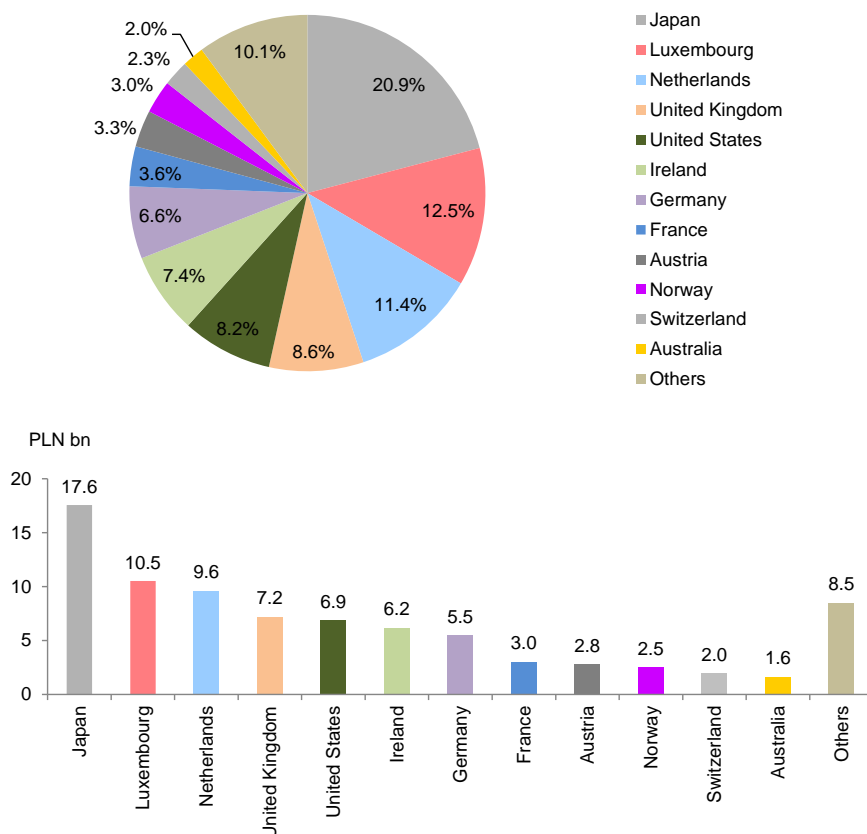
Changes in the domestic TS debt towards foreign central banks and public institutions by region in 2025

From January to November 2025 a decrease in the domestic TS holdings of central banks and public institutions was recorded (PLN -9.0bn), which was mainly the result of a decrease in holdings of investors from Asia (PLN -10.3bn) with an increase in holdings of investors from Europe non-EU (PLN +0.7bn) and investors from Middle East (PLN +0.6bn).



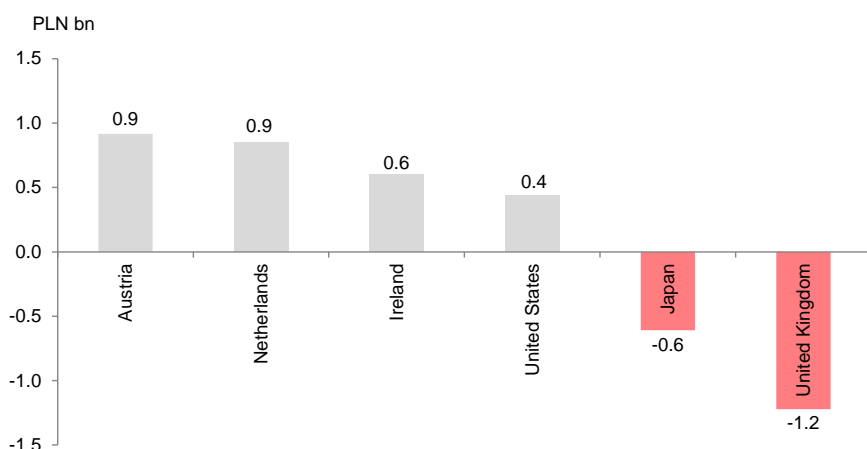
The domestic TS debt towards non-residents by country* in November 2025 – structure and nominal value

In November 2025 the domestic TS were held by investors from 69 countries, which confirm high diversification of non-residents structure. The largest TS portfolios were held by entities from Japan (20.9%, including mainly pension funds: 13.0 % share in non-resident debt in domestic TS and investment funds: 3.5%), Luxembourg (12.5%, including mainly investment funds: 7.3% and other entities: 5.1%), the Netherlands (11.4%, including mainly pension funds: 5.2% and other entities: 4.7%), the UK (8.6%, including mainly banks: 4.8% and other entities: 2.7%), the United States (8.2%, including mainly investment funds: 4.9% and other entities: 2.8%), Ireland (7.4%, including mainly investment funds: 5.3% and non-financial entities: 1.5%) and Germany (6.6%, including mainly: banks 1.9% and hedge funds: 1.7%).



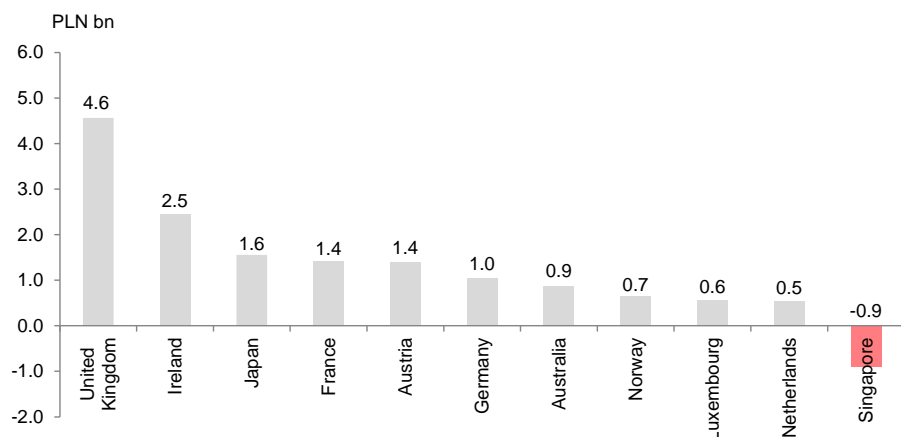
Changes in the domestic TS debt towards non-residents by country* in November 2025** m/m

In November 2025 the most notable changes in the non-residents' domestic TS holdings were observed among investors from Austria (PLN +0.9bn), the Netherlands (PLN +0.9bn), Ireland (PLN +0.6bn), the US (PLN +0.4bn), Japan (PLN -0.6bn) and the UK (PLN -1.2bn).



Changes in the domestic ST debt towards non-residents by country* in 2025***

From January to November 2025 an increase in the TS portfolios mainly concerned non-residents from the UK (PLN +4.6bn), Ireland (PLN +2.5bn), Japan (PLN +1.6bn), France (PLN +1.4bn), Austria (PLN +1.4bn) and Germany (PLN +1.0bn). The decrease concerned investors from the Singapore (PLN -0.9bn).



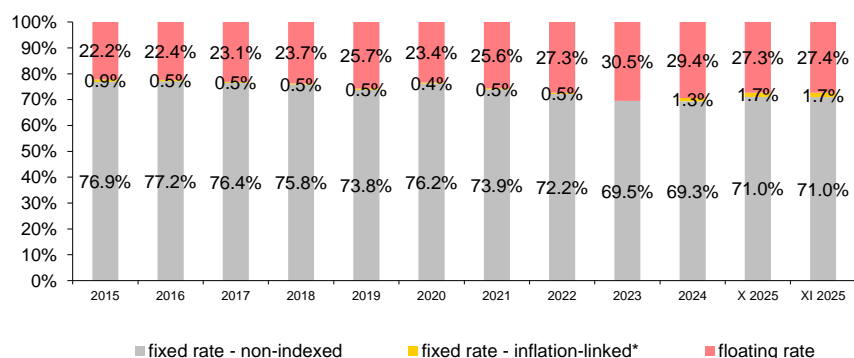
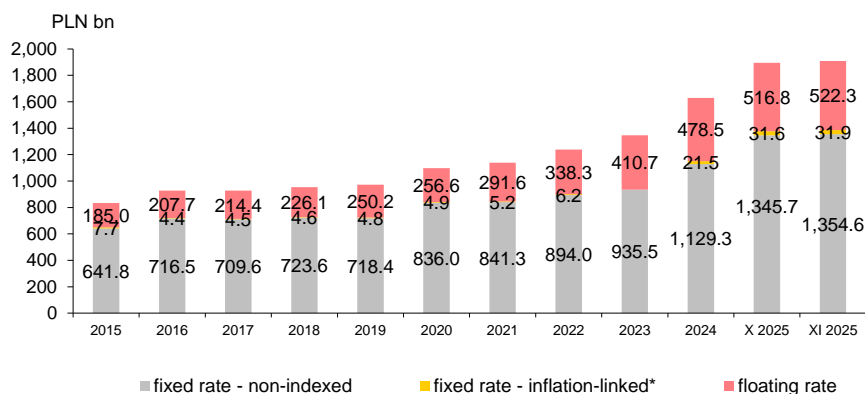

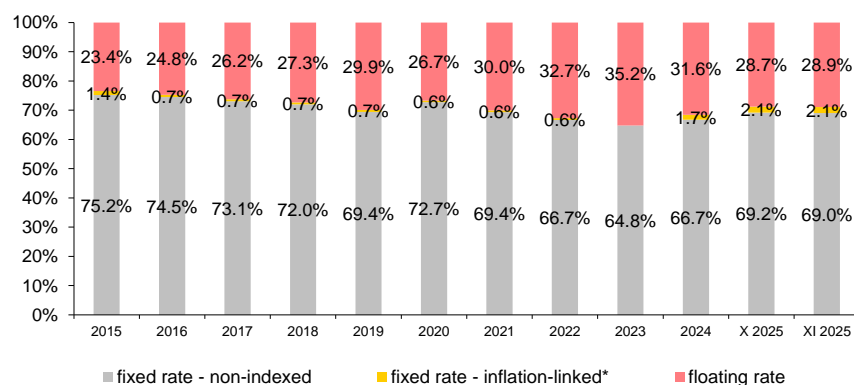
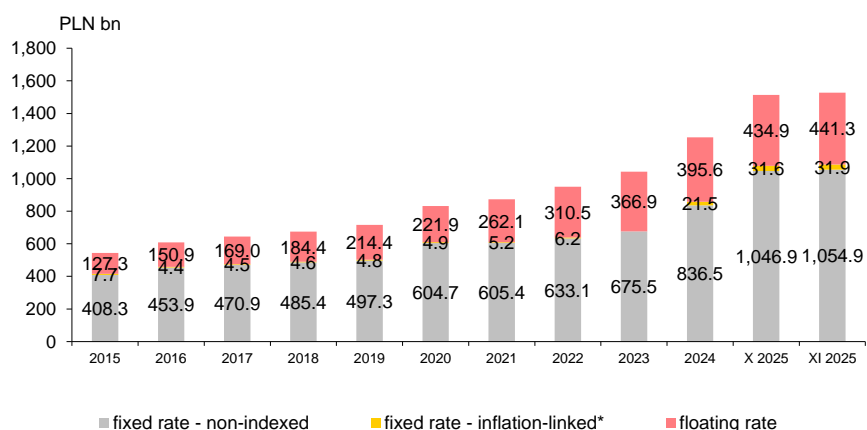
The ST debt by a type of an interest rate and an indexation in nominal value and structure

The majority of the ST debt comprised the fixed rate instruments – their share in November 2025 amounted to 72.6% (of which 1.7% were CPI indexed instruments). The share of the floating rate instruments amounted to 27.4%, of which instruments with inflation-linked coupons amounted to 4.0%. The share of the floating rate instruments rose by 0.1 pp m/m and fell by 2.0 pp compared to the end of 2024.



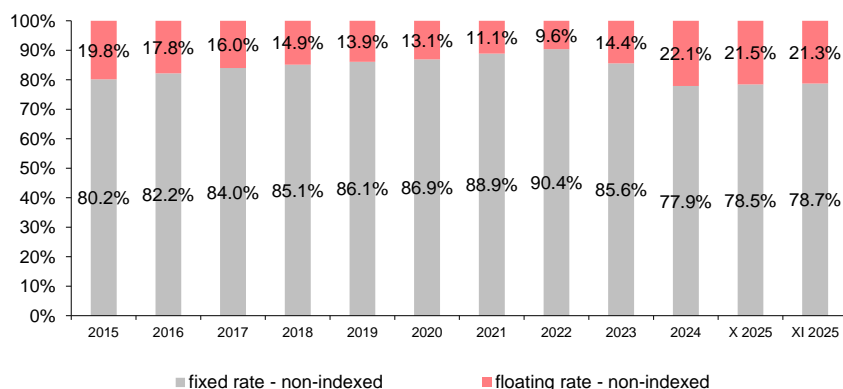
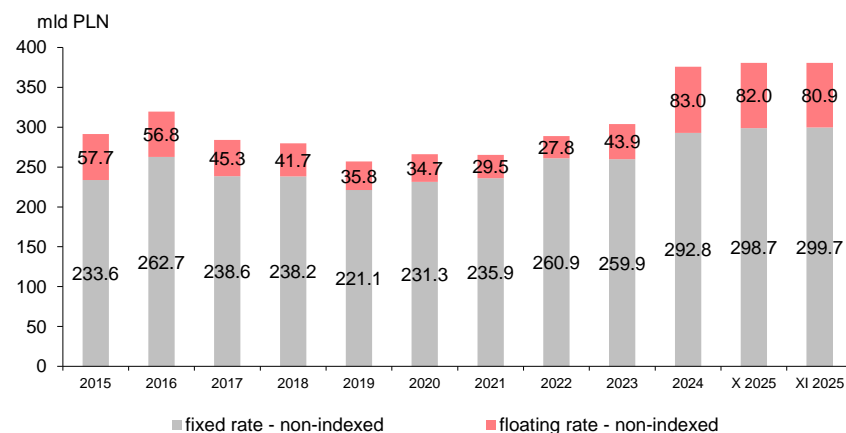
The domestic ST debt by a type of an interest rate and a type of an indexation in nominal value and structure

In November 2025 the share of the floating rate instruments in the domestic ST debt amounted to 28.9% of which 5.0% were bonds with inflation-linked coupons. The share of the floating rate instruments rose by 0.1 pp m/m and fell by 2.7 pp compared to the end of 2024. According to the debt management strategy, the dominant share of fixed-rate instruments in domestic debt was maintained.



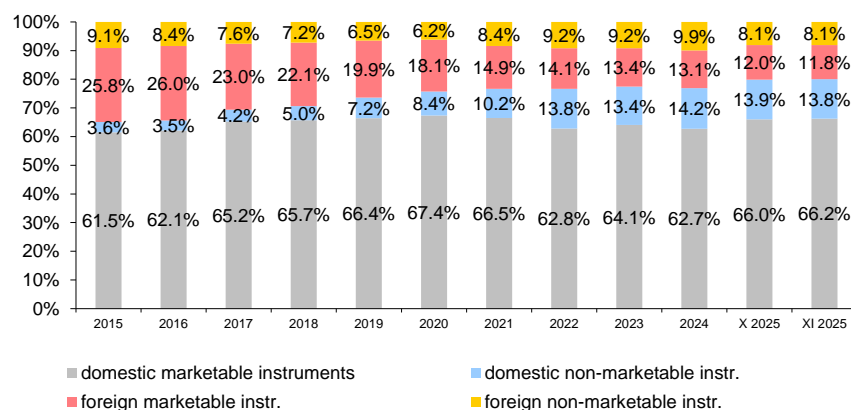
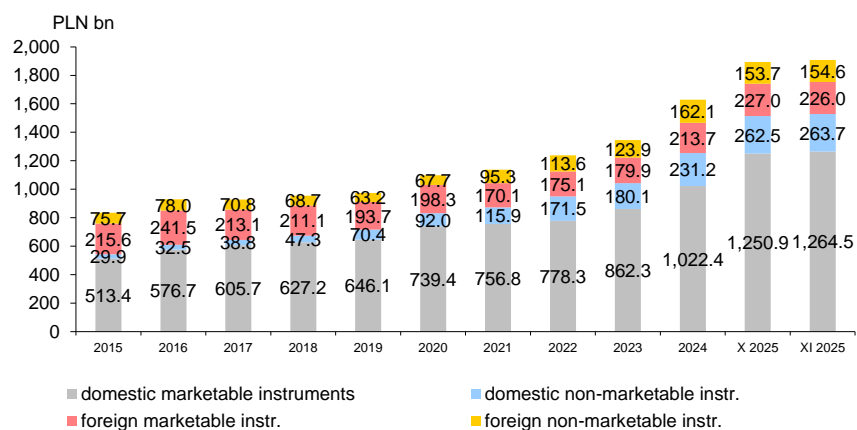
The foreign ST debt by a type of an interest rate and a type of an indexation in nominal value and structure

In November 2025 the share of the floating rate instruments in the foreign ST debt amounted to 21.3%, i.e. it decreased by 0.3 pp m/m and it decreased by 0.8 pp since the beginning of 2024. According to the debt management strategy, the dominant share of fixed rate instruments in debt denominated in foreign currencies was maintained.



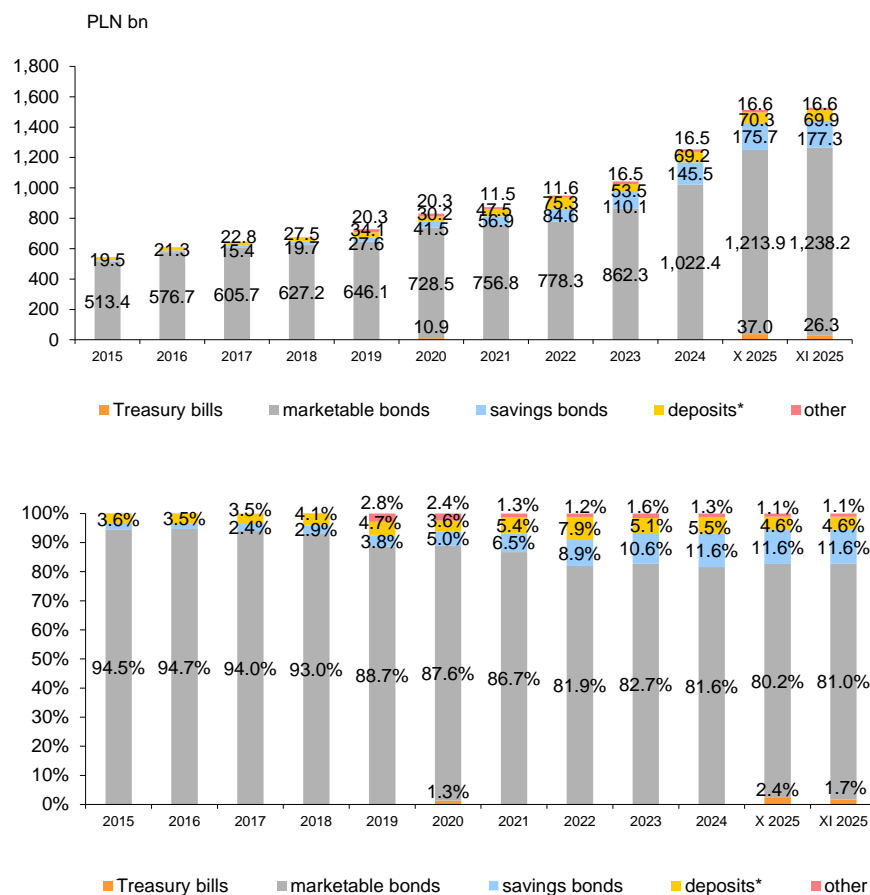
The ST debt by a type of instrument in nominal value and structure

The structure of the ST debt is dominated by the marketable TS (78.1% in November 2025), including primarily the instruments issued on the domestic TS market (66.2%). The non-marketable instruments, including loans from international financial institutions, loans from EU, domestic saving bonds, as well as deposits collected under liquidity management consolidation are complementary sources of financing of the State budget borrowing requirements.



The domestic ST debt by a type of instrument in nominal value and structure

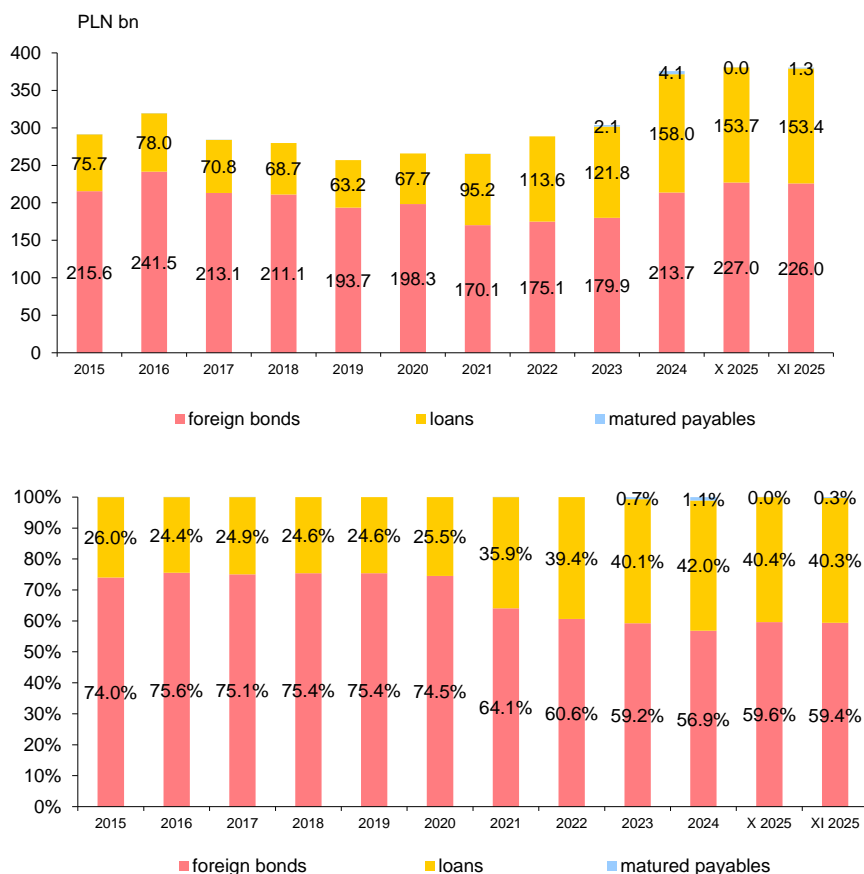
The vast majority of the domestic ST debt constituted the marketable TS (82.7% in November 2025). The saving bonds (11.6%), as well as the deposits (4.6%) are complementary and stable sources of financing.

The foreign ST debt by a type of instrument in nominal value and structure

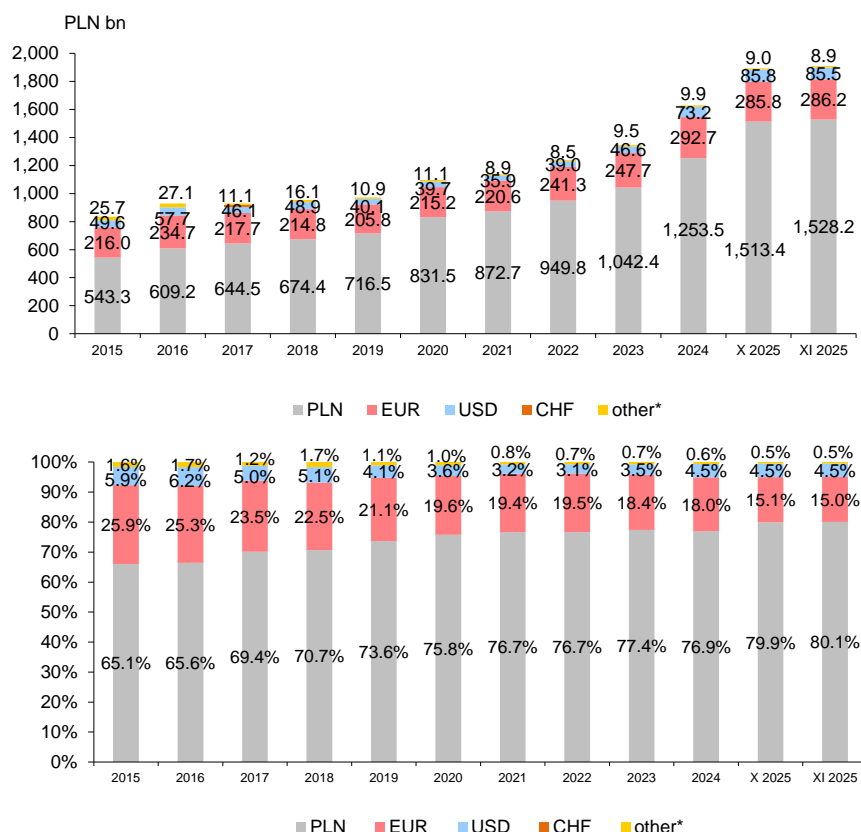
In the ST debt denominated in foreign currencies dominant share accounted for the international bonds (59.4% in November 2025). The share of loans from international financial institutions and EU is significant as well (40.3% in total).



The ST debt by currency in nominal value and structure

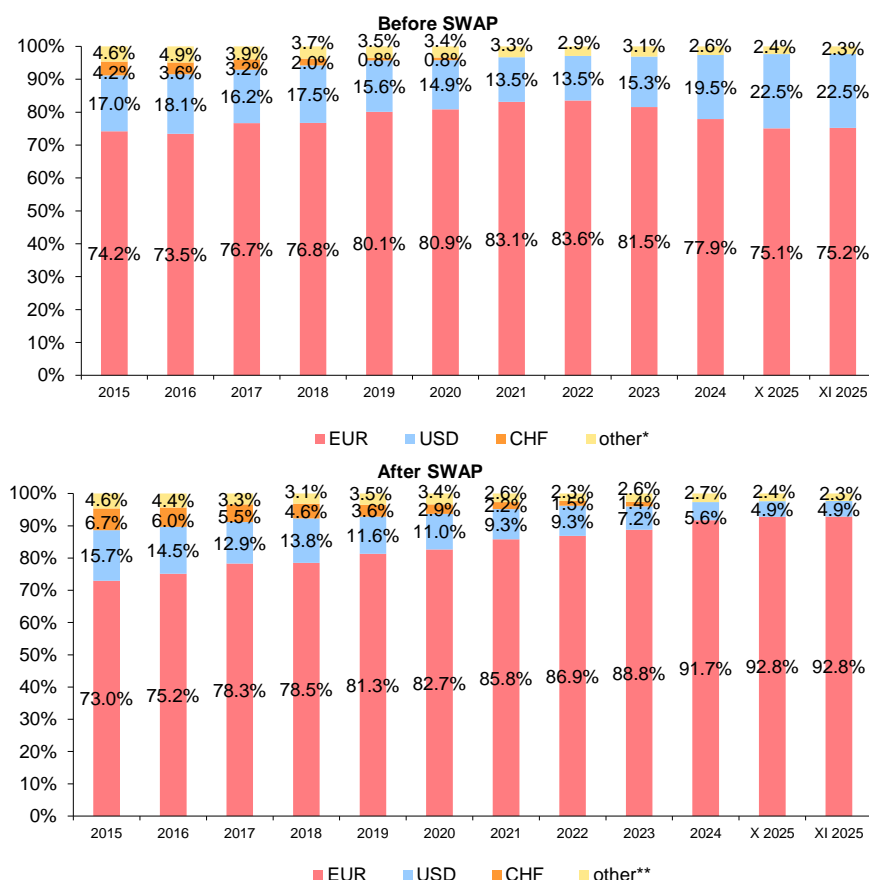
In accordance with the debt management strategy the State budget borrowing requirements are mostly financed on the domestic market. In November 2025 the debt denominated in PLN comprised 80.1% of the total ST debt, as compared to 79.9% in the previous month and 76.9% as compared to the end of 2024. The share of the foreign currency denominated debt changed as follows:

- EUR – fell by 0.1 pp m/m and fell by 3.0 pp compared to the end of 2024;
- USD – fell by 0.1 pp m/m and no change compared to the end of 2024;
- JPY – no change m/m and fell by 0.1 pp compared to the end of 2024.



The structure of the foreign ST debt by a currency – before and after swap transactions

In November 2025 the share of the EUR-denominated debt in the foreign ST debt, including derivative transactions, amounted to 92.8%, remaining above the minimum level of 70% assumed in the debt management strategy. The share of EUR rose by 0.08 pp m/m and rose by 1.1 pp compared to the end of 2024.

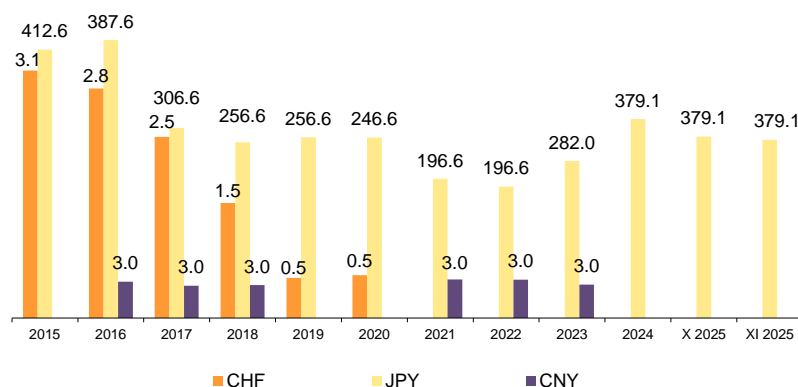
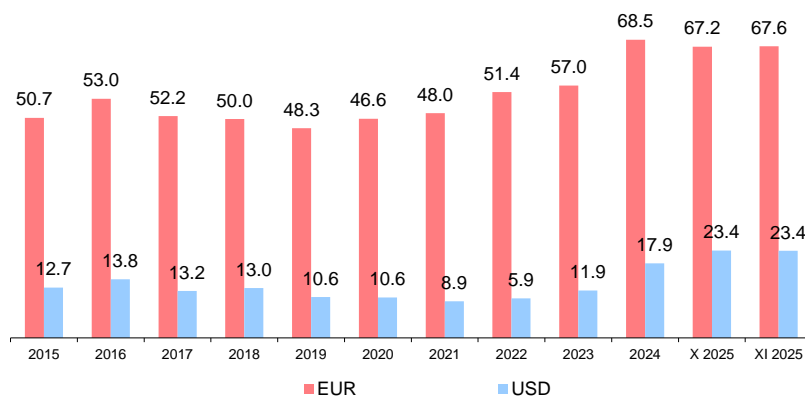

In November 2025 the nominal value of the debt denominated in USD did not change as compared to the previous month and amounted to USD 23.4bn, the debt denominated in EUR rose by 0.4 pp as compared to the previous month, and amounted to EUR 67.6bn, the debt denominated in JPY reminded unchanged as compared to the previous month, and amounted JPY 379.1bn.

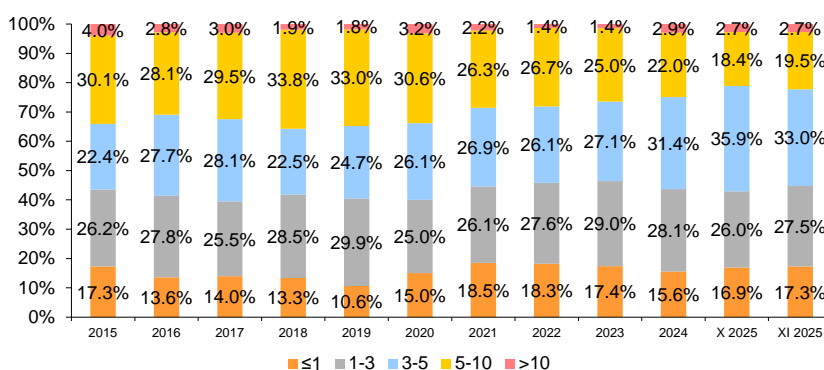
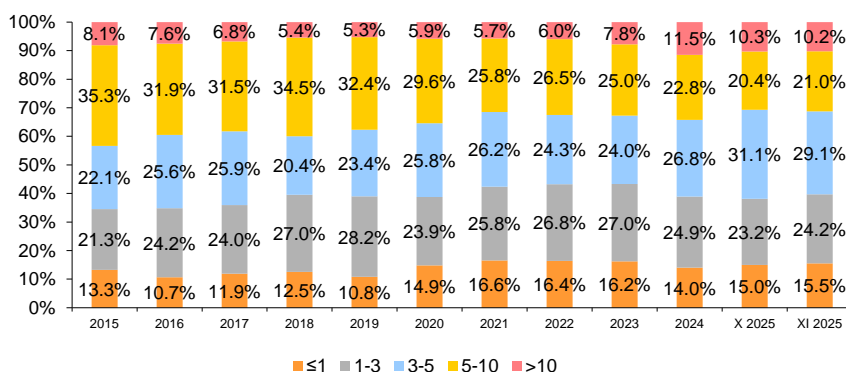


The ST debt by a residual maturity (in years)

In November 2025 the debt with the longest residual maturity (over 5 years) comprised 31.3% of the total ST debt, i.e. increased by 0.6 pp m/m and decreased by 3.0 pp as compared to the beginning of 2024. The debt with residual maturity up to 1 year constituted 15.5% of the ST debt, i.e. it increased by 0.5 pp m/m and increased by 1.5 pp since the beginning of 2024.

The domestic ST debt by residual maturity (in years)

In November 2025 the domestic debt with residual maturity over 5 years accounted for 22.3%, i.e. it rose by 1.2 pp m/m and fell by 2.7 pp since the beginning of 2024. The share of the debt with residual maturity up to 1 year amounted to 17.3%, i.e. it rose by 0.4 pp m/m and rose by 1.7 pp since the beginning of 2024.



ATM of ST debt*

In November 2025 the average time to maturity (ATM) of the ST debt amounted to 5.67 years (i.e. it fell by 0.01 years m/m and fell by 0.40 years as compared to the end of 2024). The debt management strategy assumes maintaining the ATM at the level of at least 5 years, taking into account the possibility of temporary deviations resulting from market or budget conditions. The ATM of the domestic debt amounted to 4.22 years, i.e. rose by 0.02 years m/m (mainly as a result of sale and switch auctions, and debt aging). The debt management strategy assumes striving to achieve the ATM of domestic debt at a level close to 4.5 years, taking into account temporary deviations resulting from market or budget conditions. In November 2025 the ATM of the foreign debt fell by 0.04 years m/m (mainly as a result of loans drawing and debt aging) reaching 10.47 years.

ATR of ST debt*

In November 2025 the average time to re-fixing (ATR) of the ST debt amounted to 4.13 years (i.e. it rose by 0.06 years m/m and fell by 0.11 years as compared to the end of 2024). The ATR level in November was a result of the ATR of the domestic debt, which amounted to 3.20 years (rose by 0.10 years m/m) and the ATR of the foreign debt, which amounted to 7.23 years (fell by 0.02 years m/m). The levels of the ATR resulted from changes in the ATM and the share of floating rate instruments. The ATR of the domestic debt remained within range of 2.6-3.6 years assumed in the public debt management strategy.

Duration of ST debt**)

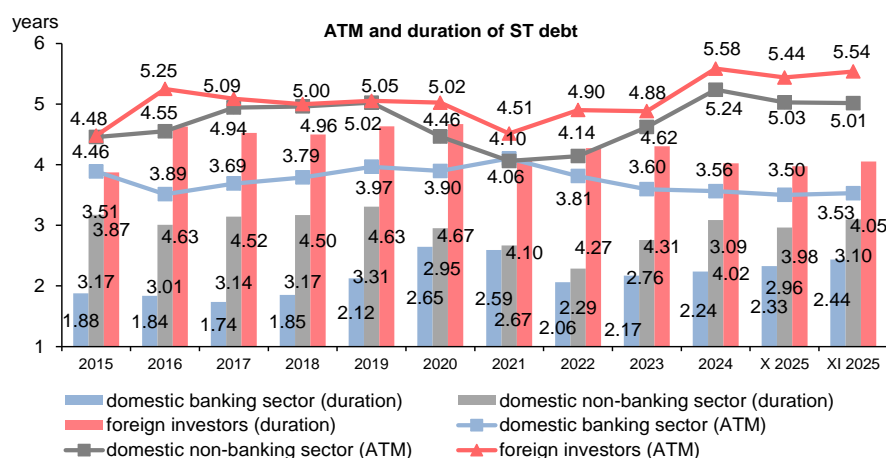
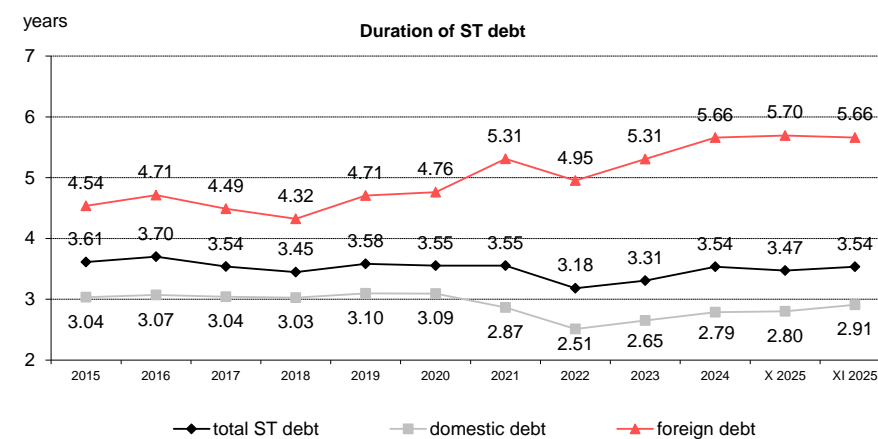
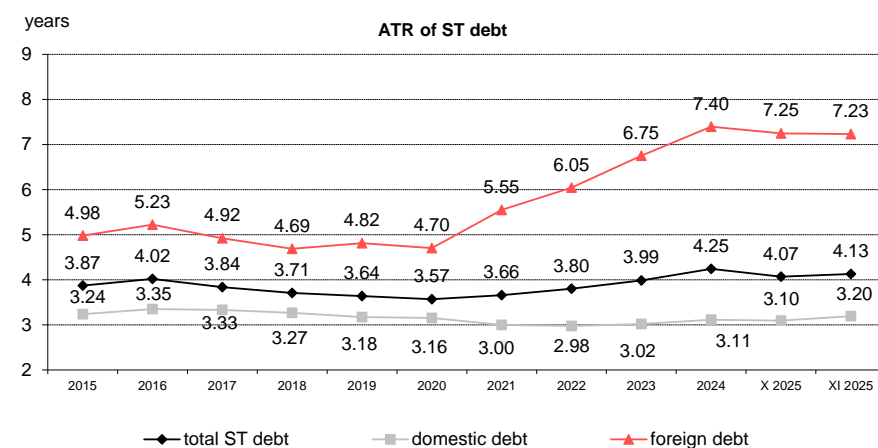
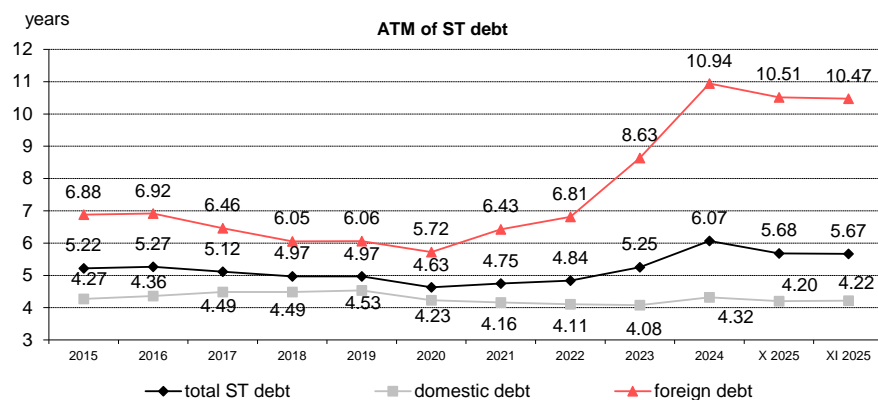
In November 2025 the duration of the ST debt amounted to 3.54 years (i.e. rose by 0.07 years m/m and no change as compared to the end of 2024). The level of duration was a result of the domestic debt duration (rose by 0.11 years m/m) which amounted to 2.91 years and decrease in the foreign debt duration (by 0.03 years m/m) to 5.66 years. The changes in the duration resulted mainly from changes in interest rates level and the ATR.

ATM and duration** of domestic marketable ST debt by group of investors

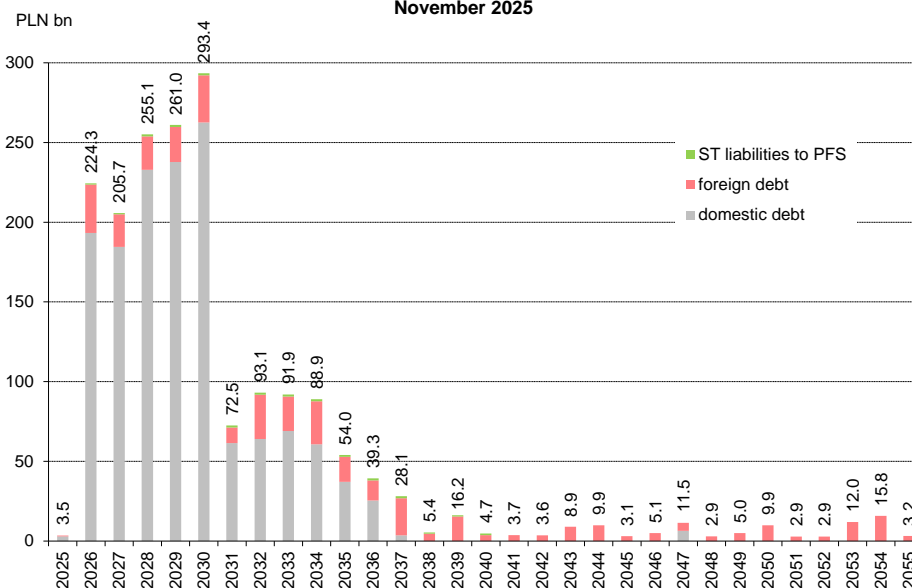
At the end of November 2025 the ATM and the duration of the portfolio of the domestic TS held by foreign investors amounted to 5.54 years (+0.10 years m/m) and 4.05 years (+ 0.08 years m/m) respectively. The ATM and the duration of the domestic non-banking sector TS portfolio amounted to 5.01 years (-0.01 years m/m) and 3.10 years (+0.13 years m/m), respectively. The ATM and the duration of the TS portfolio held by the domestic banking sector amounted to 3.53 years (+0.03 years m/m) and 2.44 years (+0.11 years m/m), respectively.

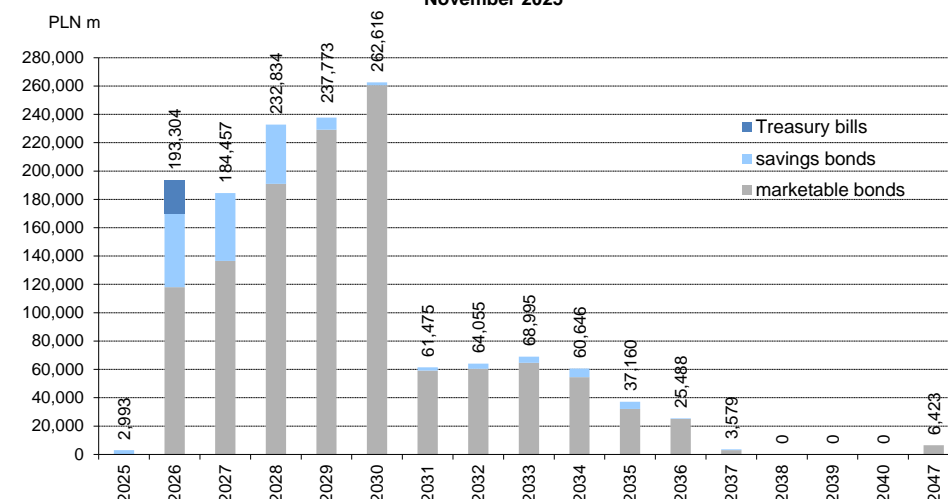

Maturity profile of the ST debt (Treasury securities and loans) as at the end of November 2025

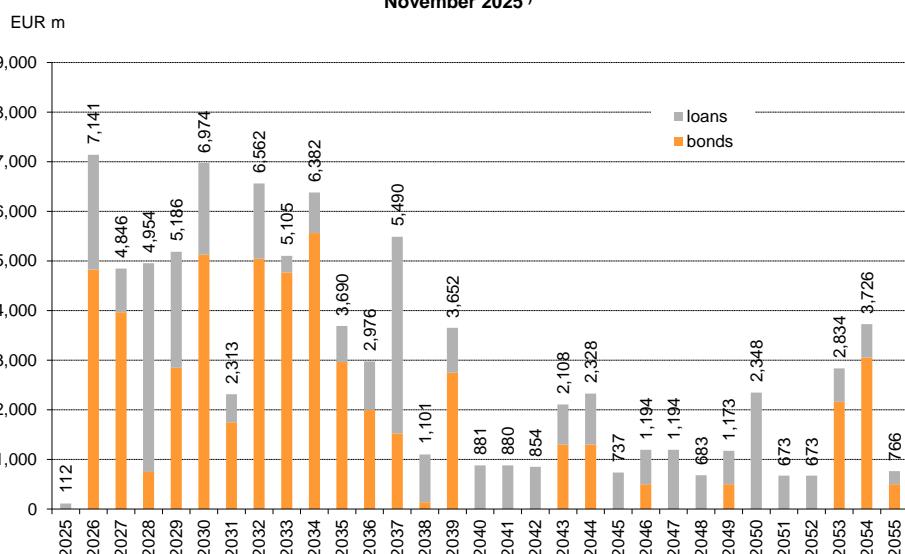


Maturity profile of the domestic Treasury securities debt as at the end of November 2025*
