



Basic information about the participation rules for partners in the 5th Call of the INNOGLOBO programme

NOTE: The information provided below is only a brief guide to the most essential aspects of Foreign Partners' participation in the projects selected for funding in the 5th Call of the INNOGLOBO programme.

For all details about the terms of the call, see the document in Polish entitled "Rules for the participation of Polish applicants in the 5th Call of the INNOGLOBO programme", including appendices thereto.

- 1. Participation in the call is open exclusively to international consortia comprising Polish entities and at least one foreign Partner.
- 2. There are no limitations as to the legal structure of the Foreign Partner(s) which form the international consortium implementing the project.
- 3. Foreign Partners implementing the project in an international consortium may originate from all the countries with which Poland maintains diplomatic relations¹.
- 4. NCBR may provide funding for project implementation only to entities which conduct business or research & development activities² on the territory of the Republic of Poland (as confirmed with an entry in the relevant register³).
- 5. The entities referred to in point 4 may include only research organisations⁴, businesses⁵ or consortia⁶ composed of any configuration of entities indicated in this point.
- 6. One of the conditions for projects to receive funding is that the Polish applicant enters into an international consortium agreement with the Foreign Partner(s) in cooperation with whom the project will be implemented.
- 7. The subjects raised in funding applications for projects must be in line with the current List of National Smart Specialisations.⁷
- 8. Project funding must be provided exclusively for the Polish applicant to implement: industrial research⁸ and/or development work⁹.
- 9. The projects which qualify for funding may take from 24 to 36 months.
- 10. The NCBR budget allocated for funding the participation of Polish entities in the 5th Call of the INNOGLOBO Programme is PLN 20 million.

- 11. The minimum amount of funding for work packages implemented by the Polish applicant within a single project is PLN 300,000.
- 12. The maximum amount of funding for work packages implemented by the Polish applicant within a single project is PLN 2 million.
- 13. The share of financial resources contributed by all the Foreign Partners forming the international consortium which implements an international project should be a minimum of 30% and a maximum of 70% of the total international consortium budget allocated to the project.
- 14. Each Foreign Partner willing to participate in project implementation within the international consortium is required to secure funding for the implementation of their respective portions of the project, including to provide the Polish applicant, before the applicant submits the funding application, with a declaration that they have secured funding for project implementation (in accordance with the original template available in the call documentation). The content of declaration is provided below.
- 15. The call for proposals procedure comprises a single phase which starts on 1 December 2025 and ends on 30 April 2026.
- 16. Polish applicants submit international application for project financing according to the "Rules for the participation of Polish applicants in the 5th Call of the INNOGLOBO programme". The international application should be submitted to the NCBR via the electronic system Application Generator in LSI 1.0.
- 17. Application evaluation by NCBR includes the following stages:
 - 1) formal evaluation to check application eligibility;
 - 2) expert evaluation the scientific and technical evaluation of the project carried out by Polish external experts;
 - 3) international arrangements conducted jointly by the NCBR with a foreign R&D funding institution cooperating with the NCBR under the 5th Call of the INNOGLOBO Programme (if applicable);
 - 4) establish of three ranking lists, containing applications recommended and not recommended for funding, and a reserve list, containing applications that received a positive final evaluation but were not recommended due to a lack of available funds in the call budget.
- 18. Based on the ranking list, NCBR's Director issues a decision under which NCBR awards funding for project implementation.
- 19. It is expected that Polish applicants will receive the funding decision no later than 30 October 2026.
- 20. Should each of the Foreign Partners forming the international consortium decide to withdraw from the project or forfeit their project funding security, the Director of NCBR may issue a decision to void the decision on the award of funding for project implementation.
