3. Notices to Skippers

In the area administered by Regional Water Management Authority in Poznan opens to navigation are: the Warta River in section at km 29+000 - 406+600 and the Ślesiński Canal in section at km 0+000 - 26+460 (Notice no. 6, 7, 8, 10, 11/2024) except sections on the Ślesiński Canal: at km 3+600 (Notice no. 37/2024) and at km 17+200 (Notice no. 33/2024).

The section of the Warta River at km 0+000 - 29+000 is closed to navigation until further notice (Notice no. 39/2024).

The Pątnów sluice - boats width limited up to 4.50 m (Notice no. 27/2024)

Please be especially careful due to the bridges renovation:

- Warta River in km 2+450,
- Warta River in km 206+000,
- Warta River in km 243+200,
- Ślesiński Canal in km 3+600 (waterway closed),
- Ślesiński Canal in km 17+200 (waterway closed).
