$\label{eq:regulation} \textbf{REGULATION}$ OF THE MINISTER OF THE INTERIOR AND ADMINISTRATION $^{1)}$

of 13 March 2020

on temporary reintroduction of border control on persons crossing the state border constituting an internal border

Pursuant to Article 17a of the Act of 12 October 1990 on the Protection of the State Border (Journal of Laws of 2019, item 1776), it is hereby ordered as follows:

- **§ 1.** This Regulation concerns the temporary reintroduction of border control on persons crossing the state border which constitutes an internal border within the meaning of Article 2(1) of Regulation (EU) 2016/399 of the European Parliament and of the Council of 9 March 2016 on a Union Code on the rules governing the movement of persons across borders (Schengen Borders Code) (OJ L 77, 23.3.2016, p. 1, as amended²⁾), hereinafter referred to as "border control on persons", and defines:
- 1) sections of the state border where the border control of persons is temporarily reintroduced;
- 2) border crossing points, the type of traffic allowed at these crossing points and their opening times, as well as the territorial coverage of border crossing points;
- 3) the period for which border control on persons is temporarily reintroduced.
- § 2. 1. During the period from 15 March 2020 to 24 March 2020, border control on persons shall be temporarily reintroduced.
- 2. The scope of control referred to in section 1, including the possibility of limiting it pursuant to the rules laid down in the Schengen Borders Code, shall be adapted accordingly, considering the degree of threat to public order or national security in view of the serious threat to public health posed by the SARS-CoV-2 coronavirus causing the COVID-19 disease.

The Minister of the Interior and Administration manages the internal affairs department of government administration pursuant to § 1 (2)(2) of the Regulation of the President of the Council of Ministers of 18 November 2019 on the detailed scope of competencies of the Minister of the Interior and Administration (Journal of Laws, item 2264).

Amendments to the aforementioned Regulation were announced in OJ L 251, 16.9.2016, p. 1, OJ L 74, 18.3.2017, p. 1, OJ L 327, 9.12.2017, p. 1, OJ L 236, 19.9.2018, p. 1 and OJ L 135, 22.5.2019, p. 27.

- § 3. Border control on persons shall be temporarily reintroduced:
- 1) at the state border with the Czech Republic;
- 2) at the state border with the Federal Republic of Germany;
- 3) at the state border with the Republic of Lithuania;
- 4) at the state border with the Slovak Republic;
- 5) at seaports constituting an internal border within the meaning of the Schengen Borders Code;
- 6) at airports constituting an internal border within the meaning of the Schengen Borders Code.
- **§ 4.** The list of border crossing points, type of traffic allowed at these crossing points, their opening times and the territorial coverage of border crossing points have been specified in the attachment to this Regulation.
- § 5. This Regulation shall enter into force on the day of its promulgation.
