THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2021/2115 of the European Parliament and of the Council of 2 December 2021, establishing rules on support for strategic plans to be drawn up by Member States under the common agricultural policy (CAP Strategic Plans), and financed by the European Agricultural Guarantee Fund (EAGF), and by the European Agricultural Fund for Rural Development (EAFRD), and repealing Regulations (EU) No 1305/2013, and (EU) No 1307/2013¹, and in particular Article 119(4) thereof,

Whereas:

- (1) On 31 August 2022, the Commission adopted Implementing Decision C(2022)6018² pursuant to Article 118(4) and (6) of Regulation (EU) 2021/2115, approving the 2023-2027 CAP Strategic Plan of Poland for Union support financed by the European Agricultural Guarantee Fund (EAGF) and the European Agricultural Fund for Rural Development (EAFRD).
- (2) On 31 December 2024, Poland submitted to the Commission a fourth request for amendment of the 2023-2027 CAP Strategic Plan, pursuant to Article 119 of Regulation (EU) 2021/2115. In accordance with Article 119(3) of Regulation (EU) 2021/2115, the Commission has assessed the request for amendment of the 2023-2027 CAP Strategic Plan of Poland and made observations on 10 February 2025.
- (3) Poland provided the Commission with all necessary additional information and submitted a revised version of the request for amendment and a revised version of the amended 2023-2027 CAP Strategic Plan on 26 February 2025.
- (4) Poland has duly substantiated and justified the request for amendment of the 2023-2027 CAP Strategic Plan in accordance with Article 119(2) of Regulation (EU)

- 2021/2115. Poland provided all necessary information in accordance with Article 2 of Commission Delegated Regulation (EU) 2023/370³.
- (5) Poland has set the date of effect for the amendments of the CAP Strategic Plan related to the EAGF for the day following the date of notification to Poland of the Commission decision approving the request for amendment. The proposed date has been determined in accordance with Article 119(8), third subparagraph of Regulation (EU) 2021/2115.
- (6) The Commission has concluded that the proposed amendments of the CAP Strategic Plan of Poland comply with the requirements set out in Article 119(4) of Regulation (EU) 2021/2115 and with Article 2 of Delegated Regulation (EU) 2023/370.
- (7) The amendments of the CAP Strategic Plan requested by Poland and the date of effect of the amendments related to the EAGF should therefore be approved.
- (8) On 21 February 2024, 21 March 2024, 27 September 2024 and 23 December 2024, Poland notified to the Commission modifications to elements of its CAP Strategic Plan concerning rural development as provided for in Article 119(9) of Regulation (EU) 2021/2115. The request for amendment to the CAP Strategic Plan of Poland includes these modifications. Pursuant to Article 86(3) of that Regulation, expenditure that becomes eligible as a result of these notifications is to be eligible as of the dates of such notifications.
- (9) This Decision does not cover information on the control systems and penalties set up by Poland, and the information included in Annexes I to IV to the 2023-2027 CAP Strategic Plan of Poland. It also does not cover State aid within the meaning of Articles 107, 108 and 109 of the Treaty falling outside the scope of Article 42 of the Treaty, which has not been approved by the Commission according to the relevant State aid procedures,

HAS ADOPTED THIS DECISION:

Article 1

The amendments of the 2023-2027 CAP Strategic Plan submitted by Poland on 26 February 2025 are hereby approved.

Article 2

The overview table of allocations, including the adjusted allocations, as referred to in Article 112(2) of Regulation (EU) 2021/2115 and set out in the CAP Strategic Plan, as amended following the approval laid down in Article 1 of this Decision, is set out in Annex I to this Decision.

The total EAFRD contribution for each EAFRD type of intervention, as amended following the approval laid down in Article 1 of this Decision, is set out in Annex II to this Decision.

The financial ceilings calculated in accordance with Articles 92(2), 93(3), 95(3), 95(4), 95(5), 97(10), 97(11) and 98(2) respectively of Regulation (EU) 2021/2115, as amended following the approval laid down in Article 1 of this Decision, are set out in Annex III to this Decision.

A table of the additional national financing, as referred to in Article 146 of Regulation (EU) 2021/2115, as amended following the approval laid down in Article 1 of this Decision, is set out in Annex IV to this Decision.

Article 3

The date of effect of the amendments of the 2023-2027 CAP Strategic Plan related to the EAGF, proposed by Poland for the day following the date of notification to Poland of the Commission decision approving the request for amendment, is hereby approved.

Article 4

Expenditure that becomes eligible as a result of the amendments of the 2023-2027 CAP Strategic Plan of Poland related to the EAGF shall be eligible for a contribution from the EAGF from the dates of effect of those amendments referred to in Article 3.

Expenditure that becomes eligible as a result of the amendment of the 2023-2027 CAP Strategic Plan of Poland related to the EAFRD shall be eligible for a contribution from the EAFRD from 31 December 2024.

Expenditure that becomes eligible as a result of the modifications notified, pursuant to Article 119(9) of Regulation (EU) 2021/2115, on 21 February 2024, 21 March 2024, 27 September 2024 and 23 December 2024, shall be eligible for a contribution from the EAFRD from those dates.

Article 5

This Decision is addressed to the Republic of Poland.
