

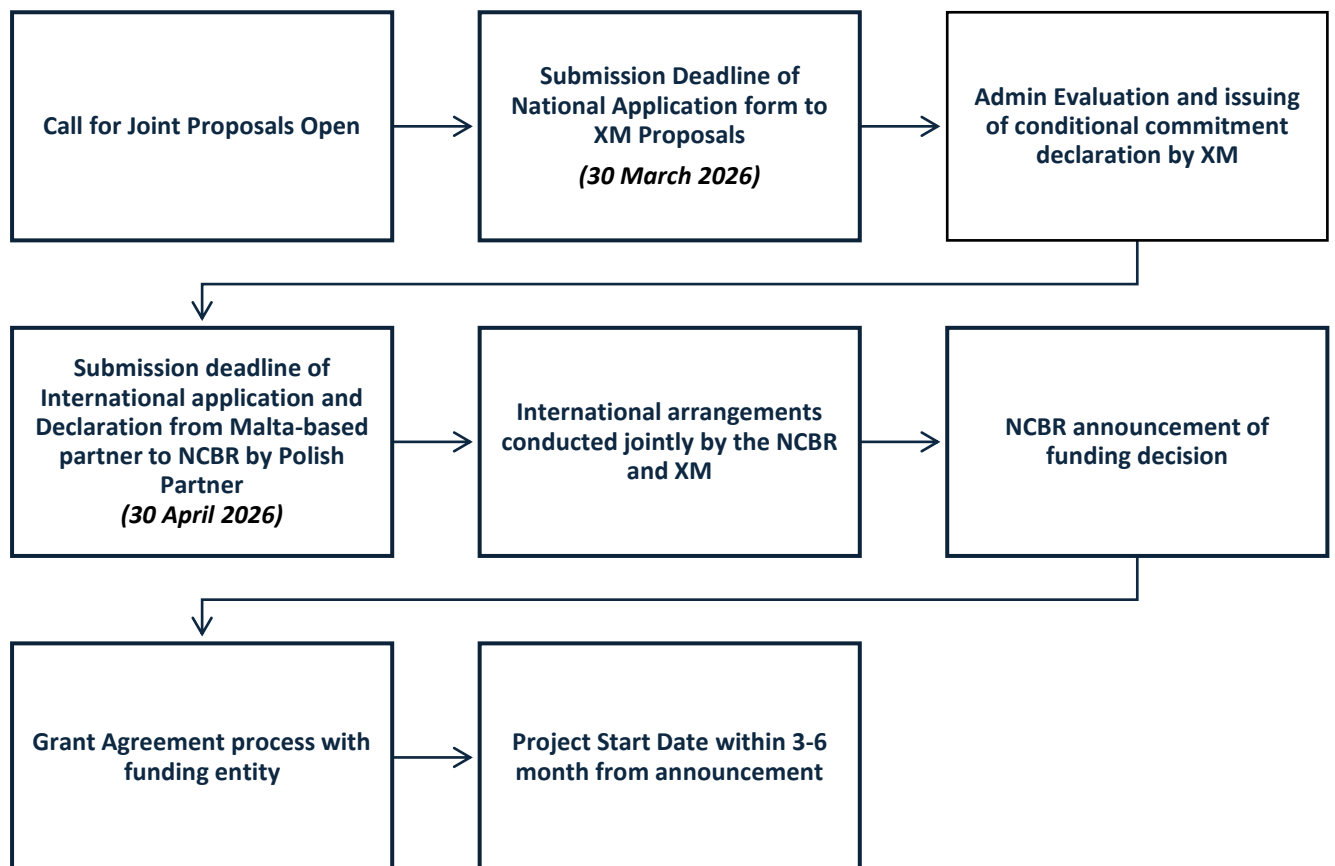

1st Malta-Poland Call for Proposals for Joint Research and Innovation Projects (2026)

Introduction

In 2024, a Memorandum of Understanding (MoU) on cooperation in Research and Innovation was signed between the Government of the Republic of Malta and the Ministry of Science and Higher Education of the Republic of Poland. In line with this MoU, Xjenza Malta and the National Centre for Research and Development (NCBR) are jointly launching this Call. The joint Call for Research and Innovation projects is co-funded by Xjenza Malta through the Access2GlobalResearch Scheme and by NCBR through the INNOGLOBO programme, with the aim of fostering cooperation and supporting joint initiatives that reflect the shared national priorities of both countries.

Further Details:

1. Call Structure

The Call invites Poland-based and Malta-based partners to submit joint research and innovation (R&I) proposals by the deadlines stipulated in this document and in all accompanying documentation issued by NCBR. Proposals must follow the procedures established by NCBR and Xjenza Malta, as detailed in the Rules for the participation of Polish applicants in the 5th Call of the INNOGLOBO Programme (Poland), the Xjenza Malta National Rules, and this Call text (Malta).

Malta-based partners must submit the Xjenza Malta national application form by **30 March 2026**. This deadline ensures that Xjenza Malta can conduct the required administrative review and based on the outcome, issue a declaration of co-financing as a conditional commitment to funding, subject to the final funding decisions.

National submissions received after 30 March 2026 may still be accepted, but Xjenza Malta cannot guarantee completion of the administrative evaluation due to time constraints.

Following the administrative review, the Polish partner is responsible for ensuring that the declaration of funds issued by Xjenza Malta is uploaded to the NCBR LSI portal along with the international application and all other required documentation by the NCBR Call deadline of 30 April 2026.

2. Financing

Eligible participants from Poland and Malta will finance their project costs through the funding schemes applicable under this Call, specifically, the NCBR INNOGLOBO programme for Poland-based participants and the Xjenza Malta, A2GR funding programme for Malta-based participants, and, where required, through their own complementary financing.

Approval or eligibility granted by one funding agency does not imply, ensure, or influence eligibility with the other agency. Each funding body may conduct its own independent evaluation, therefore, no commitment or approval from one agency shall bind or obligate the other to provide funding to its respective project participants. Formal confirmation from both agencies is required for a project to be considered eligible for funding.

2.1 Basic Requirements

Project results must contribute to the objective of the Call: **Advancing R&I by generating new knowledge, methods, technologies, or solutions that build upon the current international state of the art.** The project proposals must comply with the following guidelines:

- The partners must include **at least one Poland-based entity and one Malta-based entity.**
- Participation of other Poland-based and Malta-based entities are welcome as additional partners according to each country's funding schemes.
- Companies and/or research organisations from other countries may also participate. These partners' participation is neither funded by NCBR nor Xjenza Malta. They have to be included into the international application with the required documentation included.
- The project should have an obvious advantage and differentiated value proposition resulting from the cooperation between the participants from the two countries.
- Project duration should range from **24 up to 36 months.**
- The project should demonstrate a balanced contribution by the participants from both countries and must be equally significant to all participants:
 - The share of financial resources contributed by all the partners forming the international consortium should be a minimum of 30% and a maximum of 70% of the total international consortium budget allocated to the project.
- Any partner whose cooperative R&I proposal is consistent with the aforesaid criteria may apply to the present Call in accordance with the national laws, rules, regulations and procedures in effect.

3. Thematic Areas

The Call focuses on the following thematic areas:

- **Marine and Maritime Technologies**
- **Digital Technologies**
- **Health and Well-being**
- **Sustainable Use of Resources**
- **Smart Manufacturing**
- **Aerospace, Aviation, and Space**
- **Cultural Heritage**

Proposals must directly address the objective of this Call and clearly align with at least one of its thematic areas.

4. Selection Criteria

Proposals will be scientifically evaluated on the basis of:

- Scientific and technical excellence and originality of the project
- Feasibility, quality and effectiveness of the project plan
- Project impact, including anticipated economic effects
- Cooperation between consortium partners and added value of the project in the context of international cooperation

5. Submission

A consortium agreement is not required at the proposal submission stage.

All partners seeking funding under this Call must submit an application and any additional documentation required by their respective national funding agency, in accordance with the applicable national rules (see below), and differing stipulated deadline.

5.1 Poland

Polish applicants submit international application for project financing according to the Rules for the participation of Polish applicants in the 5th call of the INNOGLOBO programme. The international application should be submitted by the Polish applicants to the NCBR via the electronic system – Application Generator in LSI 1.0.: <https://lsi.ncbr.gov.pl>.

5.2 Malta

Each Malta-based partner must submit a national application form together with all required annexes, in accordance with the applicable national rules and the requirements specific to their entity type.

The state-aid and non-state-aid national rules, along with the national application form, can be downloaded from the Call page on the [Xjenza Malta website](#). Any additional annexes are available on the [Xjenza Malta resources page](#).

It is important that each applicant consults with the Xjenza Malta Programme Manager if they are unsure about the required annexes or submission requirements. Incorrect or incomplete submissions may result in the proposal being deemed ineligible and excluded from further evaluation. Applicants are solely responsible for ensuring compliance with

all requirements and must allow sufficient time to seek clarification before the submission deadline.

Consultation with the national funding agencies is highly recommended at an early stage.

4.3 Decision and Project Start Date

It is expected that applicants will receive the decision regarding their grant by their national funding organisations by October 2026.

Successful proposals will be required to agree on a common project start date for all partners. This start date must be set as soon as possible following the award announcement and **no later than 3–6 months from the date of the announcement.**
