REGULATION OF THE MINISTER OF HEALTH¹

of 27 August 2020

on an order to perform non-medical exposures related to employment or insurance²

Based on art. 33zi paragraph 2 of the Act of 29 November 2000 - Atomic Law (Dz. U. 2019 item 1792, and 2020 items 284 and 322), it is ordered as follows:

- § 1. The regulation shall define:
- 1) the scope of information covered by an order to perform non-medical imaging exposures, intended to assess the health of these people for purposes related to employment or insurance, hereinafter: the 'commission';
- 2) the template of the order.
 - § 2. The order shall include:
- 1) the name and address, the NIP or REGON number of the entity issuing the order;
- 2) full name of the person the order involves;
- 3) the PESEL number of the person the order involves, and in the case of a person who was not assigned a PESEL number—the series, number, and name of a document confirming the identity of this person;
- 4) the residence address of the person the order involves, and the correspondence address, if different from the residence address:
- 5) a rationale for non-medical imaging, including its purpose, prepared by a person authorised to issue an order, according to regulations on referring people for medical radiological procedures, enabling verification of the rationale for the order with respect to the fulfilment of the requirements defined in art. 33zh paragraph 1 of the Act of 29 November 2000 Atomic Law;
- 6) the issue date of the order, as well as the full name and the professional licence number of an authorised person, according to regulations on referring people for medical radiological procedures, and their signature.
 - § 3. The template of the order shall be defined in an appendix to the regulation.
 - § 4. The regulation shall enter into force 14 days after its promulgation.
