NOTICE OF THE PRIME MINISTER

of 25 February 2021

on the announcement of the consolidated text of the Regulation of the Council of Ministers on the template of the quarterly report on the amount of the payment made to the decommissioning fund

1. Pursuant to Article 16(3) of the Act of 20 July 2000 on announcing normative acts and certain other legal acts (Dz. U. of 2019, item 1461), the consolidated text of the Regulation of the Council of Ministers of 27 December 2011 on the template of the quarterly report on the amount of the payment made to the decommissioning fund (Dz. U. of 2012, item 43) is announced in the Annex to this Notice, taking into account the amendment introduced by the Regulation of the Council of Ministers of 17 September 2019 amending the Regulation on the template of the quarterly report on the amount of the payment made to the decommissioning fund (Dz. U., item 1897).

The consolidated text of the Regulation given in the Annex to this Announcement does not include § 2 of the Regulation of the Council of Ministers of 17 September 2019 amending the Regulation on the template of the quarterly report on the amount of the payment made to the decommissioning fund (Dz. U., item 1897), which states:

"§ 2. The Regulation shall enter into force 14 days following its promulgation."

REGULATION OF THE COUNCIL OF MINISTERS

of 27 December 2011

on the template of the quarterly report on the amount of the payment made to the decommissioning fund

Pursuant to Article 38d(9) of the Act of 29 November 2000 on the Atomic Law (Dz. U. of 2019, item 1792 and of 2020, item 284 and 322), it is ordered as follows:
