**RESOLUTION No. 40/2025  
OF THE SCIENCE EVALUATION COMMITTEE  
of 17 December 2025**

**on the evaluation of the quality of education at a doctoral school**

Pursuant to Art. 259(1) and Art. 262(2) of the Act of 20 July 2018 – Law on Higher Education and Science (Journal Laws of 2024, item 1571, as amended), hereinafter referred to as the “Act”, having reviewed the results of the evaluation referred to in Art. 262(1) of the Act, which was carried out by the Evaluation Team, the Science Evaluation Committee

at the WSB University Doctoral School

run by

the WSB University.

This evaluation applies to the period from 1 October 2019 to 11 May 2025.

Justification:

The WSB University submitted a self-assessment report on the functioning of the WSB University Doctoral School for evaluation within the deadline. As part of the evaluation process, the Evaluation Team appointed by the Chair of the Science Evaluation Committee reviewed the documentation and then conducted a site visit on 9 October 2025, during which it obtained additional information allowing for full verification of the submitted data.

The Evaluation Team found that, during the period subject to evaluation, the education provided by the WSB University Doctoral School complied with the applicable law and met the criteria of level 8 of the Polish Qualifications Framework. The Doctoral School effectively fulfilled its mission of educating doctoral students, and the level of completed implementation doctorates deserves recognition. The Evaluation Team recognised internationalisation as a key asset of the University, which was appropriately leveraged by the Doctoral School. The education process was conducted appropriately by qualified academic staff. This allowed doctoral students to acquire advanced scientific and teaching qualifications. There were no doubts as regards the cooperation with the Doctoral Student Council, the adequacy of the curriculum and individual research plans to the learning outcomes for qualifications at level 8 of the Polish Qualifications Framework, the method of verifying learning outcomes, the qualifications of academic teachers, the quality of the recruitment process and academic supervision, the reliability of mid-term assessment, and in particular the internationalisation and effectiveness of doctoral education. The recommendations presented by the Evaluation Team are aimed at increasing quality and serve to further improve the functioning of the Doctoral School.

Consequently, the Evaluation Team decided to positively assess the quality of education at the Doctoral School of the WSB University during the period under evaluation.

Having examined the documentation, the Science Evaluation Commission decided as stated in the introduction.
