

Cycling is my superpower

Art Competition on the occasion of Polish Children's Day and World Bicycle Day

Terms and Conditions

1. Competition is organised by the Embassy of the Republic of Poland to Ireland.
2. The following children are eligible to participate in the competition: residing in Ireland and attending the following classes of primary school: Senior Infants, 1st Class, 2nd Class, 3rd Class.
3. The closing date for receipt of entries to the Competition is Monday, 21th June 2021. Entries that arrive after June 21th will not be considered.
4. All entries will be judged together- no age categories apply.
5. Competition will include two stages:
 - a. Preliminary stage of the competition, in which the Embassy's internal jury will select 30 artworks that satisfy the requirements and will compete in final stage.
 - b. In final stage of the competition, public vote will take place on the Embassy of the Republic of Poland to Ireland's Facebook page from June 22 until June 29, 2021.
6. Public vote, as mentioned in point 5b, will allow one vote per person.
7. The Competition participant, whose entry receives largest number of votes, will be the winner of the art competition.
8. The announcement of the winner will take place no later than June 30th on the Embassy's Facebook page.
9. The winner of the Competition will also be contacted by email and phone.
10. Submission of an entry to the Competition is tantamount to giving consent to publication of the work with the name and surname of its author on the website and Facebook page of the Embassy of the Republic of Poland to Ireland.

About the artwork:

11. Please submit your artwork in A4 size (29.7cm x 21.0cm) in flat format only. Your masterpiece should not be rolled, folded or framed. You may use any type of paper, white, coloured, rough or smooth. The work that you submit may be drawn or painted in pencil, charcoal, pen and ink, crayon, markers, pastel, watercolour, gouache, acrylics, oils, poster colour and collage.
12. Work should be original and created unaided.
13. Works that do not meet the requirements referred to points 11-12 will not be considered.

About the prize:

14. The prize of this contest is a bicycle! Funded by the Embassy of the Republic of Poland after the announcement of the winner of the completion. The size of the bicycle will be appropriate to the age of the winner.
15. Date and location of the awards ceremony will be decided by the organizer after consulting with the parents/guardian.
16. Transportation costs of the bicycle from the awards ceremony to the home address of the participant will be covered by the parents.

How to apply:

17. Fill out Entry Form and send your artwork by snail mail to the Embassy:

18. One entry per individual is permitted. You may send more than one artwork together in one letter, but each entry must have its own completed Entry Form securely attached to it.
19. Name of the artist must be clearly written on the back of the entry.
20. Parent or guardian must sign and date the Entry Form and it must be securely attached to the artwork. Please note that any entries bearing incomplete entry forms will not be considered.

Damages

21. The Embassy of the Republic of Poland to Ireland shall not be responsible for any losses, damages or injuries of any kind resulting from participation in the Competition or from participants' acceptance, receipt, possession and/or use or misuse of the prize.

Final conditions

22. The Organizer shall decide in matters not covered by the terms and conditions.
23. The Organizer reserves the right to change the rules of the Competition during its duration. Information about changes will be posted on the Fanpage and on the official website of the Organizer: gov.pl/ireland.
