



Advisory Board of the OECD National Contact Point for Responsible Business Conduct

The Advisory Board of the Polish OECD National Contact Point for Responsible Business Conduct (OECD NCP) was established by <u>an order</u> of the Minister of Development Funds and Regional Policy of June 14, 2024. The establishment of the OECD NCP Advisory Board fulfils the recommendation of the OECD to strengthen transparency in the functioning of the Polish OECD NCP, formulated during the Peer Review of the Polish OECD NCP, which took place in June 2023, as well as in <u>the Peer Review Report</u>.

In accordance with the aforementioned order, the Advisory Board is chaired by the director of the Ministry of Development Funds and Regional Policy unit responsible for handling corporate social responsibility and responsible business conduct matters.

On **October 4, 2024**, at the first meeting of the OECD NCP Advisory Board, **the Minister of Development Funds and Regional Policy, Ms Katarzyna Pełczyńska-Nałęcz**, appointed to the Advisory Board eight experts representing public administration, the business sector, trade unions, civil society organisations, environmental NGOs and academia.

On May 6, 2025, during the second meeting of the OECD NCP Advisory Board, the Chair of the Board, Director Monika Kusina-Pycińska, handed in the appointments to the Board to three new Members representing public administrations and trade unions. A new Member representing trade unions received their appointment from the Chair during the third meeting of the Board, held on November 21, 2025.
