

**RESOLUTION No. 3/2026
OF THE SCIENCE EVALUATION COMMITTEE
of 14 January 2026**

on the evaluation of the quality of education at a doctoral school

Pursuant to Art. 259(1) and Art. 262(2) of the Act of 20 July 2018 – Law on Higher Education and Science (Journal Laws of 2024, item 1571, as amended), hereinafter referred to as the “Act”, having reviewed the results of the evaluation referred to in Art. 262(1) of the Act, which was carried out by the Evaluation Team, the Science Evaluation Committee

positively evaluates the quality of education

at the Doctoral School of the Karol Lipiński Academy of Music in Wrocław

run by

the Karol Lipiński Academy of Music in Wrocław.

This evaluation applies to the period from 1 October 2019 to 11 May 2025.

Justification:

On 28 July 2025, Karol Lipiński Academy of Music in Wrocław submitted for evaluation a self-assessment report concerning the functioning of the Doctoral School of the Karol Lipiński Academy of Music in Wrocław for the period from 1 October 2019 to 11 May 2025. As part of the evaluation procedure, the Evaluation Team appointed by the Chair of the Science Evaluation Committee reviewed the documentation and subsequently carried out an on-site visit to the School on 21 October 2025, during which it obtained additional information allowing full verification of the data presented.

The Evaluation Team found that, in the period under review, the educational process carried out by the Doctoral School of the Karol Lipiński Academy of Music in Wrocław provided a high level of training in the discipline of musical arts, enabling the comprehensive scientific and artistic development of PhD candidates. The study programmes and individual research plans corresponded to the learning-outcomes descriptors for qualifications at level 8 of the Polish Qualifications Framework, consistent with the requirements of the Regulation of the Minister of Education and Science of 27 September 2021 on the evaluation of the quality of education at doctoral schools (Journal of Laws of 2021, item 1847). All evaluation criteria were met to a very good degree, the high quality of doctoral supervision and an atmosphere conducive to the individual development of PhD candidates deserve particular recognition. A significant asset was the University’s excellent infrastructure, which enabled the implementation of projects at the highest artistic level. The rules for recruitment to the Doctoral School were formulated in a clear manner and in accordance with applicable regulations, with the Evaluation Team’s recommendation to ensure the timeliness of their publication. The system for conducting mid-term assessments met all the requirements of the applicable regulations, and the entire procedure was transparent and impartial.

Accordingly, the Evaluation Team decided to give a positive assessment of the quality of education at the Doctoral School of the Karol Lipiński Academy of Music in Wrocław for the period under evaluation.

Having examined the documentation, the Science Evaluation Committee decided as stated in the introduction.
