**RE: correspondence consultations for the Draft Land Acquisition and Resettlement Action Plan for the Works Contract 3A.2/3 Flood Protection in Serafa Valley - Malinówka 3 Reservoir**

Dear Sir / Madam,

State Water Holding Polish Waters RZGW in Cracow (hereinafter referred to as the Investor) plans to implement – within the City of Cracow and Wieliczka, the Municipality Cracow and Commune of Wieliczka – an investment titled *Works Contract 3A.2/3 Flood Protection in Serafa Valley - Malinówka 3 Reservoir*, realized as a part of *Odra-Vistula Flood Management Project* (hereinafter referred to as OVFMP).

The purpose for implementing the *Odra-Vistula Flood Management Project* is enhancement of the flood protection level for people living in selected areas of the Odra river-basin and of the Upper Vistula river-basin, and institutional strengthening of governmental administration in the range of securing more efficient protection against summer and winter floods and rapid floods. The OVFMP Project is co-funded by the International Bank for Reconstruction and Development (hereinafter referred to as the World Bank or IBRD) (Loan Agreement no. 8524 PL of September 10, 2015), the Council of Europe Development Bank (Frame Loan Agreement no. LD 1866 of May 24, 2016), the European Union's Cohesion Fund (IEOP 2014-2020), and by the State Budget.

*Works Contracts 3A.2/3* consisting in the construction of a dry flood reservoir will be implemented as one of tasks to be implemented under the OVFMP. Due to engagement of World Bank's financial resources in implementation of the *Works Contract*, the Investor is obliged to apply so-called Operational Policies of that International Financial Institution. And mainly to apply Operational Policy OP 4.12 Involuntary Resettlement comprising main rules and procedures forming a basis for IBRD's approach to involuntary resettlement associated with investment

projects. Within the framework of fulfilling provisions under the Policy a Land Acquisition and Resettlement Action Plan (hereinafter referred to as the LA&RAP) – containing information on legal bases related to the acquisition of properties, as well as planned measures to minimize adverse impact on project affected persons and to improve or, at least, restore their living conditions – was developed, and it is currently subject to publication procedure / public consultations. **In case of the Works Contract 3A.2/3 there are no physical and economic resettlements, only plots or parts of undeveloped plots will be taken over for the purposes of the Contract.**

Your property is located in the area of permanent acquisition and / or in the area of permanent restrictions in use or temporary restriction associated with obligatory redevelopment of networks under the *Works Contract*, you have already been informed about it in the letter of August 2019. The Consultant working on behalf of the Investor, AECOM Polska Sp. z o.o., has informed private owners of properties to be acquired on behalf of the State Treasury in letters about a socio-economic survey planned for implementation in September and October 2019. Some of you participated in a questionnaire survey, but we were not able to contact the others.

We currently wish to invite you to review the draft LA&RAP and to provide your opinion on that study and to ask questions / raise remarks. A Form for Provision of Questions attached to this letter may support you in that. The note also comprises other appendices: **the announcement and the information brochure, which contain all contact data** necessary to submit the questionnaire or provide oral information in a telephone discussion.

Note: persons not having access to the Internet may contact the Investor using the phone number given below, and after notifying about such a situation they shall receive a parcel with a hard copy of the LA&RAP.
