

CALL TEXT
7th CALL FOR PROPOSALS
POLAND - TÜRKİYE

1. Funding purpose

The National Centre for Research and Development, Poland (NCBR) and the Scientific and Technological Research Council of Türkiye (TÜBİTAK) aim to strengthen and develop scientific and technological co-operation of the two countries on the basis of equality and mutual benefit. They shall pursue their support for bilateral research and development (R&D) projects in the following areas of mutual interest:

1. Health: Pharmaceuticals, Epidemiological Studies, Biomaterials
2. Food: Innovative and Sustainable Food Production Technologies
3. Agriculture: Green and Sustainable Agriculture
4. ICT: Artificial Intelligence

The funding will be focused on topics falling into the scope of these call areas that are of major interest to the participating sides. In addition to this, the scientific oriented cooperation between the participating countries will serve to develop their national economies. Basic research projects are not supported within the scope of this call. Instead, the projects, focusing to R&D, technologically new or improved product and technological process innovation, are expected. The Parties shall encourage and support co-operation between research entities, universities, research institutes and industries of Türkiye and Poland. The project applications outside the specified thematic areas mentioned above will not be considered for evaluation.

2. Type of funding and legal basis

Project partners will be funded by the funding institutions of the respective partner countries (Poland and Türkiye).

3. Legal status of applicants

Proposals may be submitted by enterprise, consortia of enterprises or consortia of enterprise and private/public research organizations that are eligible to participate in the call according to the respective funding regulations of the funding institutions. These can be public research organizations, private research organizations, higher education institutions and industries.

4. Composition of project consortium

The work plan must show real cooperation between the partners. Project outputs are expected to provide benefits to both partner countries. Consortia also need to be balanced both in terms of number of partners and distribution of budget; such that all project partners contribute to and benefit from an equitable and balanced cooperation.

Eligible Applicants:

- The Polish part of the consortium shall consist of at least one enterprise¹ established in Poland (micro/small/medium/large enterprise) or at least one Polish enterprise established in Poland (micro/small/medium/large enterprise) and one research organization² forming a national consortium or consortium of at least two enterprises. Polish consortium may be composed of maximum 3 entities.
- The Turkish consortium has to consist of at least one Turkish commercial company. At least one academy partner (including public institutions or organizations/ research institutions/ universities/ training and research hospitals) is encouraged but is not compulsory. Turkish team will receive funding through TÜBİTAK 1071 Program. All Turkish researchers who apply for this program should be registered to TÜBİTAK ARBİS (Researcher Information system) through the following link: <https://arbis.tubitak.gov.tr>

Applicants are advised to make sure that the project consortium is balanced with regard to the type and number of entities constituting the consortium - enterprises will need to be present on both sides i.e. Polish and Turkish.

5. Financial support

For Turkish Applicants:

For each project, **the total** funding provided by TÜBİTAK is up to 8.750.000 TL (excluding overheads and Project Incentive Premium (PIP)). In cases where Turkish academia or public institution partners are involved, the total funding that can be allocated to these partners within a single proposal is limited to 3.000.000 TL (excluding overheads and Project Incentive Premium (PIP)). Turkish small and medium sized enterprises (SMEs) can receive 75% of the approved budget; Turkish large-scale enterprises can receive 60% of the approved budget. Higher education institutions, their institutes, public R&D centers can receive 100% of the approved budget. Requested funding from TÜBİTAK is obtained by multiplying the project budget with the support rate. In projects involving more than one executive institution, requested funding from TÜBİTAK is the sum of the amounts obtained by multiplying the project budget of each executive institution with the support rate. TÜBİTAK-funded costs of each grant will be issued and managed by TÜBİTAK according to its funding guidelines and procedures (For detailed information please visit [here](#)).

Turkish side shall receive daily allowances as indicated below:

- The sending party is obliged to cover all expenses of its investigator in accordance with its rules. In the case of bilateral travel, economic class air tickets and daily allowance shall be paid in accordance with the provisions of the Per diem Law No. 6245.

For Turkish applicants, the total duration of visits in one direction of a specific project should not be more than three months a year. It is possible to exceed 90 days a year provided that it is justified and deemed appropriate.

For Polish Applicants:

Each winning project may apply for funding up to 850 000 PLN from NCBR within the scope of the available call budget.

This funding will cover the expenses in connection with the project, i.e. personnel costs, equipment, subcontracting, travel, overheads, etc. All expenses must be in accordance with the national regulations and the NCBR eligibility guide published in the Call announcement.

The duration of projects can be minimum 24 months and not exceed 36 months.

6. Application procedure

There is a one-level procedure for submission of proposals.

Project proposals must provide detailed information on the objectives and justification of the planned joint research work, the methodology to be followed, the composition of each research team and the intended timetable and the proposed budget.

Project proposals shall be submitted for evaluation and approval simultaneously to TÜBİTAK (<https://uidb-pbs.tubitak.gov.tr>) and to NCBR (<https://lsi.ncbr.gov.pl>). Applications which are not submitted on both sides will not be accepted for evaluation. Hence, Turkish/Polish project leaders should make sure that their counterpart submits a matching Application.

Each national applicant shall need to consult with the National Rules & Regulations imposed by the corresponding Managing Authority. Applications which are found to be ineligible by one of the Managing Authorities will automatically render the whole proposal as ineligible.

Applicants are eligible to submit more than one proposal under this call.

Turkish partners are obliged to use E-Signature for their applications. Detailed information can be achieved [here](#).

7. Evaluation of project proposals

Evaluation procedure

The proposals will be evaluated according to the national regulations of the funding institutions, but based on jointly agreed rules and criteria of evaluation. Only projects that fit to the call topics mentioned in Part 1 of this document can be funded.

Selection/Evaluation criteria:

- (1) Scientific/Technological Excellence
- (2) Methodology
- (3) Project Management
- (4) Structure and Contribution of International Collaboration
- (5) Impact

Based on evaluations from external experts each funding institution will establish its own ranking list of proposals with the average score given for each proposal.

The final score for each proposal will be an average of points received in both evaluation procedures. The common ranking list will be established based on these final scores.

The final decisions on what projects to support will be made by the funding institutions based on the common ranking list and within available budget.

8. Communication of project evaluation decisions

The outcome of the evaluation of proposals will be communicated to applicants in accordance with the respective communication procedures of the funding institutions.

9. Decision process and the start of projects

The formal funding decisions will be taken jointly by the funding institutions after the proposals have been evaluated by external experts, wherein only projects which were positively evaluated by both parties will be considered eligible for support. Each country will fund its own project partners within the available budget.

When the final decisions have been conveyed to project participants, successful applicants must enter into individual contractual agreements with their national funding institutions. Project partners are required to establish and sign an agreement on the ownership and management of intellectual property rights arising from the joint research and development activities. This agreement must specify the distribution of rights, rules for exploitation, IP management procedures, and the competent court and applicable law for dispute resolution.

The drafting, negotiation, and finalization of this agreement are the sole responsibility of the project partners. The participating funding agencies do not provide or endorse any model agreement. Funding for awarded projects must only be requested and initiated after the agreement has entered into force.

The terms agreed by the partners must not conflict with national laws, regulations, terms and conditions of TÜBİTAK and NCBR. The signed agreement must be submitted to TÜBİTAK and NCBR upon request.
