Please be informed that failure to submit the documents listed below **may result in refusal decision in your visa case by the Embassy/Consulate General of the Republic of Poland**. The required documents have to be translated into Polish or English in a separate document according to the instructions below. The passport remains at the Embassy/Consulate during the review of the documents.

1.	<b>Visa application form</b> completed in Latin alphabet and signed by the applicant (in case of a minor signed by both parents or legal guardians). <b>One color photograph</b> (white background, 35 mm x 45 mm, not older than 6 months). 签证申请表，无空项，由申请人以拉丁字母签名（未成年人由父母或法定监护人签名）。 一张彩色照片（白色背景，35 毫米 x 45 毫米，拍摄时间不早于 6 个月）。			
2.	<b>Passport or other travel document</b> and one copy of the identification page, copy of the pages with Schengen/Polish national visas (if issued) and copy of page with signature on the passport. If the visas were in the previous passport – copy of that passport identification page and page with signature. Travel document must be: not older than 10 years, valid for at least 90 days after the expiration of visa and containing at least 2 blank pages. 护照或其他旅行证件，身份证页复印件一份，申根/波兰国家签证页复印件（如已签发）和护照上签字页复印件一份。如果签证在前一本护照上，请提供该护照的身份证页和签名页复印件。 旅行证件须：不超过10年，有效期至少为签证到期后90天，至少包含2页空白页。			
3.	<b>Original ID and hukou</b> with copies of all the pages (only for Chinese nationals). In case the applicant is from other consular jurisdiction: <i>Zan Zhu Zheng</i> or other police certificate to prove his or her stay in the current jurisdiction. 身份证，户口本原件及户口本所有页的复印件（只针对中国公民） 若申请人来自其他领区，须提供暂住证或其它由公安机关开具的相关证明，证明其在本领区居住。			

4.	<p><b>Original residence permit with copy</b> (applicable only for non-Chinese passport holders) valid for at least 3 months after the date of application.  居留许可/在中国合法居留的其他证明，以及复印件，有效期至少为提交签证申请之日后 3 个月。</p>			
5.	<p><b>Travel medical insurance</b> covering the entire duration of stay with a minimum coverage of 30 000 EUR, including costs of emergency medical treatment, repatriation for medical reasons as well as transportation in case of death. Handwritten certificates will not be accepted. The name of the insured should be also written in Latin alphabet.  医疗保险原件及复印件。旅行医疗保险涵盖整个逗留期间，最低保险额为 30000 欧元，包括紧急治疗、医疗原因送返以及死亡时的转运费。不接受手写证明。被保险人的姓名也应以拉丁字母书写。</p>			
6.	<p><b>Original and valid certificate of the institution conducting the studies on admission to studies or on continuation of studies.</b> This document must contain information about the current year of study and semester.  进行学习的机构出具的关于入学或继续学习的有效证明原件。该文件必须包含有关当前学习年份和学期的信息。</p>			
7.	<p><b>Proof of highest completed level of education:</b>  For applicants starting the first year of studies/preparatory course: <b>secondary school leaving certificate or diploma notarized and legalized by the MFA.</b>  For applicants starting the second and third cycle studies: <b>certificate issued by the MFA or diploma of graduation notarized and legalized by the MFA.</b>  最高完成教育水平的证明。  对于开始第一年学习/预科课程的申请人：经外交部认证的中学毕业证书或文凭。  对于开始第二和第三阶段学习的申请人：由外交部颁发的证书或经外交部认证的毕业证书。</p>			
8.	<p><b>Proof of payment for studies/proof of receiving a scholarship</b> (if applicable) – issued by the unit conducting the studies.  学习费用支付证明/获得奖学金的证明（如适用）--由进行学习的单位出具。</p>			
9.	<p><b>Proof of financial means</b> (one of the following documents):  1. Traveler's cheque,  2. Certificate of the amount of the credit card limit issued by the bank (any bank located in China or Poland or another country is allowed),  3. Certificate of availability of money in a Polish or European Union bank or a cooperative savings and loan association located in the territory of the Republic of Poland or European Union (<b>certificates of Chinese banks are not accepted</b>),  4. Document confirming the grant of a national or foreign scholarship,  5. Certificate of employment with monthly salary statement.  Documents stated in point 2, 3 and 5 shall not be issued more than one month before submission of visa application.  <b>Minors and adults financially dependent on their parents (if applicable)</b>  Notarized sponsor's letter from parents, as well as documents confirming the availability of financial means (points 1-5). The letter should state that parents are required to cover all travel and accommodation expenses of the applicant. If the applicant's parents are not indicated in the applicant's <i>hukou</i>, the applicant must submit a notarial certificate on family ties in Chinese with a translation into Polish or English, legalized by the MFA.  Sponsorship by a third person is possible only after obtaining approval from the consul – the sponsor's letter must be certified by a notary and legalized by Chinese MFA.</p>

10.	<p><b>Proof of appropriate accommodation for the intended period of stay:</b></p> <ol style="list-style-type: none"> <li>1. Certificate of registration (<i>zameldowanie</i>)</li> <li>2. Lease agreement,</li> <li>3. Decision on the provision of the dormitory issued by the unit conducting the studies,</li> <li>4. **To be completed by the Inquiry Officer:**
