

NOTIFICATION OF NATO CURRENT PROCUREMENT OPPORTUNITY

2. Reference number of the tendering procedure: NSIP/NCP/1/2026

3. Name given to the tendering procedure:

Execution of construction and installation works for a project involving the construction of a training building with an auditorium, including associated technical and road infrastructure, as well as site development works, carried out for the needs of the Joint Force Training Centre in Bydgoszcz, implemented as part of the following projects: "Provide additional training infrastructure" and "Provide CIS (Communication and Information systems) infrastructure for JFTC"

4. Scope of the Contract (Project):

The subject of the Contract is the execution of construction and installation works for a project consisting of the construction of a training building together with the necessary technical infrastructure and site development, in accordance with the design documentation and obtained administrative decisions, in particular:

- Construction of a training building equipped with all internal installations (central heating, water supply, air conditioning and ventilation, electrical, telecommunications, structured cabling, AV/VTC, fire alarm system, voice alarm system, intrusion alarm system, access control system, Closed-Circuit Television system, Building Management system BMS, photovoltaic system) together with the delivery and installation of equipment,
- construction of a medium--voltage/low-voltage (MV/LV) transformer substation, generator set and a rainwater retention tank, reconstruction of the existing chilled water plant room;
- construction/reconstruction of external connections and installations;
- site development – including internal roads, sidewalks, removal and transplanting of existing trees, planting of new trees and shrubs,

together with completion procedures, including submission of the notification of construction completion and obtaining the occupancy permit.

5. Estimated duration of the Contract: 21 months

6. Procurement method:

- 1) The procurement method is NATO Competitive Procurement (NCP) under the document AC/4-D(2025)0008 titled "Procedure for NATO Competitive Procurement", which is available at:

- 2) The Notification of NATO Current Procurement Opportunity has also been published on the website of the Ministry of Economic Development and Technology Republic of Poland (MEDT RP).

7. Requirements concerning the Declaration of Eligibility:

- 1) Vendors interested in participating in the tendering procedure must have a "Declaration of Eligibility" (DoE) issued for the Project by the appropriate national authorities of the Vendor's nation of origin.
- 2) Entities running business on the territory of the Republic of Poland, hereinafter referred to as "Polish Vendors", interested in participating in the tendering procedure are obliged to obtain a DoE issued for the current tendering procedure by the MEDT RP.
- 3) Declarations of Eligibility for Polish Vendors are issued based on Regulations developed by the MEDT RP, which is available on the MEDT RP website.
- 4) Foreign entities, hereinafter referred to as „foreign Vendors” that nation of origin is one of the nation's participating in Project costs (the list of nations participating in the Project costs is defined in Annex No. 1 to the Notification of NATO Current Procurement Opportunity) interested in participating in the tendering procedure are obliged to obtain a DoE, issued for the current tendering procedure by the appropriate national authorities of the Vendor's nation of origin.
- 5) Declaration of Eligibility constitutes confirmation that the Vendor possesses necessary financial, technical and professional competence, **including ability to protect classified information at the level required by the project**, as specified in section 9.
- 6) The Declaration of Eligibility should confirm compliance with the requirements referred to in point 5 above as of the date it is granted.
- 7) In the case of Vendors jointly applying for being awarded a contract as a consortium, all its members must possess the DoE, which does not contradict the fact that a single DoE covering individual members of the consortium may be issued.

8. Deadline for submitting Declarations of Eligibility:

Declarations of Eligibility must be submitted or sent to the Contracting Authority no later than **19th of June 2026**, subject to the condition that Polish Vendors are obliged to submit applications for the issuance of Declaration of Eligibility to MEDT RP within the deadline specified in the MEDT RP Announcement.

9. Requirements for the protection of classified information:

- 1) **Both at the stage of the tendering procedure and during the performance of the Contract**, the Contracting Authority requires the Vendor to have the ability to: protect information classified as POUFNE (or relevant) and NATO CONFIDENTIAL, including the ability to process such information in: facilities used by Vendor and Vendors'

- own accredited (security approved) Communication and Information Systems (CIS), as well as at least the ability to protect information classified as NATO SECRET, excluding the possibility of processing such information in facilities used by Vendor.
- 2) Polish Vendors are obligated to meet the requirements set out in the Act on Protection of Classified Information of 5th August 2010 (consolidated text, Journal of Laws 2025, item 1209) and the implementing regulations to the Act above.
 - 3) Foreign Vendors are obligated to meet the requirements set out in the NATO documents:
 - a) The main NATO security document: Security within the NATO - C-M(2002)49;
 - b) Directive on the security of NATO classified information - AC/35-D/2002,
 - c) The Management of Non-Classified NATO Information - C-M(2002)60 (11th July 2002),
 - d) Directive on classified project and industrial security - AC/35-D/2003,
 - e) Primary directive on INFOSEC – AC/35-D/2004.
 - 4) **Polish Vendors** (and in the case of Vendors jointly applying for being awarded the contract, at least the entity responsible for the protection of classified information – the Contracting Authority requires a **clear indication of which of the Vendors** jointly applying for the award of the contract is responsible for the protection of classified information), are obliged to possess:
 - a) the ability to protect information classified as POUFNE and NATO CONFIDENTIAL, in facilities used by the Vendor and the ability to protect information classified as NATO SECRET, excluding the possibility of processing such information in facilities used by Vendor;
 - b) accredited (security approved) Communication and Information Systems (CIS), used for processing information classified as POUFNE and NATO CONFIDENTIAL.
 - 5) To confirm compliance with the requirements referred to in point 4 above, Polish Vendors (and in the case of Vendors jointly applying for being awarded a contract, at least the entity responsible for the protection of classified information) must possess the following documents:
 - a) a first-level industrial security certificate confirming the ability to protect information classified as POUFNE;
 - b) a first-level industrial security certificate confirming the ability to protect information classified as NATO CONFIDENTIAL;
 - c) a third-level industrial security certificate confirming the ability to protect information classified as NATO SECRET;
 - d) certificate of security accreditation of the Communication and Information Systems (CIS) used to process information classified as POUFNE
 - e) certificate of security accreditation of the Communication and Information Systems (CIS) used to process information classified as NATO CONFIDENTIAL.
 - 6) Foreign Vendors (and in the case of Vendors jointly applying for being awarded the contract, at least the entity responsible for the protection of classified information – the Contracting Authority requires a **clear indication of which of the Vendors** jointly applying for the award of the contract is responsible for the protection of classified information), are obliged to possess:
 - a) the ability to protect information classified as POUFNE (**or relevant**) and NATO CONFIDENTIAL, in facilities used by the Vendor and the ability to protect information classified as NATO SECRET, excluding the possibility of processing such information in facilities used by Vendor;

- b) accredited (security approved) Communication and Information Systems (CIS), used for processing information classified as POUFNE (**or relevant**) and NATO CONFIDENTIAL.
- 7) To confirm compliance with the requirements referred to in point 6 above, Foreign Vendors (and in the case of Vendors jointly applying for being awarded a contract, at least the entity responsible for the protection of classified information) must possess the documents appropriate for their country of origin, confirming the possession of capabilities and systems.
- 8) Other entities jointly applying for being awarded a contract (Polish Vendors and Foreign Vendors) should have the ability to protect classified information at the level and to the extent to which they will have access to it **while performing a contract**. This means that a consortium member **whose scope of participation in the performance of the contract will:**
- a) require access to information classified as POUFNE (or relevant) and/or NATO CONFIDENTIAL and/or NATO SECRET – must have an industrial security certificate confirming the ability to protect classified information to the level corresponding to the scope of the activities entrusted to perform within the contract;
 - b) be related to performing activities requiring processing classified information in its own Communication and Information Systems (CIS), must demonstrate possession of an accredited CIS system for processing them;
 - c) be related to performing activities requiring access to information classified as ZASTRZEŻONE (or relevant) and/or NATO RESTRICTED, **also at its registered office** – must submit at the stage of performing the contract a declaration of compliance with the requirements set forth in the documents outlining the rules and principles for protecting information classified as ZASTRZEŻONE (or relevant) and/or NATO RESTRICTED;
 - d) be related to performing activities requiring access to information classified as ZASTRZEŻONE (or relevant) and/or NATO RESTRICTED, **excluding its registered office** – must submit at the stage of performing the contract a statement on a disposal of personnel authorized to access information classified as ZASTRZEŻONE (or relevant) and/or NATO RESTRICTED.
- 9) If the scope of activities performed by a particular Vendor jointly executing the contract does not involve access to classified information, then the entity indicated as the one responsible for protecting classified information is obliged to protect all classified information and materials against their unauthorized disclosure.
- 10) In accordance with the applicable regulations, upon receipt of the Declarations of Eligibility, the Contracting Authority will verify the Vendors' ability to protect classified information, including the right to verify documents confirming compliance with the requirements concerning the protection of classified information. The foreign Vendors' ability to protect classified information will be verified by the National Security Authority (ABW), by the security authority appropriate to the Vendors' country of origin.
- 11) The Vendor that does not meet the requirements regarding the protection of classified information on the day of submitting the DoE, is subject to exclusion from the tendering procedure.

10. The Contracting Authority, before issuing the Invitation to submit offers, will call Vendors who have received the Declaration of Eligibility to submit the documents referred to in sections 11 and 13 below.

11. Requirement (condition) for participation in tendering procedure:

- 1) The Contracting Authority requires that the Vendor, within the last five years preceding the deadline for submitting the Declaration of Eligibility, and if the period of running a business is shorter – within that period, carry out (complete) at least two construction works corresponding in nature to the Subject of the Contract, namely the execution of **projects** related to the construction, reconstruction, or expansion of administrative buildings or office or conference buildings carried out for the needs of the Armed Forces, together with sanitary, electrical, and telecommunications networks (**each of the aforementioned projects**), each with a value of at least 50 000 000,00 PLN gross.
- 2) In order to confirm that the Vendor meets the participation requirement (condition) referred to in point 1 above, the Contracting Authority will call Vendors who have received the Declaration of Eligibility to submit a list of construction works – part A, completed no earlier than in the last 5 years before the deadline for submitting the Declaration of Eligibility, and if the period of running a business is shorter – within that period, comparable to the construction works constituting the Subject of the Contract, together with the specification of their type, value, date, place of execution and the entities for whom the works were performed, and attaching evidence indicating whether these construction works were carried out properly and completed correctly. The evidence referred to consists of references or other documents prepared by the entity for whom the construction works were carried out.
- 3) In the case of construction works meeting the conditions set out in point 1 above, the value of which has been expressed in a foreign currency, this value will be converted into PLN according to the average exchange rate of the National Bank of Poland (Table A of the average exchange rates of foreign currencies) on the day on which the deadline for submitting the Declarations of Eligibility expired, indicated in section 8, or on the following day, if the NBP did not announce average foreign exchange rates on that day.
- 4) The Contracting Authority does not foresee the possibility of Vendors supplementing the documents referred to in point 2 above.
- 5) The Vendor, who on the request of the Contracting Authority failed to submit the documents referred to in point 2, or whose submitted documents are incomplete or do not confirm compliance with the requirement (condition) for participation in tendering procedure, is subject to exclusion from the tendering procedure.

12. Predicted maximum number of Vendors who will be invited to submit offers: 7 (seven).

13. Selection criteria:

- 1) In the event that the number of Vendors who have received the Declaration of Eligibility and confirmed compliance with the requirement (condition) for participation in tendering procedure referred to in section 11.1 above and are not excluded from participation in the procedure, will be greater than specified in section 12 above, the Contracting Authority

shall invite to submit offers those Vendors who demonstrate that they have performed more than the required amount of construction works meeting requirements set out in section 11.1 above.

- 2) In order to carry out by the Contracting Authority an assessment based on the selection criteria referred to in point 3 below, the Contracting Authority shall call upon the Vendors who have received the Declaration of Eligibility to submit a list of construction works – part B and attach evidence indicating whether these construction works were carried out properly and completed correctly. The evidence referred to consists of references or other documents prepared by the entity for whom the construction works were carried out.
- 3) For each construction work duly carried out, meeting the requirement (condition) laid down in the section 11 point 1 above (over the minimum demonstrated to confirm the fulfilment of the requirement (condition) for participation in tendering procedure in the list of construction work – part A), performed within the last 5 years before the deadline for submitting the Declarations of Eligibility, and if the period of running a business is shorter, then during this period, points will be awarded as follows:
 - a) 1 point – for 1 construction work;
 - b) 2 points – for the performance of 2 construction works;
 - c) 3 points – for the performance of 3 construction works;
 - d) 4 points – for the completion of 4 works and more.
- 4) The maximum number of points that can be awarded to the Vendor is 4 points.
- 5) The contracting authority does not allow the use of the capacity of third parties (a third party is an entity other than the Vendor or Vendors jointly applying for being awarded a contract) in order to demonstrate compliance with the selection criteria referred to in point 3.
- 6) The Contracting Authority does not foresee the submission of additional documents by Vendors referred to in point 2 above, which means that if a Vendor has not submitted the documents referred to in point 2, the submitted documents are incomplete or the demonstrated construction work does not meet the conditions specified in section 11, point 1 above, Vendor will not be awarded points for given construction work.
- 7) In the event that two or more Vendors obtain the same number of points, the Contracting Authority, for the purpose of assessment, will additionally take into account the summed value of works demonstrated in the list of construction works – Part B and award a higher position in the ranking to the Vendor who has demonstrated the execution of works with a higher value.
- 8) In the event that two or more Vendors obtain the same number of points, based on point 7 above, the Contracting Authority, for the purpose of assessment, will also take into account the summed value of construction works listed as evidence of meeting the requirement (condition) for participation in tendering procedure in the list of construction works – Part A. The Contracting Authority will award a higher position in the ranking to the Vendor who has demonstrated the execution of construction works with a higher total value.
- 9) In the event that none of the Vendors demonstrates experience within the selection criteria in the list of construction works – part B, the determination of the ranking list will be decided by the summed value of construction works listed as evidence of meeting the requirement (condition) for participation in tendering procedure in the list of construction works – Part A.

The Contracting Authority will award a higher position in the ranking to the Vendor who has demonstrated the execution of works with a higher total value.

14. The Contracting Authority will inform the Vendors about the assessment of the Vendor's fulfilment of the requirement (condition) referred to in section 11 above, and of the selection criteria referred to in section 13 above.
15. The Vendor who is subject to exclusion under Articles 108 and 405 of the Act of 11 September 2019, *Public Procurement Law*, is excluded from the tendering procedure for awarding the contract

18. The Contracting Authority informs that the solicitation documentation will be provided to the Vendors invited to submit offers.
19. The tendering procedure may be cancelled without reimbursement of costs incurred by Vendors.
