

Experiences from Denmark The Danish Gambling Act

To keep the use of gambling services at a moderate level

- To protect young people or other vulnerable people from being exploited through gambling or developing gambling addiction
- To protect players by ensuring that gambling is provided in a fair, responsible and transparent manner
- To ensure public order and to prevent gambling from reinforcing criminal activities

The model is considered successful with a large number of licence holders, and an estimated small amount of illegal gambling.

Many licence holders contribute to a competitive gambling market with little incentive for gamblers to use illegal sites.

Licence type	Licence Holders
Online Casino	25
Online Casino (revenue restricted)	7
Betting	16
Betting (revenue restricted)	3

Defining illegal online gambling operators



A gambling activity is provided illegally if:

the gambling activity is provided **without the required licence** from the Danish Gambling Authority and

the gambling provider directs marketing towards Danish gamblers

A gambling activity provided through the Internet, is seen to be provided in Denmark if:

• the homepage is in **Danish**, or



- a Danish currency can be chosen, or
- the homepage has a Danish customer service, or
- payment methods can be used which would normally only work in Denmark, like e.g. Dankort, or
- the operator of the homepage directs marketing towards Denmark.

Note – this definition means that other EU sites providing gambling services in local languages etc are not illegal according to The Danish Gambling Act.

Experiences from Denmark Detecting illegal online gambling operators

The Danish Gambling Authority has two channels to detect illegal online gambling operators:



* Web crawling is done using the Dutch developed Xenon.

Tools for blocking illegal online gambling operators

In order to protect the regulated gambling market and to protect the players, the Danish Gambling Act provides these tools:



Advertising ban



Internet-blocking




There is no public blacklist officially available from The Gambling Authority. However, the telecom industry's trade cooperation maintains a public list of blocked sites.


Experiences from Denmark Number of blocked gambling operators

The operators of the gambling activities that The Danish Gambling Authority assesses illegal, are initially given a petition from The Danish Gambling Authority, requesting them to terminate the illegal provision of games.

If they do not comply, the enforcement, however, will not be addressed directly against the illegal gambling operators, but rather against the Danish ISPs, banks and media.

The authorities will force these parties to block the Danes access to illegal gambling.

Potential illegal websites, petitions and internet blockings



* Of the 25 blocked websites, 12 have decided to follow the petition why the blocking has been removed. The remaining 13 are still blocked.

Experiences from Denmark Internet-blocking

SOLUTIONS



Enforcement to block the homepage with illegal gambling, is addressed against the **Danish ISPs**.



The majority of ISPs will typically first block the homepage when there is a **ruling from the Bailif's court**.

The Danish Gambling Authority has a good dialogue with the ISPs, however;



Therefore, The Danish Gambling Authority often takes the matter to the Bailif's court in order to have the homepage blocked using DNS blocking.

CHALLENGES OF INTERNET BLOCKING



DNS-blocking can easily be surpassed by the user



It is **not illegal** to surpass the DNS-block and thus visit the illegal gambling website

Experiences from Denmark Payment-blocking

SOLUTIONS



Danish payment institutions are require to **block access to transfer money** to/from illegal gambling operators

CHALLENGES OF PAYMENT BLOCKING

Easy to surpass, as;



It is practically impossible to force **foreign banks** to block transactions The same challenge applies for international transaction services such

as PayPal



It is also impossible to block transactions from Danish banks to foreign banks or international transaction services

Experiences from Denmark Advertising ban

SOLUTIONS



All advertising of gambling activities and gambling providers without a license forbidden.




Media advertising for gambling operators without a license, gets a **petition** from The Danish Gambling Authority to stop the illegal advertising.



If the media does not cease the illegal advertising, they will be **reported to the police**.
